

Change of Classification of Reserves—Porirua City

Under section 24 of the Reserves Act 1977, and a delegation from the Minister of Conservation, the Porirua City Council, pursuant to a resolution dated 1 August 2011, gives notice that:

- a. the classification of the land described in the First Schedule to this notice is changed from recreation reserve to local purpose (esplanade) reserve, subject to the provisions of the said Act, and to be known as Porirua Stream Esplanade Reserves - north;
- b. the classification of the land described in the Second Schedule to this notice is changed from local purpose drainage reserve to local purpose (esplanade) reserve, subject to the provisions of the said Act, and to be known as Porirua Stream Esplanade Reserves - south;
- c. the classification of the land described in the Third Schedule to this notice is changed from scenic reserve to recreation reserve, subject to the provisions of the said Act, and to be known as The Quarterdeck Lookout Reserve;
- d. the classification of the land described in the Fourth Schedule to this notice is changed from recreation reserve to scenic reserve for the purposes specified in section 19(1)(b) of the Reserves Act 1977, subject to the provisions of the said Act, and to be known as Bromley View Reserve; and
- e. the classification of the land described in the Fifth Schedule to this notice is changed from recreation reserve to historic reserve, subject to the provisions of the said Act, and to be known as Ngāti Toa Barracks Historic Reserve.
