- Royalty provisions for minerals and coal production.
- A detailed summary of the reasons for and against adopting the allocation framework.
- A detailed summary of the reasons for and against adopting the royalty regime.

The programme replaces the *Minerals Programme for Minerals Other Than Coal and Petroleum* and the *Minerals Programme for Coal* that were issued to take effect from 1 October 1996.

The programme applies to all initial permit applications for minerals (excluding petroleum) received by the Crown from 1 February 2008 onwards.

Existing permit holders may however elect to transfer to the policies, procedures and provisions of the new programme should they so desire.

Pursuant to section 131(2) of the Biosecurity Act 1993, the Animal Health Board Incorporated declares those parts of New Zealand described in the Schedule to this notice to be Controlled Areas for the purpose of enabling the limitation of the spread of bovine tuberculosis.

Pursuant to section 131(3)(a) of the Biosecurity Act 1993, the Animal Health Board gives notice that the movement of cattle and deer within the Controlled Areas is restricted and regulated to the extent and subject to the conditions specified below.

#### Notice

#### 1. Definitions

In this notice, unless the context otherwise requires:

"herd" means:

- (a) a group of cattle, or deer, or cattle and deer, that is managed as one unit; or
- (b) a group of cattle, or deer, or cattle and deer, that is kept within the same enclosure or behind the same fence.
- "herd of origin" means the herd with which a cattle beast or a deer is, for the time being, grazing,
- "Order" means the Biosecurity (National Bovine Tuberculosis Pest Management Strategy) Order 1998.
- "Controlled Area" means an area specified in the Schedule to this notice.

#### 2. Testing Prior to Movement From or Within Controlled Areas

- 2.1 No cattle beast or deer aged 90 days or more may be moved:
  - (a) from any Controlled Area to a place outside that Controlled Area; or
  - (b) within any Controlled Area from its herd of origin, or the place or establishment at which the animal is being kept to a place other than a place occupied by the owner or person in charge of the cattle beast or deer

unless it has undergone, within 60 days prior to the date of movement, a negative test for bovine tuberculosis in accordance with the Order.

- 2.2 The restriction on movement in 2.1 does not apply where an animal is being moved directly to a place of slaughter.
- 2.3 Notwithstanding 2.1, an animal may be exempted from the requirement for a test in accordance with the Animal Health Board Tuberculosis Operational Plan.
- 2.4 Where a herd is managed or kept on a property, or group of properties, divided by a boundary described in the Schedule, then the requirements to test cattle or deer described in 2.1 above apply to the whole herd.

This declaration takes effect from 1 March 2008.

- 2. Failure to comply with the requirements of this notice may result in prosecution under the Biosecurity Act 1993. If convicted, an individual will be liable to a term of imprisonment not exceeding five years or a fine not exceeding \$100,000.00, or both. A corporation convicted of an offence is liable to a fine not exceeding \$200,000.00.

#### Revocation

The declaration issued on the 1st day of February 2007, in regard to movement controls for bovine tuberculosis and published in the *New Zealand Gazette*, 1 February 2007, No. 10, page 226 and in *Straight Furrow* on 6 February 2007, is hereby revoked, with effect from 1 March 2008.

#### Summary of Changes

- contact details and location of the processing facility;
- indicative forecasts of spare capacity over the short- and medium-term;
- technical capability of the plant, that is information on the ability of the plant to remove or separate various constituents; and
- summary information on any bona fide approaches by third parties investigating the possibility of having their gas processed.

A recommendation for amended regulations providing for compliance with, and enforcement of, the Gas (Processing Facility Information Disclosure) Rules was made in conjunction with this recommendation.
