- (4) breaching the Rules and/or the institute's Code of Ethics, specifically Rule 18.2 and/or 19.2(c) and/or the fundamental principle(s) of integrity and/or professional behaviour and/or Appendix 1 of the Code of Ethics; and/or
- (5) (withdrawn).

Particulars

IN THAT

In her role as a chartered accountant and in relation to complaints, the member:

- (a) has offered and/or continues to offer accounting services to the public without holding a certificate of public practice in breach of Rule 18.2; and/or
- (b) is a director and shareholder of Arnerich & Associates Limited, a company which offers accounting services to the public, without the consent of council, in breach of Rule 19.2(c); and/or
- (c) failed to comply with an undertaking to the Institute of Chartered Accountants of New Zealand, dated 15 December 2006, to completely cease advertising accounting services, in that she displayed a sign advertising her accounting services outside her house on or about 14 March 2007 and/or sent a letter printed on Arnerich & Associates Limited letterhead on or about 28 March 2007 and/or sent emails which inferred a relationship between herself and Arnerich & Associates Limited on or about 8 March 2007 and/or 22 March 2007 and/or 1 April 2007, in breach of the fundamental principle(s) of integrity and/or professional behaviour and/or Rule 1 and/or paragraph 30 of the Code of Ethics; and/or
- (d) failed to comply with an undertaking to the Institute of Chartered Accountants of New Zealand, dated 15 December 2006, to not actively pursue or take on new clients until a certificate of public practice was obtained, in that she informed the professional conduct committee that she purchased a block of fees from another member in February 2007 in breach of the fundamental principle(s) of integrity and/or professional behaviour and/or Rule 1 and/or paragraph 30 of the Code of Ethics; and/or

- (e) failed to comply with an undertaking to the Institute of Chartered Accountants of New Zealand, dated 15 December 2006, to take all steps to regulate the practice of Arnerich & Associates Limited, as soon as possible, in that she has not obtained her certificate of public practice, in breach of the fundamental principle(s) of integrity and/or professional behaviour and/or Rule 1 and/or paragraph 30 of the Code of Ethics; and/or
- (f) downloaded and/or otherwise transferred files from the client database of A & Associates to her home computer without authority and in breach of the fundamental principle(s) of integrity and/or professional behaviour and/or Rule 12 of the Code of Ethics; and/or
- (g) downloaded and/or otherwise transferred, precedents and templates from the practice of A & Associates to her home computer without authority and in breach of the fundamental principle(s) of integrity and/or professional behaviour and/or Rule 12 of the Code of Ethics; and/or
- (h) instructed an associate to provide to her, to download and/or otherwise transfer, client database records and/or precedents and templates and/or other documents, from the practice of A & Associates in breach of the fundamental principle(s) of integrity and/or professional behaviour and/or Rule 12 and/or Appendix 1 paragraph 3 of the Code of Ethics; and/or
- (i) admitted downloading and/or otherwise transferring files from the client database and/or precedents and templates and/or other documents from the practice of A & Associates, without forethought to the consequences and/or the sensitivity of the documents to A & Associates, in breach of Rule 9 and/or Rule 14 of the Code of Ethics; and/or
- (j) (withdrawn);
- (k) misled the public by advertising and using stationery which implied that she had the approval to offer accounting services to the public from the Institute of Chartered Accountants of New Zealand, in breach of the fundamental principle of integrity and/or Rule 2 of the Code of Ethics; and/or
- (1) (withdrawn).

Reasons

This case involves a member not holding a certificate of public practice who was employed by a sole practitioner who passed away after a period of illness.

The member has foolishly and impatiently proceeded to offer accounting services to the public in the expectation that a certificate of public practice was imminent.

The member has conspired with an associate to obtain intellectual property from the deceased's practice for personal advantage. The member has admitted breaching the terms of an undertaking given to the institute not to actively pursue or take on new clients.

As to publication, the tribunal is not persuaded that the member's desire for anonymity outweighs the interests of the public and the institute's members.

Orders of the Tribunal

- (a) Pursuant to Rule 21.31 (c) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Tracey Joy Arnerich** pay to the institute a monetary penalty of \$7,000.00.
- (b) Pursuant to Rule 21.31 (k) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that Tracey Joy Arnerich be censured.

(c) Pursuant to Rule 21.33 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Tracey Joy Arnerich** pay to the institute the sum of \$17,000.00 (inclusive of GST) in respect of the costs and expenses of the hearing before the disciplinary tribunal and the investigation by the professional conduct committee and the cost of the publicity.

In accordance with Rule 21.35 of the Rules of the Institute of Chartered Accountants of New Zealand, the decision of the disciplinary tribunal will automatically be published in the *Chartered Accountants Journal* and on the institute's website and the tribunal directed that the decision be published in the *Western Leader*, the *New Zealand Gazette* and the *New Zealand Herald* with mention of the member's name and locality.

The publicity in the *Chartered Accountants Journal*, the *New Zealand Gazette* and on the website will be the full version of the notice of decision, and the version in the *Western Leader* and the *New Zealand Herald* will be the abbreviated version of the notice of decision with reference to the full decision on the institute's website.

Right of Appeal

Pursuant to Rule 21.41 of the Rules of the Institute of Chartered Accountants of New Zealand which were in force at the time of the original notice of complaint, the member may, not later than 14 days after the notification of this tribunal to the member of the exercise of its powers, appeal in writing to the appeals council of the institute against the decision.

No decision other than the direction as to publicity shall take effect while the member remains entitled to appeal or while any such appeal by the member awaits determination by the appeals council.

Institute of Chartered Accountants of New Zealand —Notice of decision of the Disciplinary Tribunal (Member Guilty of Incompetence in a Professional Capacity and Breaching the Institute's Rules and/or Code of Ethics)

At a hearing of the disciplinary tribunal of the Institute of Chartered Accountants of New Zealand held in public on 26 November 2007, at which the member was in attendance and represented by counsel, **Kwok-Chi (Paul) Tsui**, a chartered accountant of Auckland, admitted particulars (a), (b), (c) and (d) and pleaded guilty to charges (2) and (3). Charge (1) was withdrawn.

The charges and particulars were as follows:

Charges

THAT in terms of the Institute of Chartered Accountants of New Zealand Act 1996 and the Rules made thereunder, and in particular Rule 21.30, the member is guilty of:

- (1) (withdrawn);
- (2) incompetence in a professional capacity that has been of such a degree and/or so frequent as to reflect on his fitness to practise as an accountant and/or tends to bring the profession into disrepute; and/or
- (3) breaching the Rules and/or the Code of Ethics, specifically Rule 20.6(d) and/or the fundamental principle of Integrity (Rule 2) and/or the fundamental principle of Competence (Rule 7 and/or

8) and/or the fundamental principle of Quality Performance (Rule 9 and/or Rule 11).

Particulars

IN THAT

In his role as a chartered accountant in public practice, the member:

- (a) In relation to Institute A:
 - (i) undertook assurance work in the form of an attestation to the New Zealand Qualifications Authority (NZQA) dated 18 August 2006 and in doing so failed to comply with the practice review board's directive in accordance with Rule 20.6(d) not to do so, pursuant to their letter to him dated 8 March 2005; and/or
 - (ii) failed to prepare sufficient documentation to carry out an assurance engagement, being a professional attestation for NZQA dated 18 August 2006, in breach of Review Engagement Standard, RS-1; and/or
 - (iii) made a false or misleading statement, in that he signed an attestation to NZQA dated 18 August 2006 that included a statement that his work was conducted in accordance with the Professional Engagement Standards issued by the Institute of Chartered Accountants of New Zealand, when this was not the case, in breach of the fundamental principle of integrity; and/or
 - (iv) made a false or misleading statement, in that he signed an attestation to NZQA dated 18 August 2006 that included a statement that he had no relationship with the entity other than in his role as an independent chartered accountant, when this was not the case as his firm also undertook compilation engagements for this client, in breach of the fundamental principle of integrity; and/or
- (b) In relation to Company B:
 - (i) failed to make proper enquiry and/or prepare appropriate documentation to support numerous transactions in the compilation of the 2005 financial statements in breach of Compilation Standards' 6 (Documentation) and/or 7 (Perusal) and/or the fundamental principle of quality performance; and/or
 - (ii) prepared an income tax return based on the financial statements that contained the entries referred to in Particular (b)(i), in breach of TG-1 and/or EG-2; and/or
 - (iii) incorrectly filed the 2005 income tax return IR4, including the annual imputation return, and in doing so demonstrating a breach of TG-1 and/or EG-2 and/or the fundamental principle of quality performance; and/or
 - (iv) failed to produce in a timely manner the supporting documentation and source documents required by the professional conduct committee pursuant to letters dated 29 January 2007 and/or 15 February 2007 and/or 20 March 2007; and/or
- (c) In relation to the compilation engagement for Company C:
 - (i) failed to maintain sufficient documentation to substantiate the inventory balance of \$358,616.00 as at 31 March 2003, in breach of Compilation Standards' 6 (Documentation) and/or 7 (Perusal) and/or the fundamental principle of quality performance; and/or

- (ii) failed to make proper enquiry into expenses introduced through a credit to the shareholder's current account in the 2002 and/or 2003 financial statements, where the amount reported as shareholder's drawings was significantly lower than appeared reasonable in breach of Compilation Standards' 6 (Documentation) and/or 7 (Perusal) and/or the fundamental principle of quality performance; and/or
- (iii) prepared an income tax return based on the financial statements that contained the entries referred to in Particular (c)(i) and/or (c)(ii), in breach of TG-1 and/or EG-2;
- (d) Failed to address a number of issues raised by practice review in the review completed in August 2004, in breach of the fundamental principle of competence and/or the fundamental principle of quality performance and/or the statement of compilation engagement standards.

Reasons

The tribunal noted that the member has not been charged with misconduct or negligence but only incompetence. There is no suggestion of lost money or client complaints and the tribunal has taken this into account.

But the incompetence has been exhibited repeatedly over many years and despite the assistance of practice review. It goes beyond mere technical non-compliance and is so significant as to reflect on the member's fitness to practise and this tends to bring the profession into disrepute.

The member has relied on information furnished by clients without any real knowledge of whether it is true or false.

The member's inability to satisfactorily answer the questions put to him by the professional conduct committee and the practice review board reinforce the level of his incompetence.

The tribunal is gravely concerned with the protection of the public.

Orders of the Tribunal

(a) Pursuant to Rule 21.31 (d) of the Rules of the Institute of Chartered Accountants of New Zealand, the

- disciplinary tribunal ordered that the certificate of public practice held by **Kwok-Chi (Paul) Tsui** be cancelled.
- (b) Pursuant to Rule 21.33 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Kwok-Chi (Paul) Tsui** pay to the institute the sum of \$14,000.00 (inclusive of GST) in respect of the costs and expenses of the hearing before the disciplinary tribunal and the investigation by the professional conduct committee and the cost of the publicity.

Fisheries (South Island Customary Fishing) Notice (No. 6) 2007 (No. F424)

Pursuant to Regulation 9(2) of the Fisheries (South Island Customary Fishing) Regulations 1999, the Programme Manager (Deed of Settlement Implementation Programme) at the Ministry of Fisheries (acting pursuant to a delegated authority in accordance with section 41 of the State Sector Act 1988) gives the following notice.

Notice

- **1. Title and commencement**—(1) This notice may be cited as the Fisheries (South Island Customary Fishing) Notice (No. 6) 2007.
- (2) This notice shall come into effect on 13 December 2007.
- **2. Interpretation**—In this notice:
 - (a) "customary food-gathering" has the same meaning as defined in the Fisheries (South Island Customary Fishing) Regulations 1999;
 - (b) "Tangata Tiaki/Kaitiaki" means the person or persons appointed under Regulation 9 of the Fisheries (South Island Customary Fishing) Regulations 1999 for the management of customary food-gathering within an area/rohe moana; and
 - (c) "area/rohe moana" means the area from the northern bank of the Hakatere River following the coast to Ounu Hau Point at Pōhatu: the area excludes Te Waihora-Lake Ellesmere (as defined as Quota

Management Area ANG 13 in the Fisheries Act 1996), its catchments and Te Wairewa-Lake Forsyth; then due east to the limit of the South Island fisheries waters; then following the boundary of the South Island fisheries waters to a point due east of the Hakatere River; and finally back to the northern bank of the Hakatere River.

- **3.** Nomination of Tangata Tiaki/Kaitiaki—The Ōnūku Rūnanga, being the tangata whenua holding manawhenua manamoana over the area/rohe moana (as represented by Te Rūnanga o Ngāi Tahu), has nominated Bruce Rhodes and Meri Robinson as Tangata Tiaki/Kaitiaki for the area/rohe moana for further five-year terms.
- **4. Appointment of Tangata Tiaki/Kaitiaki**—On 21 November 2007, the Associate Minister of Fisheries confirmed, under Regulation (9)(5) of the Fisheries (South Island Customary Fishing) Regulations 1999, the reappointment of Bruce Rhodes and Meri Robinson for managing customary food-gathering in the area/rohe moana. The appointments are for five years commencing on 13 December 2007.
- 5. Power to authorise the taking of fisheries resources for customary food-gathering—A Tangata Tiaki/Kaitiaki may authorise any individual to take fisheries resources managed under the Fisheries Act 1996 for customary food-gathering purposes from within the whole or any part of the area/rohe moana for which they have been appointed as a Tangata Tiaki/Kaitiaki. No customary food-gathering of fisheries resources may take place in the area/rohe moana without an authorisation from a Tangata Tiaki/Kaitiaki.

- "special deposit" means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;
- "trust deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:
 - (i) for persons not of full age or capacity; or
 - (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.
- (2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.
- **3. Rates of Common Fund interest**—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.
- (2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.

Where early application of the revised NZ IAS 1 is permitted for an entity, NZ IAS 1 *Presentation of Financial Statements* (2004) is deemed to be withdrawn in relation to that entity upon such early application.
