##### ACC Board Levy Recommendations for 2008/09 Following Consultation

Under the Injury Prevention, Rehabilitation, and Compensation Act 2001, the ACC Board has recommended to the Minister for ACC the levy rates for the 2008/09 levy year.

In recommending these levy rates, the board has considered submissions received as part of the public consultation process.

The ACC Board’s recommendations are not binding on the Minister, who will obtain further advice from officials and actuaries before making recommendations to Cabinet.

Cabinet is expected to decide on the 2008/09 levy rates by December 2007.

The Minister for ACC will announce the rates once they are decided.

The ACC Board levy recommendations are summarised as follows (GST exclusive):

The only change in the average levy rates recommended to the Minister for ACC from those consulted on publicly is a \$0.01 increase in the combined average levy rate for self-employed people and employers.

This change is in the levy rate for injury claims prior to 1999 and is the result of updating the interest rate used to calculate levies from 6.61% as at 30 June 2007 to 6.1% at 30 September 2007.

The only change in the motor vehicle levy is that it is recommended that it is split between petrol levy (60%) and licence fee (40%).

**ACC also recommended that:**

- a small number of changes be made to classification units;
- the number of levy risk groups be reduced from 127 to 117 and be based on the latest version of the Australia New Zealand Standard Industrial Classification (ANZSIC) codes; and
- 41 risk groups for pre-1999 claims levy be maintained.

Individual rates will be finalised and incorporated into levy regulations once the Government has set the average rates.

## Customs

### Customs and Excise Act 1996

#### Customs (Volume of Alcohol) Rules 2007 (CR IG/2007)

Pursuant to section 288(1)(g) of the Customs and Excise Act 1996, the chief executive hereby makes the following rules prescribing the manner in which the volume of alcohol in an alcoholic beverage is to be ascertained and revokes the Customs (Volume of Alcohol) Rules 1996, Amendment No. 1 (CR IG/1996)\*.

#### **Rules**

**1. Title, Commencement, Application and Purpose—**  
(a) These rules may be cited as the Customs (Volume of Alcohol) Rules 2007 (CR IG/2007).

(b) These rules shall come into force on the 28th day after the day of the publication of these rules in the *New Zealand Gazette*.

(c) These rules shall apply for the purposes of prescribing the manner in which the volume of alcohol in an alcoholic beverage is to be ascertained.

(d) The volume of alcohol in an alcoholic beverage shall be ascertained by multiplying the quantity of litres of the particular beverage by its alcoholic strength in accordance with these rules.

**2. Interpretation—**In these rules, unless the context otherwise requires:

- (a) the term “the Act” means the Customs and Excise Act 1996;
- (b) Any terms used in these rules which are defined in Section 2 of the Act shall have the meanings given to them by that section;
- (c) “targeted strength” means the intended percentage of alcohol by volume for each product, and each brand of the product in relation to alcoholic beverages, as advised by the manufacturer in accordance with such conditions as may be specified under section 12(2) of the Act;
- (d) “weighted mean value”, in relation to beer which is accounted for in an entry for home consumption, means the percentage of alcohol by volume obtained by dividing the total quantity of litres of alcohol, as ascertained in accordance with these rules, by the total quantity of litres of beer so entered.

**3. Methods to ascertain volume of alcohol in beer—**The volume of alcohol in beer may be ascertained by any one or more of the following processes:

- (a) by use of a Servo Chem Automatic Beer Analyser; or
- (b) by use of headspace gas chromatography; or
- (c) by use of gas chromatography with liquid injection; or
- (d) by way of distillation followed either by the gravimetric measurement of the distillate or by measurement in an oscillating U-tube type density meter; or
- (e) by use of near infra red spectroscopy.

**4. Methods to ascertain volume of alcohol in alcoholic beverages other than beer—**The volume of alcohol in alcoholic beverages other than beer may be ascertained by anyone or more of the following processes:

- (a) by use of headspace gas chromatography; or
- (b) by use of gas chromatography with liquid injection; or
- (c) by way of distillation followed either by the gravimetric measurement of the distillate or by measurement in an oscillating U-tube type density meter; or
- (d) by way of Hydrometric testing using an OIML hydrometer of the British Standard BS 5470, in the case of goods of a class or kind which, if imported, would be classified in Tariff headings 2208.20 to 2208.60, or in Tariff items 2208.90.42 or 2208.90.48.

Provided that if the Chief Executive has reason to believe that any alcoholic beverage analysed by use of the process specified in paragraph (d) of this rule has had added to it any substance so as to impair the hydrometer reading, he or she may disregard the results so obtained and require the beverage to be analysed using any one or more of the processes specified in paragraphs (a), (b) or (c) of this Rule.

**5. Manner of calculating the volume of alcohol—**(1) For the purposes of the Act, the volume of alcohol present in an alcoholic beverage shall be calculated on an entry as the amount corresponding to the value of “C” in accordance with the formula:

$$C = A \times B$$

where:

A is the total quantity of the beverage, in liquid litres, to which the entry relates; and

B is the alcohol strength of the beverage.

(2) For the purposes of paragraph (1) of this rule, in respect of alcoholic beverages, other than beer, the alcohol strength is:

- (a) The targeted strength providing that, when tested, it is equal to the strength obtained from analysis in accordance with these rules; or
- (b) where the targeted strength is not confirmed when tested, the result obtained by analysis in accordance with these rules.

(3) Subject to paragraph (5) of this rule, for the purposes of paragraph (1) of this rule, in respect of beer the alcoholic strength is:

- (a) Subject to paragraph (4) of this rule, where the targeted strength is confirmed within plus 0.04% by the weighted mean value, the targeted strength stated to 2 decimal places; or
  - (b) Subject to paragraph (4) of this rule, where the targeted strength is not confirmed pursuant to subparagraph (a) of this rule when tested and the weighted mean value exceeds the targeted strength by more than 0.04%, the weighted mean value stated to 2 decimal places; or
  - (c) The weighted mean value where the targeted strength is not confirmed when tested and the weighted mean value is less than the targeted strength. Provided that where the weighted mean value is less than the targeted strength for more than two consecutive entries the alcoholic strength shall, in the third entry and all entries made thereafter, be declared as the targeted strength stated to 2 decimal places, until such time as the targeted strength or more than such strength is achieved.
- (4) Notwithstanding subparagraphs 3(a) and (b) of this rule, with respect to beer, if in the case of two successive entries the weighted mean value exceeds the targeted strength, the alcoholic strength for the purposes of paragraph (1) of this rule shall, for the third entry and all entries made thereafter be the weighted mean value until that value is equal to or is less than the targeted strength.

(5) Where the production of beer at any one place of manufacture:

- (a) is not expected to exceed 2,000,000 litres per annum intended to be entered for home consumption; and
- (b) analyses are not done in accordance with paragraph (3) of this rule the alcoholic strength is:
  - (i) The targeted strength when confirmed by analyses of three consecutive brews of that beer, at intervals not exceeding 6 months, obtained by using any one or more of the methods to ascertain the volume of alcohol in beer as set out in rule 3 of these rules; or
  - (ii) Where the beer is packaged with a stated label strength or, in the case of bulk beer, where the product is otherwise packaged with a stated label strength; and
  - (iii) The label strength is no less than the targeted strength for the product, the alcoholic strength for the purposes of paragraph (1) of this rule shall be the label strength.

**6. Revocation of the Customs (Volume of Alcohol) Rules 1996, Amendment No. 1**—The Customs (Volume of Alcohol) Rules 1996, Amendment No. 1 (CR 1G/1996)\* are hereby revoked.

“protection deposit” means a deposit, held at call, of tuition, boarding, accommodation or other fees by or on behalf of a student enrolled at a private training establishment within the meaning of Part 18 of the Education Act 1989;

“special deposit” means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

“trust deposit” means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Rates of Common Fund interest—**(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.

(3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.

(4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(5) Despite subparagraphs (1), (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on investment deposits, protection deposits or special deposits that is different from the rate specified in Schedules 1, 2, or 3 and the agreed rate then applies.

#### **4. Revocation of notice and transitional provisions—**

(1) The Public Trust Common Fund Interest Rates Notice 15 November 2007 is revoked.

#### Biosecurity (Bovine Tuberculosis-Otago Land Levy) Order 1998

##### Levy on Rural Land in the Otago Region

Pursuant to the Biosecurity (Bovine Tuberculosis-Otago Land Levy) Order 1998 made under the Biosecurity Act 1993, a levy is payable to the Animal Health Board (Inc.) by the occupiers of all rural landholdings 4 hectares or more in area in the Otago Region.

The purpose of the levy is to partially fund Tb vector control operations in Otago under the National Bovine Tuberculosis Pest Management Strategy.

For the 2007/2008 financial year, the single rate of levy payable is 0.01225% (\$12.25) per \$100,000.00 of the property land value recorded in the district valuation roll on 1 July 2007 (GST exclusive).

For the purpose of calculating the levy payable, no property shall be valued at more than \$5,000.00 per hectare.

Where the levy payable is less than \$10.00 excluding GST for the property, the occupier is exempt from payment of the levy and will not receive an invoice.

Land occupiers will be invoiced by the Animal Health Board for levies payable on or after 7 February 2008.

The due date for payment of levies is 31 March 2008.

It ordered that **Dalip Chand** must pay \$3,000.00 as a contribution towards the tribunal's costs and \$3,000.00 as a contribution towards the professional conduct committee's costs.

It also directed that the details of this decision are to be published in the *New Zealand Gazette*, *Kai Tiaki: Nursing New Zealand*, *New Zealand Nursing Review* and the newsletter of the Nursing Council of New Zealand, with express reference being made to **Dalip Chand**'s name.
