#### Fisheries (Kaimoana Customary Fishing) Notice (No. 7) 2007 (No. F407)

Pursuant to Regulation 9 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998, the Programme Manager (Deed of Settlement Implementation Programme) at the Ministry of Fisheries (acting pursuant to a delegated authority in accordance with section 41 of the State Sector Act 1998) gives the following notice.

#### Notice

**1. Title and commencement**—(1) This notice may be cited as the Fisheries (Kaimoana Customary Fishing) Notice (No. 7) 2007.

(2) This notice shall come into effect the day after the date of its notification in the *New Zealand Gazette*.

#### 2. Interpretation

In this notice:

- “customary food-gathering” has the same meaning as defined in Regulation 2 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998.
- “Kaitiaki Kaimoana” are local dialect words that have the same meaning as “Tangata Kaitiaki/Tiaki”, a term that is defined in Regulation 2 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998.
- “Kaitiaki Kaimoana” means the person or persons appointed under Regulation 9 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998 for the management of customary food-gathering within the area/rohe moana.
- “area/rohe moana” means the area described by a line commencing at a point on the line of mean high-water springs at the mouth of the Huikomako Stream (38°30.44’S 174°37.95’E); then due west for 200 nautical miles to a point on the Exclusive Economic Zone (38°30.44’S 170°23.49’E); then north following the Exclusive Economic Zone to a point due west of Tapirimoko Point (38°21.84’S 170°25.65’E); then due east for 200 nautical miles to a point on the line of mean high-water springs at Tapirimoko Point (38°21.84’S 174°39.60’E); then generally southerly following the line of mean high-water springs to the point of commencement. The geographical coordinates named are in terms of the WGS84 datum.

**3. Nomination of Kaitiaki Kaimoana**—Ngāti Kinohaku, as represented by the Oparure Marae, has nominated George Kete, Perry Taituha and Stephen Rewi Walsh as Kaitiaki Kaimoana for managing customary food-gathering within the area/rohe moana.

**4. Appointment of Kaitiaki Kaimoana**—On 1 May 2007, the Associate Minister of Fisheries confirmed the appointment of George Kete, Perry Taituha and Stephen Rewi Walsh as Kaitiaki Kaimoana for managing customary food-gathering within the area/rohe moana.

**5. Confirmation of tangata whenua**—Ngāti Kinohaku, as represented by the Oparure Marae, is confirmed as the tangata whenua of the area/rohe moana to which the appointment of Kaitiaki Kaimoana relates.

**6. Power to authorise the taking of fisheries resources for customary food-gathering**—A Kaitiaki Kaimoana may authorise any individual to take fisheries resources managed under the Fisheries Act 1996, other than those resources that are taken in fresh water, for customary food-gathering purposes from within the whole or any part of the area/rohe moana. No customary food-gathering of fisheries resources may take place in the area/rohe moana without an authorisation from a Kaitiaki Kaimoana.

## Electricity Commission

### Electricity Act 1992

#### Notice of Making of Electricity Governance Amendment Rules (No. 52) 2007 and Notice of Reasons for Decision

1. Pursuant to section 172I of the Electricity Act 1992 ("Act"), I notify the amendment of the Electricity Governance Rules 2003 ("Rules") under section 172H of the Act.

2. The empowering provisions for the Electricity Governance Regulations in relation to which the amendments to the Rules are made are sections 172D(1)(4)–(6), 172D(1)(28)–(31), 172J(1)(a), 172J(1)(aa), 172J(1)(b), 172J(1)(g) and 172KA of the Act.

3. A brief description of the nature of the amendments are as follows:

- (a) The addition of a new Schedule F1 to Section II of Part F of the Rules to add the categories of designated transmission customers for the purposes of Rule 2 of Section II of Part F;
  - (b) the addition of a new Schedule F2 to Section II of Part F of the Rules, setting out the Benchmark Agreement for the purposes of Rule 4 of Section II of Part F;
  - (c) amendments to Sections I, II, III and IV of Part F of the Rules associated with the Benchmark Agreement;
  - (d) the addition of a new Section VI to Part F of the Rules to provide for rules relating to interconnection asset services;
  - (e) the addition of a new Section VII to Part F of the Rules to establish rules to provide for the making of an Outage Protocol; and
  - (f) related amendments to Part A of the Rules to add new definitions.
4. Some of the amendments are made in reliance on section 172F(3) of the Act.
5. Pursuant to section 172Z(4) of the Act, the reasons for my decision to amend the Rules are that:
- (a) Rules 2 and 4 of Section II of Part F of the Rules require the Electricity Commission to make recommendations to me about new schedules to Section II of Part F:
    - (i) to cover the categories of designated transmission customers required to enter into transmission agreements with Transpower; and
    - (ii) to include the Benchmark Agreement in the Rules;
  - (b) the Electricity Commission has determined that the categories of designated transmission customers and the Benchmark Agreement give effect to the matters provided for in Rules 2 and 4 of Section II of Part F of the Rules, respectively;

- (c) the changes to Sections I, II, III and IV of Part F of the Rules are related to the Benchmark Agreement, and give effect to the proposals in the Benchmark Agreement;
  - (d) the new Section VI of Part F provides for rules for interconnection services as it is not possible to provide for this in the Benchmark Agreement, due to the common good nature of interconnection services;
  - (e) the new Section VII of Part F requires the making of an Outage Protocol, which is required for the purposes of the Benchmark Agreement and the interconnection rules in new Section VI; and
  - (f) the new definitions in Part A are incidental to the above amendments.
6. These Rules come into force as follows:
- (a) Rules 5.5 to 5.9 of Section II of Part F and Rules 5 to 8 of Section VI of Part F come into force on 1 April 2008; and
  - (b) the rest of the amendments come into force on 28 June 2007.

This notice of a recommendation and assessment concerning the Electricity Governance Rules 2003 ("Rules"), Rule Amendment Proposals No. 40 and No. 64, is issued by the Electricity Commission ("Commission"), established under the Electricity Act 1992 ("Act"), pursuant to section 172E(2)(c) of the Act.

2. Section 172E(2)(c) of the Act provides that, no later than 10 working days after making a recommendation concerning the Rules to the Minister of Energy, the Commission must publicise the recommendation and the assessment completed under section 172F of the Act.

#### Recommendation

3. On 21 May 2007 the Commission made a recommendation that the Rules be amended. The Commission's recommended amendments to the Rules consisted of the following:

- (a) The addition of a new Schedule F1 to Section II of Part F of the Rules to add the categories of designated transmission customers for the purposes of Rule 2 of Section II of Part F;

- (b) the addition of a new Schedule F2 to Section II of Part F of the Rules, setting out the Benchmark Agreement for the purposes of Rule 4 of Section II of Part F;
- (c) amendments to Sections I, II, III and IV of Part F of the Rules associated with the Benchmark Agreement;
- (d) the addition of a new Section VI to Part F of the Rules to provide for rules relating to interconnection services;
- (e) the addition of a new Section VII to Part F of the Rules to establish rules to provide for the making of an Outage Protocol; and
- (f) amendments to Part A of the Rules to add new definitions related to the above Rule amendments.

#### Recommended Amendment to the Rules

4. The recommended amendments to the Rules to insert the Commission's proposed Benchmark Agreement, Interconnection Rules and Outage Protocol Rules in Part F of the Rules and the other proposed amendments were part of an integrated package to provide for the regulation of transmission services.

## Electricity Governance Regulations 2003

### Electricity Governance Regulations (Exemption No. 44 (Pricing Manager)) Exemption Notice 2007

Pursuant to Regulation 194(2) of the Electricity Governance Regulations 2003, the Electricity Commission ("Commission") gives the following notice.

#### Notice

**1. Title and commencement**—(1) This notice is the Electricity Governance Regulations (Exemption No. 44 (Pricing Manager)) Exemption Notice 2007.

(2) This notice comes into force on the day after the date it is notified in the *New Zealand Gazette*.

**2. Exemption**—The Pricing Manager is exempted from compliance, to the extent set out below, with Rules 3.1 and 3.4 of Section V of Part G of the Electricity Governance Rules 2003 ("Rules").

**3. Terms and conditions**—This exemption is granted on the following conditions:

- (a) It only applies in respect of trading period 37 on 29 April 2007;
- (b) the Pricing Manager must calculate final prices and final reserve prices for trading period 37 on 29 April 2007 by using the methodology and inputs required under the Rules, except that:
  - (i) the transmission security constraint that has bound in that trading period, the MGM\_WDV\_1\_MGM\_OTAS\_DISABLED\_S\_P\_1B group constraint, will be relaxed by applying the greater of 1 MW or 1% of that transmission security constraint in that trading period to the maximum flow limit of the transmission security constraint; and

- (ii) for the purposes of this exemption, a transmission security constraint is a flow limit covered by Rule 5.4(a) or Rule 5.4(c) of Schedule G6 of Part G of the Rules, including any adjustments that have been made in accordance with paragraphs (d) and (f) of Rule 4.2 of Schedule G6 of Part G of the Rules, but excluding a flow limit set in relation to the HVDC link; and

- (c) the Pricing Manager must publish final prices and final reserve prices within two business days of this exemption coming into force;
- (d) in all other respects, the Pricing Manager must calculate and publish final prices and final reserve prices, for trading period 37 on 29 April 2007, in accordance with the processes and requirements set out in the Rules;
- (e) upon the Pricing Manager publishing the final prices and final reserve prices, for trading period 37 on 29 April 2007, in accordance with this exemption, those prices shall be the final prices and final reserve prices for trading period 37 on 29 April 2007 for all purposes under the Rules; and
- (f) it expires on the day after the date upon which the final prices and final reserve prices are published, in accordance with the conditions set out above, in respect of trading period 37 of 29 April 2007.

**4. Reasons for granting the exemption**—The reasons for granting this exemption are:

- (a) On 30 April 2007, the Commission delayed the publication of final prices and final reserve prices in accordance with Rule 3.28 of Section V of Part G of the Rules;
- (b) the prices for this trading period were extreme, both high and low;
- (c) these extreme prices would otherwise have a significant impact on some participants;
- (d) although on 1 March 2007 the Minister published a notice in the *New Zealand Gazette*, making an amendment to the Rules to introduce a mechanism to resolve high spring washer price situations such as this, the amendment does not come into force until 3 September 2007; and
- (e) the Commission considers that it would be appropriate for prices for the trading period to be calculated in the manner specified in clause 2 of this notice, rather than in the manner set out in the Rules.

#### Land Transport Rules

In accordance with section 161(2) of the Land Transport Act 1998, Land Transport New Zealand, on behalf of the Minister of Transport, gives notice of the Minister's intention to make a Rule concerning emissions standards for vehicles entering the New Zealand fleet, and advises that draft *Land Transport Rule: Vehicle Exhaust Emissions [2007]* (Rule 33001/2) is available for public comment.

This draft Rule revises and replaces *Land Transport Rule: Vehicle Exhaust Emissions 2006* (Rule 33001/1).

The revised Rule updates the existing minimum standards for new vehicles entering the fleet.

It would require minimum emissions standards for used vehicles imported into New Zealand and introduce a requirement to test the emissions of those vehicles.

It also proposes other, minor changes to clarify elements of the Rule.

These automotive CNG fuel cylinders are approved subject to the following conditions:

1. That they comply with all the design, performance and test requirements of New Zealand Standard NZS 5454:1989 as applicable to all-metal steel cylinders.
2. That they be provided with a cylinder shut-off valve designed for the cylinder working pressure and compatible with the test pressure of the cylinder. Cylinder shut-off valves shall be fitted with a handwheel to facilitate ease of opening and closing of the valve and shall be fitted with a pressure relief device, which remains in contact with the gas contained in the cylinder whether the handwheel is in the open or closed position, comprising a burst disc backed with a fusible alloy plug having a nominal melt temperature of 100°C. Should the alloy plug melt, the burst disc shall yield at a pressure of not less than 24.7MPa and not more than 30.0MPa, otherwise it shall remain inoperative. Cylinder valves shall be provided with an outlet thread of 1/4" NPT (female) and a stem thread compatible with the cylinder neck thread.
3. That they are tested at periods not exceeding five years, in accordance with the requirements of Australian Standard AS 2337.1.
4. That the cylinder markings are in accordance with section 9 of New Zealand Standard NZS 5454:1989.
5. That the neck threads meet the specification required for the market the cylinders are manufactured for.
