Fair Trading Act 1986

Unsafe Goods (Hot Water Bottles) Notice 2007

Pursuant to section 31 of the Fair Trading Act 1986, the Minister of Consumer Affairs gives the following notice.

Notice

1. Title—(1) This notice may be cited as the Unsafe Goods (Hot Water Bottles) Notice 2007.

(2) This notice is effective from 26 May 2007.

2. Certain hot water bottles declared to be unsafe goods—Goods which do not comply with the Schedule to this notice are declared to be unsafe goods.

3. Certain hot water bottles exempt—This notice does not apply to rubber or PVC hot water bottles that are carried in the baggage or effects of a person arriving in New Zealand where the number of hot water bottles carried is four (4) or fewer.

Clause 2 of the Schedule does not apply to PVC hot water bottles before 25 November 2007.

4. New Zealand Customs Service requirements—All persons importing rubber or PVC hot water bottles to which this notice applies into New Zealand must produce to a New Zealand Customs officer:

- (a) documentation showing that the hot water bottles comply with clauses (1) and (2) of the Schedule; and
- (b) a statutory declaration that the documents produced relate to those hot water bottles being imported.

This clause 4 does not apply to PVC hot water bottles imported before 25 November 2007.

Rubber and PVC hot water bottles must:

Radiocommunications Act 1989

Statement of Government Policy and Directions to Chief Executive of Ministry of Economic Development

To: The Chief Executive of Ministry of Economic Development.

Pursuant to section 112 of the Radiocommunications Act 1989 ("the Act"), I hereby give you notice that it is part of the general policy of the Government, in relation to your functions, duties and powers under the Radiocommunications Regulations 2001 ("the Regulations")—

A That for the purposes of this notice, any applicant for a non-commercial broadcasting licence must meet the following criteria:

- (i) The applicant must not be a rightholder of a spectrum licence which could be used for the purpose;
 - (ii) the constitution or articles of association of the applicant or funding organisation show it to be clearly non-profit in nature;
 - (iii) the applicant can demonstrate that it does not intend to operate its service at a profit, can identify a permanent fund-raising mechanism to cover its costs, and is demonstrably financially viable and sustainable within existing public funding arrangements;
 - (iv) the format the applicant proposes is not operated by other stations on a "for profit" basis, and must complement and provide alternative services to those offered by existing broadcasters;
 - (v) the applicant is not primarily intending to raise funds for charitable purposes;
 - (vi) the applicant is not paying higher than market rates for salaries or for other services. Such rates of payment would be taken to indicate a de-facto commercial service where proprietors received financial benefits for their services;
 - (vii) advertising (or decoder revenue) is not planned to be more than 50% of the revenue. Taken as a general guideline, this would demonstrate the good faith of the organisation in respect of its intentions to operate on a non-profit basis; and
 - (viii) the service is driven by programming tailored to a particular audience rather than the need to deliver a desired audience for advertisers; and
- B That the Government's broadcasting policy objectives are to:
- (i) ensure that all New Zealanders have reasonable and regular access to broadcasting representing the uniqueness and diversity of New Zealand life, recognising that the histories and stories of whānau, hapū and iwi are integral to any description of that life;
 - (ii) meet the information and entertainment needs of as many interests as reasonably possible, including those that cannot be met by commercial broadcasting;
 - (iii) contribute to public awareness of and participation in the political and social debates of the day;
 - (iv) provide for minority interests and increased choice; and
 - (v) encourage innovation and creativity in broadcasting while aiming to continually increase audience satisfaction with the quality of the content; and
- C That there should be competition in the provision of telecommunication services; and
- D That in the granting of radio licences, consideration should be given to permitting a range of uses and users in any given frequency band; and
- E That until a decision is made concerning the creation of management rights in bands allocated for broadcasting services, radio licences granted pursuant to Regulation 8 of the Regulations should be limited to:
- (i) maintaining the coverage of services provided by existing licensees; or
 - (ii) implementing new television broadcasting services where the primary objective is the promotion of Māori language and culture; or
 - (iii) implementing new television broadcasting services where such services are undertaken otherwise than for profit; and
- F That until a decision is made concerning the creation of management rights in bands that are subject to international planning processes for the introduction of new technologies and services, radio licences granted pursuant to Regulation 8 of the Regulations should be limited to:
- (i) facilitating the transition of existing licensed services to alternative frequencies; and
 - (ii) demonstrating, subject to protecting existing licensed services, the operation of new technologies; and
- G That licensing of New Zealand originated short wave radio broadcasting, in frequency bands below 30 MHz allocated to broadcasting under Article s5 of the ITU International Radio Regulations, should be consistent with the foreign policy of the Government of New Zealand; and
- H That adequate provision should be made, in common frequency bands where practicable, for the licensing of services operated by Government departments and Crown agencies, where the primary objective of such services is the protection of life and property; and
- I That adequate provision should be made, pursuant to Regulation 9 of the Regulations and in common frequency bands where practicable, for the licensing of classes of low-powered radio transmitters; and
- J That until a decision is made concerning the outcomes of the review of security of tenure for radio licences, no further changes to the spectrum allocations for land mobile bands (as set out in Issue 5 of the Public Information Brochure 21) will be made.
- Pursuant to the above policies, I hereby direct you as follows:
1. You shall not grant new radio licences for services in the ranges of frequencies:
- (a) 525 kHz to 1705 kHz;
 - (b) 88 MHz to 108 MHz;
 - (c) 494 MHz to 806 MHz;
 - (d) 1461.5 MHz to 1490 MHz;
 - (e) 11.7 GHz to 12.75 GHz;
- except where the granting of radio licences is necessary for the purpose of:
- (i) maintaining the coverage of services provided by existing licensees; or
 - (ii) facilitating, by means of short-term licences, the transition of existing licensed services to alternative frequencies; or
 - (iii) demonstrating, by means of short-term licences and subject to the protection of existing licensed services, the operation of new technologies; or
 - (iv) implementing new television broadcasting services in the range of frequencies 582 MHz to 614 MHz, where the primary objective is the promotion of Māori language and culture; or
 - (v) implementing new television broadcasting services in the range of frequencies 614 MHz to 646 MHz, where such services are undertaken otherwise than for profit; or
 - (vi) facilitating the short-term operation of non-broadcasting services in the range of frequencies 494 MHz to 518 MHz for specific events.
- In granting applications for radio licences for television services under subsection (v), you shall have regard to the following matters:
- 1. The extent to which the proposed service contributes to Government's broadcasting objectives.

2. The extent to which the proposed service is consistent with the definition of a non-commercial broadcaster.
3. The capability of the proposed service to commence within two years.
4. The extent to which the proposal increases the diversity of programme choice for viewers.
5. The extent to which a proposal can provide non-commercial services not being provided on a national level. These may include parliamentary broadcasts, educational services such as foreign language programming, religious programming, coverage of minority sports, and New Zealand documentaries and short films.
6. The extent to which the proposal provides access to local and regional programme makers.
7. The extent of geographic coverage possible for non-commercial services, given spectrum capacity.
8. The extent to which time is made available for non-commercial uses, including prime time.
9. The extent to which the proposal can demonstrate that its overall objective is "not for profit".
10. The prospect that the proposal will be implemented.
11. The extent to which the proposal contains sufficient accountability mechanisms to ensure that it delivers on its undertakings to provide services. Arrangements may include:
 - A. mechanisms for equitable allocation of air time amongst all interested users;
 - B. procedures for resolving disputes over allocation of time to users;
 - C. systems for ensuring efficient management of services;
 - D. provision of satisfactory services to the full variety of audiences to be catered for;
 - E. mechanisms for ensuring compliance by all users on the frequency with broadcasting standards.
12. Any potential future public benefit from providing for the transition of services to digital transmission.
13. Any other benefits the proposal may offer.

2. Application of this notice—You shall comply with the directions set out above in relation to all applications for radio licences, including applications made before the date of this notice but not dealt with before that date.

3. Revocation of previous notices—All previous statements of Government policy made pursuant to section 112 of the Act are hereby revoked.

Fisheries (Kaimoana Customary Fishing) Notice (No. 6) 2007 (No. F406)

Pursuant to Regulation 10 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998, the Programme Manager (Deed of Settlement Implementation Programme) at the Ministry of Fisheries (acting pursuant to a delegated authority in accordance with section 41 of the State Sector Act 1998) gives the following notice.

1. Title and commencement—(1) This notice may be cited as the Fisheries (Kaimoana Customary Fishing) Notice (No. 6) 2007.

(2) This notice shall come into effect the day after the date of its notification in the *New Zealand Gazette*.

2. Interpretation—In this notice:

- (a) “customary food-gathering” has the same meaning as defined in Regulation 2 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998;

(Kaimoana Customary Fishing) Regulations 1998 for the management of customary food-gathering within the area/rohe moana; and

- (d) “area/rohe moana” means the area described by a line commencing at a point on the coastline at Wairakei (37°42.9'S, 176°20.2'E), then generally north-westerly following the coastline and Tauranga Harbour to a point on the coastline at Uretara (37°29.8'S, 175°57.6'E), then north-easterly by a line to a point on the coastline at Kura-a-Maia (37°27.9'S, 175°59.2'E), then generally north-easterly for 24 nautical miles to a point (37°10.3'S, 176°19.7'E), then south-easterly to a point (37°25.3'S, 176°40.7'E) then generally south-westerly for 24 nautical miles to the point of commencement. The geographical coordinates named are in terms of the WGS84 datum.

3. Request to cancel appointments—The Tauranga Moana Iwi Customary Fisheries Working Committee, on behalf of Ngāiterangi, Ngāti Ranginui and Ngāti Pukenga, being the tangata whenua who nominated Waraki Paki and Tei Walker as Tangata Kaitiaki for the area/rohe moana, has requested in writing the cancellation of the appointment of Waraki Paki and Tei Walker as Tangata Kaitiaki.

4. Cancellation of appointments—On 8 May 2007, the Associate Minister of Fisheries confirmed the cancellation of the appointment of Waraki Paki and Tei Walker as Tangata

Kaitiaki for managing customary food-gathering within the area/rohe moana.

5. Nomination of Tangata Kaitiaki—The Tauranga Moana Iwi Customary Fisheries Working Committee, on behalf of Ngāiterangi, Ngāti Ranginui and Ngāti Pukenga, has nominated Paul Borell and Peter Walker as replacement Tangata Kaitiaki for managing customary food-gathering within the area/rohe moana.

6. Appointment of Tangata Kaitiaki—On 8 May 2007, the Associate Minister of Fisheries confirmed the appointment of Paul Borell and Peter Walker as replacement Tangata Kaitiaki for managing customary food-gathering within the area/rohe moana.

7. Power to authorise the taking of fisheries resources for customary food-gathering—A Tangata Kaitiaki may authorise any individual to take fisheries resources managed under the Fisheries Act 1996, other than those resources that are taken in fresh water, for customary food-gathering purposes from within the whole or any part of the area/rohe moana. No customary food-gathering of fisheries resources may take place in the area/rohe moana without an authorisation from a Tangata Kaitiaki.

Health (Quarantine) Regulations 1983

Ship Sanitation Inspection and Certification Fees

Pursuant to Regulation 15(3) of the Health (Quarantine) Regulations 1983, the Director-General of Health has fixed the fee for a health protection officer to conduct a ship sanitation/sanitation exemption inspection and/or issue a certificate at \$96.00 per hour (excluding GST) payable to the district health board (DHB) conducting the inspection and/or issuing the certificate with effect from 15 June 2007.

Background Information

The Health (Quarantine) Regulations 1983 permit charging for the issuing of deratting certificates and exemption certificates.

Regulation 15(3) states that the fee for a deratting certificate or a deratting exemption certificate shall be such as may be fixed from time to time by the Director-General of Health.

The fee for issuing a certificate was \$150.00 (including GST) or \$133.33 (excluding GST), payable to the DHB public health unit which provided the certificate.

This fee was unchanged for over ten years.

Following the World Health Organization's International Health Regulations (IHR) 2005 coming into force on 15 June 2007, ships arriving in New Zealand will be required to obtain ship sanitation/ship sanitation exemption certificates rather than deratting/deratting exemption certificates.

As part of implementing the IHR in New Zealand, the Director-General of Health reviewed the fee for inspections and certification and set the fee for ship sanitation inspections and certification at \$96.00 per hour (excluding GST).

Fees for ship sanitation inspections and certification will be charged only for the health protection officer's time for the inspection (including travel time).

It is estimated that deratting activities currently take a health protection officer between one and one and a half hours to complete.

The ship sanitation regime may be expected to take between two and three and a half hours, and up to five hours or longer in exceptional circumstances (depending on the size, complexity and sanitary conditions on an individual vessel).

The implications of these revised fees and charges are expected to be that the cost of the proposed ship sanitation/ship sanitation exemption inspection and certification regime will be around \$192.00–\$336.00 (excluding GST) per vessel.

This estimated cost is based on scoping the services involved in ship sanitation, compared with deratting activities.

The new fees and charges will take effect from 15 June 2007, when the ship sanitation/ship sanitation exemption inspection and certification regime will also take effect.

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

3. Rates of Common Fund interest—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.
