### Public Trust Act 2001

#### The Public Trust Common Fund Interest Rates Notice 22 March 2007

The following notice is given pursuant to section 50 of the Public Trust Act 2001 ("the Act").

#### Notice

**1. Title and commencement**—(1) This notice may be cited as the Public Trust Common Fund Interest Rates Notice 22 March 2007.

(2) The determinations and revocation notified in this notice take effect from and including 15 March 2007.

**2. Interpretation**—(1) Unless the context otherwise requires:

"agency deposit" means a deposit (not being an investment deposit) held as agent or attorney;

"call deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call;

"deposit" means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;

"investment deposit" means a deposit held at call or otherwise as an investment under section 51 of the Act;

"protection deposit" means a deposit, held at call, of tuition, boarding, accommodation or other fees by or on behalf of a student enrolled at a private training establishment within the meaning of Part 18 of the Education Act 1989;

"special deposit" means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

"trust deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Rates of Common Fund interest**—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.

(3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.

(4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(5) Despite subparagraphs (1), (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on investment deposits, protection deposits or special deposits that is different from

the rate specified in Schedules 1, 2, or 3 and the agreed rate then applies.

#### 4. Revocation of notice and transitional provisions—

(1) The Public Trust Common Fund Interest Rates Notice 8 February 2007 is revoked.

(2) The rates of interest specified in Schedules 1 and 2 to this notice do not apply to any period that ends with 14 March 2007 but otherwise operate as from 15 March 2007.

(3) The rates of interest specified in Schedule 3 to this notice:

- (i) do not apply to investment deposits repayable at the end of a fixed term that commenced prior to 15 March 2007; but

Pursuant to section 4 of the Finance Act (No 2) 1990, His Excellency the Governor-General, acting on the advice and with the consent of the Executive Council and on the advice of the Minister of Finance given in accordance with a recommendation by ANZ Investment Services (New Zealand) Limited, gives the following order.

#### Order

**1. Title**—This order is the Bonus Bonds (Prize Structure) Order 2007.

**2. Commencement**—This order comes into force on 1 May 2007.

**3. Interpretation**—In this order, unless the context otherwise requires:

**deed of trust** means the deed of trust describing the unit trust between the Bank and Trustees Executors dated 17 September 1990 (as amended) and approved for the purposes of the Finance Act (No 2) 1990 by the Minister of Finance by notice published in the *New Zealand Gazette*, 20 September 1990, No. 164, page 3431.

**the Bank** means ANZ Investment Services (New Zealand) Limited, being a company related to Post Office Bank Limited, and approved by the Minister of Finance by notice published in the *New Zealand Gazette*, 20 September 1990, No. 164, page 3431.

**Trustees Executors** means Trustees Executors Limited, previously called The Trustees, Executors, and Agency Company of New Zealand (Limited).

**4. Changes to prize structure authorised**—(1) Clause 1.01 of the deed of trust is authorised to be amended by inserting the following definition in its appropriate alphabetical order:

“**Bonus Bonds Prize** means a prize described or referred to in Schedule 3 of this Deed (as amended from time to time in accordance with the Finance Act (No 2) 1990)”.

(2) Clause 1.01 of the deed of trust is authorised to be amended by inserting the following definition in its appropriate alphabetical order:

“**Eligibility Period** means, in respect of a Unit in the Bonus Bonds Portfolio and a particular Bonus Bonds Prize, the period of such length of time in respect of that Bonus Bonds

Prize as may be described or referred to in Schedule 3 of this Deed (as amended from time to time in accordance with the Finance Act (No 2) 1990), provided that—

- “(b) if no time period is described or referred to in Schedule 3 of this Deed (as amended from time to time in accordance with the Finance Act (No 2) 1990) in respect of a Unit in the Bonus Bonds Portfolio and a particular Bonus Bonds Prize, such period shall end on (but shall include) the last day of the Month immediately following the Month in which that Unit was deemed to be issued in accordance with clause 5.02(a) of this Deed”.

(3) Clause 1.01 of the deed of trust is authorised to be amended by revoking the definition of **Entitlement** and substituting the following definition:

“**Entitlement** means—

- “(a) in respect of a Unit in the Bonus Bonds Portfolio and a ballot completed by the Manager during any applicable Entitlement Period, entitlement to any part of the Distribution Amount attributable to that Unit as a result of that ballot; and
- “(b) in respect of a Unit in any other Portfolio but only during any applicable Entitlement Period, entitlement to any part of the Distribution Amount attributable to that Unit for any applicable period”.

(4) Clause 1.01 of the deed of trust is authorised to be amended by revoking the definition of **Entitlement Period** and substituting the following definition:

“**Entitlement Period** means—

- “(a) in respect of a Unit in the Bonus Bonds Portfolio and a particular Bonus Bonds Prize, the period commencing on the expiry of the Eligibility Period applicable to that Unit and that Bonus Bonds Prize and terminating on the day on which the Manager makes an appropriate entry on the Register recording the redemption and cancellation of that Unit in accordance with clause 7 of this Deed; and
- “(b) in respect of a Unit in any other Portfolio, the period determined by the Manager and specified in the current Prospectus”.

**5. Schedule 3**—Schedule 3 of the deed of trust is authorised to be amended by omitting the item under the heading Bonus Bonds prize structure and substituting the item set out in the Schedule of this order.

**6. Revocation**—The Bonus Bonds (Prize Structure) Order 1995 is revoked.

### Civil Aviation Act 1990

#### Direction to Require Screening Notice 2007

Pursuant to section 77A(1) of the Civil Aviation Act 1990, in order to enhance aviation security to enable New Zealand to be part of a concerted international response to a threat to aviation security, notice is given that I have directed the Aviation Security Service to perform the functions listed in the Schedule. This direction is consistent with the recommended security control guidelines for screening liquids, gels, and aerosols issued by the International Civil Aviation Organization. This notice comes into force on 31 March 2007.

#### Schedule

The Aviation Security Service must, at every international screening point, screen and, if necessary, undertake reasonable searches for liquids, aerosols, and gels, including (but not limited to)—

- water and other drinks, soups, syrups, jams, stews, sauces, and pastes (including toothpaste); and
- foods in sauces or containing a high liquid content; and
- creams, lotions, cosmetics, and oils; and
- gels (including hair and shower gels); and
- contents of pressurised containers (including shaving foam, other foam, and deodorants); and
- waxy substances (including hair wax); and
- mascara, lipstick, lip gloss, and lip balm; and
- any item of similar consistency at room temperature to the items specified in paragraphs (a) to (g).

For the purposes of this direction, **international screening point** means a passenger inspection and screening station that is used for screening and searching people and items that enter a sterile area that services international flights (including transit flights).
