“protection deposit” means a deposit, held at call, of tuition, boarding, accommodation or other fees by or on behalf of a student enrolled at a private training establishment within the meaning of Part 18 of the Education Act 1989;

“special deposit” means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

“trust deposit” means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Rates of Common Fund interest—**(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.

(3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.

(4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(5) Despite subparagraphs (1), (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on investment deposits, protection deposits or special deposits that is different from the rate specified in Schedules 1, 2, or 3 and the agreed rate then applies.

**4. Revocation of notice and transitional provisions—**(1) The Public Trust Common Fund Interest Rates Notice 18 January 2007 is revoked.

(2) The rates of interest specified in Schedules 1 and 2 to this notice do not apply to any period that ends with 31 January 2007 but otherwise operate as from 1 February 2007.

(2) Any term or expression that is defined in the Act and used, but not defined, in this notice has the same meaning as in the Act.

**Clause 3: Authorisation**—(1) JPMAL is authorised to carry on the business of dealing in futures contracts other than futures contracts made on or effected through a recognised exchange.

(2) The authorisation is subject to the conditions that:

- (a) JPMAL deals only on behalf of its wholesale clients, being any client that is:
  - (i) a person who controls at least \$10 million; or
  - (ii) a trustee of a trust or a funds manager, acting in that capacity, who has under that person's control, as trustee or funds manager, net assets of at least \$10 million; or
  - (iii) a person who is authorised to carry on the business of dealing in futures contracts under the Act; or
  - (iv) a person authorised in another jurisdiction by the competent authority of that jurisdiction to deal in futures contracts; or
  - (v) Her Majesty the Queen in right of New Zealand, a Crown entity named in the Crown Entities Act 2004, or a State enterprise named in the First or Second Schedule to the State-Owned Enterprises Act 1986 (each as amended from time to time); or
  - (vi) a person who is a statutory corporation or a registered bank; or
  - (vii) a person whose principal business is the investment of money or who, in the course of and for the purposes of their business, habitually invests money; or
  - (viii) a person who is a related body corporate of any of the persons mentioned in subparagraphs (i) to (vii) above; and
- (b) before dealing in any futures contract in respect of which the authorisation applies, JPMAL is satisfied on reasonable grounds that the wholesale client is contracting:
  - (i) as principal on its own account; or
  - (ii) on behalf of a related body corporate; or
  - (iii) as trustee of a trust or manager of a managed fund; and
- (c) the terms of every futures contract in respect of which the authorisation applies:

- (i) create obligations that cannot be transferred or terminated by either party to the futures contract without the consent of the other party; and
- (ii) require that any transfer of obligations under the futures contract can be made only to a person who meets the criteria described in paragraphs (a) and (b); and
- (d) JPMAL does not hold client money or client property in connection with dealing in futures contracts; and
- (e) JPMAL is licensed as an Australian Financial Services Licensee under the Corporations Act and holds an AFS Licence which authorises JPMAL to provide futures dealing and advisory services to wholesale clients; and
- (f) JPMAL notifies the Commission if JPMAL's AFS Licence is varied or revoked and notifies the Commission of any regulatory action taken by ASIC in relation to JPMAL's AFS Licence; and
- (g) JPMAL provides the Commission with a copy of JPMAL's annual financial statements no later than 3 months after the end of each financial year for JPMAL; and
- (h) JPMAL notifies the Commission of any material matter concerning JPMAL's authorisation as a futures dealer.

- (h) One member from the Grey District appointed after public nomination.
- (i) One member from the Westland District appointed after public nomination.
- (j) One member appointed in consultation with the New Zealand Council of Trade Unions.
- (k) One member appointed in consultation with the Canterbury Employers Chamber of Commerce.

Nominations for 3(g), (h), and (i) will be called for by public advertisement.

4. The term of office of members of the council, vacation of office, disclosure of members' interest and casual vacancies are covered in sections 173–176 of the Education Act 1989. Subject to section 173, the maximum term for any member, other than the chief executive officer, shall be three consecutive four-year terms.

5. The powers of Tai Poutini Polytechnic Council shall not be affected by vacancy in the membership thereof.
