Electricity Act 1992

Notice of Making of Electricity Governance Amendment Rules (No. 46) 2006 and Notice of Reasons for Decision

- 1. Pursuant to section 172I of the Electricity Act 1992 ("Act"), I notify the amendment of the Electricity Governance Rules 2003 ("Rules") under section 172H of the Act.
- 2. The empowering provisions for the Electricity Governance Regulations, in relation to which the amendments to the Rules are made, are sections 172D (1) (1) (a), 172D (1) (1) (b), 172D (1) (1) (d), 172D (1) (16) and 172D (1) (18) of the Act.
- 3. There has been the creation of a new Part J (Reconciliation) which has resulted in a substantial rewrite of section VI of Part G and the associated reconciliation-related schedules (in particular Schedules G7 and G8 of Part G) and significant, but less substantial amendments to Parts A, D, E, and H, as well as other sections of Part G. This is to ensure that the Rules reflect the recommendations for enhancing the reconciliation system, contained in the Electricity Commission Reconciliation Project Team (ECRPT) final report. The four key recommendations of the ECRPT report were the:
 - (a) elimination of incumbency;
 - (b) facilitation and treatment of embedded generation data processing;
 - (c) development of a compliance and audit regime; and
 - (d) grouping of grid exit points (GXPs) for reconciliation.
- 4. Pursuant to section 172z (4) of the Act, the reasons for my decision to amend the Rules are to:
 - (a) provide a coherent reconciliation process that clearly sets out the expectations to be placed on industry participants;
 - (b) improve the quality of data that goes into the reconciliation process;
 - (c) remove ambiguity about what actions the reconciliation rules actually require;
 - (d) clarify the processes that retailers must follow when a consumer switches retailers (switching); and
 - (e) set a platform for future enhancements, should they be required.
- 5. These Rules come into force on 1 May 2008.

Levy on Rural Land in the Otago Region

Pursuant to the Biosecurity (Bovine Tuberculosis-Otago Land Levy) Order 1998 made under the Biosecurity Act 1993, a levy is payable to the Animal Health Board (Inc.) by the occupiers of all rural landholdings 4 hectares or more in area in the Otago Region.

The purpose of the levy is to partially fund Tb vector control operations in Otago under the National Bovine Tuberculosis Pest Management Strategy.

For the 2006/2007 financial year, the single rate of levy payable is 0.0131% (\$13.10) per \$100,000.00 of the property land value recorded in the district valuation roll on 1 July 2006 (GST exclusive).

For the purpose of calculating the levy payable, no property shall be valued at more than \$5,000.00 per hectare.

Where the levy payable is less than \$10.00 excluding GST for the property, the occupier is exempt from payment of the levy and will not receive an invoice.

Land occupiers will be invoiced by the Animal Health Board for levies payable on or after 7 February 2007.

The due date for payment of levies is 31 March 2007.

Meat Board Act 2004

Amendment of Quota Allocation Mechanisms Following Review—European Union (EU) Sheepmeat and Goatmeat Tariff Rate Quota, EU High Quality Beef Tariff Rate Quota and United States (US) Beef and Veal Tariff Rate Quota

The New Zealand Meat Board has reviewed its existing quota allocation mechanisms under the Meat Board Act 2004 ("the Act"), being mechanisms for the EU Sheepmeat and Goatmeat Tariff Rate Quota (TRQ), US Beef and Veal TRQ (both dated August 2005) and EU High Quality Beef TRQ (dated February 2006).

Initial amendments resulting from the review were published in the *New Zealand Gazette*, 11 August 2005, No. 123, page 3207. The board has now agreed one final amendment, and has closed the review. The final amendment, made pursuant to section 27 of the Act, relates to the transition to a 6-year stand-down period for new entrants and is achieved by amending the meaning of "specified period" in the definition of New Entrant at Section 2 of each of the allocation mechanisms as follows:

(e) "specified period" in relation to applications for the 2006, 2007, and 2008 Quota Years circumstances that did not apply after 31 August 2005 means 3 years, and for applications for subsequent years circumstances that did apply after 31 August 2005 means 6 years.

The amended mechanisms will come into effect in relation to the Quota Years commencing **1 January 2007** for EU Sheepmeat and Goatmeat TRQ and US Beef and Veal TRQ, and **1 July 2007** for EU High Quality Beef TRQ. The amendment will not however have any impact on applications until 2009 at the earliest.

- For EU Sheepmeat and Goatmeat TRQ and US Beef and Veal TRQ:
 - Applications by New Entrants for Reserved Quota Allowance Allocations are due by 1 September in the year preceding each quota year.
 - Applications for General Quota Allowance Allocations are due by 15 of October in the year preceding each quota year.
- For EU High Quality Beef TRQ:
 - Applications by New Entrants for Reserved Quota Allowance Allocations are due by 1 of March preceding the commencement of each quota year.
 - Applications for General Quota Allowance Allocations are due by 15 of April preceding the commencement of each quota year.
- The EU Sheepmeat and Goatmeat TRQ applies to 227,854 tonnes carcass weight equivalent and the tariff rate for "in quota" imports is zero.
- The EU High Quality Beef TRQ applies to 1,300 tonnes product weight and the tariff rate for "in quota" imports is 20 per cent *ad valorem* duty.
- The US Beef and Veal TRQ applies to 213,402 tonnes product weight and the tariff rate for "in quota" imports is \$US0.044 per kilogram on most beef products.
