  - "special deposit" means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;
  - "trust deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:
    - (i) for persons not of full age or capacity; or

- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.
- (2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.
- **3. Rates of Common Fund interest**—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

### **Electricity Industry Reform Act 1998**

- (c) Any generation asset owned by the joint venture must not be connected to electricity lines owned or operated by Unison except to the extent that is necessary in order to connect the generation asset to the national transmission network.
- (d) This exemption is specific to the cross-involvements created through Unison's involvement in the proposed joint venture. It does not extend to any other interest, or existing or future crossinvolvement of Unison.

The Commission may vary or revoke the exemption in accordance with section 81 (5) of the EIR Act.

The temporary exemption takes effect from the date of publication of this notice in the *New Zealand Gazette*.
