### Notice of Decision of the Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand (Member Guilty of Misconduct in a Professional Capacity, Negligence or Incompetence in a Professional Capacity, and Breaching the Institute's Rules and Code of Ethics)

At a hearing of the Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand held in public on the 2nd day of March 2006, at which the member was in attendance by teleconference and was represented by counsel, **Richard Gregory Smithson**, of Rangiora, pleaded guilty to the following charges (1), (2), (3), (4) and (5) and admitted the following particulars (a), (b), (c), (d), (e), (f), (g), (h) and a second set of particulars (a), (b), (c) and (d).

#### Charges

THAT in terms of the Institute of Chartered Accountants of New Zealand Act 1996 and the Rules made thereunder, and in particular Rule 21.30, the member is guilty of:

- (1) misconduct in a professional capacity; and/or
- (2) negligence or incompetence in a professional capacity, and this has been of such a degree as to reflect on his fitness to practise as an accountant; and/or
- (3) breaching the Rules or the Code of Ethics (particularly Rule 21.2, Code of Ethics Rules 10 and 11, PS-2); and/or
- (4) failing to respond promptly to communications from the institute; and/or
- (5) failing to pay a sum due to the institute by the date specified for payment.

#### Particulars

IN THAT being a member of the Institute of Chartered Accountants of New Zealand and in relation to a complaint, the member:

- (a) invested funds of organisation A into the company Scarba Fifty One Limited ("SFO Limited") without gaining approval at a general meeting, as required by the rules of the organisation;
- (b) invested funds of organisation A into SFO Limited without the prior written authority of the organisation, in breach of Professional Standard No. 2 "Client Monies and Members' Trust Accounts" ("PS-2") (paragraph 41);
- (c) invested funds of organisation A into SFO Limited, a company of which he was the sole shareholder and director, in breach of PS-2 (paragraph 43);
- (d) failed to repay to organisation A all the funds invested in SFO Limited, when requested to do so;
- (e) failed to pay to organisation A, within a reasonable period of time, the interest that is due to them from their investment in SFO Limited;

- (f) did not fully disclose organisation A's investment in SFO Limited in the 2002 financial statements of organisation A;
- (g) did not fully disclose organisation A's investment in SFO Limited in the 2002 financial statements of SFO Limited;
- (h) failed to respond to a complaint about this conduct within the period specified in Rule 21.2 (b).

And, in his role as a chartered accountant in public practice, the member:

- (a) has breached PS-2, in that funds that are direct credited into his client trust account do not have deposit details recorded (paragraph 24);
- (b) has breached PS-2, in that numerous clients in his trust account had and/or continue to have overdrawn balances (paragraph 28);
- (c) has breached PS-2, in that he is unable to provide client authority for the offset of fees charged against Inland Revenue Department refunds (paragraph 30);
- (d) failed to pay his 2006 institute membership fees by the due date of 31 July 2005.

#### Reasons

The tribunal need to have regard to the protection of the public and the institute. The offences were over a long period of time and go beyond mere incompetence or carelessness and relate to serious mishandling of other people's money, and this is not acceptable behaviour for a member of the institute.

#### Orders of the Tribunal

- (a) Pursuant to Rule 21.31 (a) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that the name of **Richard Gregory Smithson** be removed from the institute's Register of members.
- (b) Pursuant to Rule 21.33 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Richard Gregory Smithson** pay to the institute the sum of \$9,800.00 (inclusive of G.S.T.) in respect of the costs and expenses of the hearing before the disciplinary tribunal and the investigation by the professional conduct committee.

In accordance with Rule 21.35 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal directed that the decision of the tribunal be published in the *Chartered Accountants Journal*, the *New Zealand Gazette* and the *Christchurch Press* with mention of the member's name and locality.

#### Right of Appeal

At a hearing of the Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand held in public on the 1st day of March 2006, at which the member was not in attendance and was not represented by counsel, **Robert Barrie Johnson**, of Wellington, pleaded guilty to the following charge and admitted the following particular.

### Charge

THAT in terms of the Institute of Chartered Accountants of New Zealand Act 1996 and the Rules made thereunder, and in particular Rule 21.30:

The member was adjudicated bankrupt.

### Particular

IN THAT on or about the 12th day of August 2005, the member was adjudicated bankrupt in the Wellington High Court.

### Reason

The member has pleaded guilty to the charge and admitted the particular, and it was noted that there is no evidence of misconduct. The bankruptcy of a member is not consistent with the values and profile of the institute and it does reflect badly on the profession. The tribunal ordered that the member be suspended from membership of the institute until he is discharged from bankruptcy and that the decision of the tribunal be published in the *Chartered Accountants Journal*, the *New Zealand Gazette* and the *Dominion Post*.

### Orders of the Tribunal

Pursuant to Rule 21.31 (b) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Robert Barrie Johnson** be suspended from membership for the duration of his bankruptcy.

In accordance with Rule 21.35 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal directed that the decision of the tribunal be published in the *Chartered Accountants Journal*, the *New Zealand Gazette* and the *Dominion Post* with mention of the member's name and locality.

### Right of Appeal

Pursuant to Rule 21.41 of the Rules of the Institute of Chartered Accountants of New Zealand which were in force at the time of the original notice of complaint, the member may, not later than 14 days after the notification of this tribunal to the member of the exercise of its powers, appeal in writing to the appeals council of the institute against the decision.

## Notice of Decision of the Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand (Member Guilty of Misconduct in a Professional Capacity, Conduct Unbecoming an Accountant, and Breaching the Institute's Rules and Code of Ethics)

At a hearing of the Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand held in public on the 1st day of March 2006, at which the member was in attendance and was represented by counsel, **Howard Karl Taylor**, of Auckland, pleaded guilty to the following charges (1), (2) and (4) and admitted the following particulars (a), (b), (c), (d), (e), (f), (i), (j), (k) and (l).

Charges (3), (5) and (6) and particulars (g), (h) and (m) were withdrawn.

### Charges

THAT in terms of the Institute of Chartered Accountants of New Zealand Act 1996 and the Rules made thereunder, and in particular Rule 21.30, the member is guilty of:

- (1) misconduct in a professional capacity; and/or
- (2) conduct unbecoming an accountant; and/or
- (3) (withdrawn);
- (4) breaching the rules and/or code of ethics of the institute (specifically Rules 18.2, 19.2, 21.4, PS-2, code of ethics' Rules 2, 9, 10, 11 and 14); and/or
- (5) (withdrawn);
- (6) (withdrawn).

### Particulars

IN THAT being a member of the Institute of Chartered Accountants and in relation to two complaints, the member:

- (a) deposited client monies into a bank account that had not been established as a trust account in accordance with paragraphs 7-13 of Professional Standard No. 2 "Client Monies and Members' Trust Accounts" ("PS-2");
- (b) deducted fees from clients' funds without written authorisation from the client in breach of paragraph 30 of PS-2;
- (c) failed to remit interest earned on client monies to clients, in breach of paragraphs 15 and 37 of PS-2;
- (d) held client monies for a period that was longer than reasonably necessary to allow the purpose for which they were received to be discharged, in breach of paragraph 38 of PS-2;
- (e) has breached and/or continues to be in breach of Rule 18.2 in that he is offering accounting services to the public without holding a certificate of public practice;
- (f) has breached and/or continues to be in breach of Rule 19.2(c) in that he is a director and shareholder

of H K Taylor & Associates Limited, which offers accounting services to the public without the consent of council;

- (g) (withdrawn);
- (h) (withdrawn);
- (i) provided misleading information to the professional conduct committee;
- (j) failed to file income tax returns and/or G.S.T. returns for his clients within the deadlines set by the Inland Revenue Department;
- (k) signed and filed nil G.S.T. returns with the Inland Revenue Department for company A, when there were income and expense transactions;
- (l) filed an incorrect income tax return with the Inland Revenue Department for company A, without the knowledge of the client;
- (m) (withdrawn).

#### Reasons

The member, in pleading guilty to the charges and particulars, accepted that the decision of the tribunal should be removal from membership with full costs and full publicity.

It was the unanimous decision of the tribunal that the member be removed from membership of the institute, that he pay full costs of \$17,920.98 and that the decision of the tribunal be published in the *Chartered Accountants Journal*, the *New Zealand Gazette* and the *New Zealand Herald*.

#### Orders of the Tribunal

- (a) Pursuant to Rule 21.31 (a) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that the name of **Howard Karl Taylor** be removed from the institute's Register of members.

- (b) Pursuant to Rule 21.33 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Howard Karl Taylor** pay to the institute the sum of \$17,920.98 (inclusive of G.S.T.) in respect of the costs and expenses of the hearing before the disciplinary tribunal and the investigation by the professional conduct committee.

In accordance with Rule 21.35 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal directed that the decision of the tribunal be published in the *Chartered Accountants Journal*, the *New Zealand Gazette* and the *New Zealand Herald* with mention of the member's name and locality.

#### Right of Appeal

Pursuant to Rule 21.41 of the Rules of the Institute of Chartered Accountants of New Zealand which were in force at the time of the original notice of complaint, the member may, not later than 14 days after the notification of this tribunal to the member of the exercise of its powers, appeal in writing to the appeals council of the institute against the decision.

No decision other than the direction as to publicity shall take effect while the member remains entitled to appeal or while any such appeal by the member awaits determination by the appeals council.
