## Social Security Act 1964

### Maximum Contribution Applying in Each Territorial Local Authority Region From 22 March 2006

Under section 152 of the Social Security Act 1964, the Director-General of Health is required to notify the maximum contribution that applies in each region.

The maximum contribution is the maximum weekly amount (inclusive of G.S.T.) that a resident assessed as requiring long-term residential care is required to pay for contracted care services provided to them in the region in which their rest home or continuing care hospital is located.

Contracted care services are services provided to needs assessed people in a rest home or continuing care hospital that has a contract with a District Health Board ("DHB"). The services are those provided and paid for in accordance with the agreement between the DHB and the residential care provider.

The agreement covers:

- residents who are eligible for the residential care subsidy (as determined through a financial means assessment under section 141 of the Act); and
- needs assessed persons who are entitled to have funding paid on their behalf (under section 140) to cover the difference between the maximum contribution and the cost of contracted care services provided to them.

The maximum contribution is the same for all residents regardless of the type of contracted care services they receive.

The maximum contribution set by this *New Zealand Gazette* notice applies from 22 March 2006 and replaces the previous maximum contribution notice published in the *New Zealand Gazette*, 23 June 2005, No 94, page 2253.

It is equivalent to the most recent, nationally agreed rest home contract price applying to residential care facilities in each territorial local authority region.

The maximum contribution is set at \$636.00 per week (G.S.T. inclusive) for any region where the rest home contract price is lower than \$636.00.

The maximum contribution will change only when a new maximum contribution is gazetted.

New maximum contributions will reflect changes to rest home contract prices that usually result from the annual review of the residential care contract between DHBs and residential care providers.

This notice of the grant of an exemption is issued by the Electricity Commission ("Commission"), continued under subpart 1 of Part 15 of the Electricity Act 1992, pursuant to the Electricity Governance Regulations 2003 ("Regulations") in favour of the unincorporated joint venture between Todd Energy Limited and Whareroa Co-generation Limited ("the Whareroa Joint Venture").

Pursuant to Regulation 194 (1), the Commission may, in its discretion and upon the terms and conditions (if any) that it thinks fit, exempt any participant, or class of participants, from compliance with all or any of the Electricity Governance Rules ("Rules").

##### Notice of the Grant of an Exemption ("notice")

Regulation 194 (2) requires that the exemption and the Commission's reasons for granting it are notified in the *New Zealand Gazette* as soon as practicable after being granted.

The Commission hereby notifies it has granted an exemption to the Whareroa Joint Venture from the requirement to comply with Rule 4.11 of Section III of Part G of the Rules.

##### Terms and Conditions of the Grant of the Exemption

In respect of the exemption contained within this notice, the Commission imposes the following terms and conditions:

1. The exemption shall expire on 31 March 2007.
2. The exemption relates to generation at HWA1102 only.
3. Generation at HWA1102 stays within +/- 5MW of any previous dispatch instruction issued by the system operator.
4. Any deviation from the dispatch quantity of greater than +/- 1MW must not continue for longer than one trading period without a revised offer.
5. The Whareroa Joint Venture must comply with dispatch instructions where the system operator has issued a formal notice as defined in Part A of the Rules.

##### Commission's Reasons for the Grant of the Exemption

The reasons for the grant of the exemption are as follows:

- (a) Most of the energy produced by the Whareroa Joint Venture's generation is used on-site and the on-site processes require the operation of the co-generation plant in conjunction with these processes. The Whareroa Joint Venture is therefore unable to comply with Rule 4.11 of Section III of Part G, which requires it to comply with all dispatch

instructions properly given by the system operator (subject to certain exceptions).

- (b) The reasons for requesting this exemption are similar to those given by Carter Holt Harvey (CHH) and Alinta ENZ Limited (Alinta) for the Kinleith and Glenbrook co-generation plants respectively. Exemptions were granted to CHH and Alinta and it would be appropriate to grant a similar exemption to the Whareroa Joint Venture for similar circumstances.
- (c) The conditions will give the system operator confidence in its ability to meet its principle performance obligations when unplanned increases in generation occur.
- (d) Granting the exemption will allow time for the Commission to complete its investigation into rule changes or other mitigation measures which appropriately reflect the operation of the co-generation plant.
- (e) Granting the exemption, while considering whether a rule change is required, is appropriate at this time.

##### Date Upon Which the Exemption Becomes Effective

Pursuant to Regulation 195, the date upon which the exemption contained in this notice takes effect is 16 March 2006.

### Requirements and Exemptions for Profiles for 2007-09 for Tertiary Education Organisations

Under sections 159 (1), 159X (1) and 159Y (3) (b) of the Education Act 1989, the Tertiary Education Commission (TEC) gives the following notice.

#### Notice

**1. Title and commencement**—This notice may be cited as the Education (Profiles 2007-09 for Tertiary Education Organisations) Notice 2006.

(2) This notice applies from the date of its publication.

**2. Introduction**—To access funding from the TEC for the 2007 year, all tertiary education organisations (TEOs), other than those exempted via this notice, are required to have an approved Profile, as described in section 159W of the Education Act 1989, in place by 15 December 2006 that covers the period 2007-09. This Profile will be referred to as “Profile 2007-09”.

Profiles are multi-purpose documents. They first and foremost “profile” each TEO. That is, a Profile is a TEO’s document that outlines for its students and its other key stakeholders how it will give effect to its Charter and what its contribution in terms of the tertiary education strategy (TES) and statement of tertiary education priorities (STEP) will be.

Second, Profiles, during the process of negotiation and agreement with the TEC, provide a means of identifying areas of duplication and gaps in delivery and once completed, inform decisions on the allocation of public funding.

Overall, Profiles serve the following purposes. They:

- demonstrate how an organisation will give effect to its Charter;
- provide the basis for monitoring organisational performance, accountability for the use of public funds and meeting other statutory requirements;
- contribute to a system-wide map of tertiary provision which can inform TEC in its role of giving effect to the TES;
- encourage relevance of educational provision to stakeholders’ needs;
- encourage greater co-operation and collaboration; and
- provide information on existing and planned programmes and activities as a basis for allocating public funding.

### Content, Criteria, Timeline and Process for Profiles 2007-09 for Tertiary Education Organisations

The content and criteria for Profile 2007-09 are based on the content requirements developed by the Charter and Profiles Working Party and endorsed by the Government.

Specific content and assessment criteria, and the timetable for Profile submission, apply for:

- universities;
- polytechnics;
- wananga;
- colleges of education;
- industry training organisations;
- private training establishments;
- rural education activities programmes (REAPs), other tertiary education providers (OTEPs) and community groups; and
- schools that provide tertiary education or tertiary education-related services.

The content and assessment criteria, process and submission date requirements for Profiles 2007-09 for each of the above TEOs are available on TEC’s web site at:

  - not seeking student component funding in 2007.
