The Regulations impose levies on generators, purchasers, and distributors for the costs of the Commission performing its functions, duties, and powers under the Electricity Act 1992 from 1 July 2004.

The Regulations provide that each generator, purchaser, or distributor is liable to pay a levy to the Commission.

The Commission collects the levy on behalf of the Crown.

Regulation 7 specifies the Commission must calculate the annual levy rates using estimated Commission costs, estimated quantities of electricity generated, purchased or conveyed, and an estimated number of consumer connections.

Regulations 11, 12, and 13 set out how the levy is to be reconciled after the end of a financial year on the basis of the Commission's actual costs, actual quantities of electricity generated, purchased or conveyed, and the actual number of consumer connections.
