Dumping and Countervailing Duties Act 1988

Final Determination and Imposition of Anti-Dumping Duty: Galvanised Wire from Malaysia Amendment No. 1 (Amendment of Amount of Anti-Dumping Duty)

Pursuant to section 14 (6) of the Dumping and Countervailing Duties Act 1988 ("the Act"), the Minister of Commerce, having carried out a reassessment of anti-dumping duty in respect of imports into New Zealand of galvanised wire from Malaysia and having determined a new amount of anti-dumping duty applicable to those goods, gives the following notice.

Title and commencement—(1) This notice may be cited as the "Duty Reassessment: Galvanised Wire from Malaysia", and shall be read together with the notice entitled "Final Determination of Dumping Investigation: Galvanised Wire from Malaysia" dated the 29th day of April 2004 and published in the *New Zealand Gazette*, 6 May 2004, No. 49, page 1236 (hereinafter referred to as the principal notice).

(2) Pursuant to section 14 (6) of the Act, the reassessed anti-dumping duty applicable to galvanised wire, set out in the Second Schedule to this notice, shall apply to imports of the goods specified in the First Schedule to this notice with effect from the day after the date of this notice. In accordance with section 14 (10) of the Act, I require the Collector of Customs to refund the difference between the duty paid and any lower duty specified in the Second Schedule of this notice, with effect from 10 March 2005, being the date of the initiation of the reassessment.

1. Title, commencement and expiry—(1) This notice is the Authorised Futures Dealers Notice (No. 3) 2005.

(2) This notice comes into force on the day after the date of its publication in the *New Zealand Gazette*.

(3) This notice expires on the close of 30 November 2008.

2. Interpretation—(1) In this notice unless the context otherwise requires:

“Act” means the Securities Markets Act 1988.

“agreed upon procedures engagement terms” means a written agreement, in terms of the Explanatory Foreword to Reporting Engagement Standards and Guidelines issued by the Institute of Chartered Accountants of New Zealand, between the compliance reporter and the company to perform specific procedures with respect to the company’s compliance with rules contained in the company’s compliance manual.

“compliance reporter” means a qualified auditor who has entered into agreed upon procedures engagement terms with the company.

“qualified auditor” has the same meaning as in section 2C of the Securities Act 1978.

“recognised exchange” means an authorised futures exchange or any exchange in a country other than New Zealand which is authorised by the laws of that country to operate as a futures exchange.

“Regulations” means the Futures Industry (Client Funds) Regulations 1990.

“the company” means KVB Kunlun New Zealand Limited.

(2) Any term or expression that is defined in the Act or the Regulations and used, but not defined, in this notice has the same meaning as in the Act or the Regulations.

3. Authorisation—(1) The company is authorised to carry on the business of dealing in futures contracts generally.

(2) The authorisation is subject to the conditions that:

- (a) the company does not carry on the business of dealing in futures contracts on behalf of any person other than a person who has entered into a written client services agreement with the company, and then only in accordance with the terms of that agreement.
- (b) before the company carries on the business of dealing in futures contracts on behalf of any person, the company has provided that person with copies of the following:
 - (i) A document that clearly describes, for the prudent but non-expert investor, the risks associated with trading in futures contracts, including any specific risk factors that apply to trading in any of the particular contracts or classes of contracts dealt with by the company;
 - (ii) one or more documents that clearly describe, for the prudent but non-expert investor, the class or classes of futures contracts in which the company intends to deal on behalf of that person; and
 - (iii) an investment broker disclosure document including the information listed in section 3 of the Investment Advisers (Disclosure) Act 1996.
- (c) no employee, director, or agent of the company may give investment advice to any client unless that director, employee or agent has first provided investment adviser disclosure to that client in terms of the Investment Advisers (Disclosure) Act 1996, including the request disclosure under section 4 of the Act.
- (d) any company document that states the company has been authorised by the Securities Commission to carry on the business of dealing in futures contracts includes a statement to the effect that:
 - (i) the Securities Commission’s role in authorising futures dealers is limited and does not imply approval or endorsement of the business, trading or solvency of the company; and
 - (ii) the Securities Commission has not approved the client services agreement or any disclosure documents of the company.
- (e) the company maintains proper records:
 - (i) to record dealings in respect of futures contracts with or on behalf of the client;
 - (ii) to record client money, funds and property held or received in connection with dealings in futures contracts; and

- (iii) which are audited or reviewed, and reported on, in accordance with the Regulations and the Financial Reporting Act 1993.
- (f) the company has current agreed upon procedures engagement terms.
- (g) the company has appointed a compliance reporter.
- (h) copies of the current agreed upon procedures engagement terms, the company's compliance manual and any amendments to these documents have been deposited with the Securities Commission.
- (i) the company's financial statements are prepared and registered on the basis that the company is an issuer in terms of the Financial Reporting Act 1993 and are audited at least once a year by a qualified auditor under the Financial Reporting Act 1993.
- (j) the agreed upon procedures engagement terms provide for (without limitation):
 - (i) the client money, funds and property records in respect of futures contracts to be reviewed and reported on by the compliance reporter at least once a year;
 - (ii) the review of, and reporting on, the dealing practices and systems of the company against the practices and procedures set out in the company's compliance manual by the compliance reporter (including on-site inspections of the company's records and procedures), such review and reporting to be undertaken at least once in every six months;
 - (iii) a copy of the compliance reporter's reports to be sent to the Securities Commission by the compliance reporter;
 - (iv) the company to provide the compliance reporter with copies of its annual report and monthly financial statements including a statement of financial position, a statement of financial performance, a statement of cash receipts and payments that includes receipts and payments of client monies, funds and property for the month, and a statement of its position with regard to client funds;
 - (v) the compliance reporter to give notice to the Securities Commission before or immediately

upon it resigning or retiring from its position as compliance reporter.

- (k) the company sends a copy of its audited financial statements to the Securities Commission not more than three months after the end of each financial year.
- (l) the company maintains adequate professional indemnity insurance for its business at all times.
- (m) the company immediately notifies the Securities Commission in writing of any of the following events:
 - (i) The insolvency of the company or the bankruptcy of any of its directors.
 - (ii) If the company, or any of its directors, is convicted of an indictable offence.
 - (iii) Where a receiver, provisional liquidator, liquidator or a similar officer is appointed, or any resolution is passed or order made for the winding up or dissolution of the company.
 - (iv) Any regulatory action taken against the company, or any of its directors or senior management, whether in New Zealand or elsewhere.

4. (1) Unless the contrary intention appears, the definitions in Chapter 3 of this Code apply for the purposes of this Standard.

Division 2 – Reserved**Division 3 – Production of ready-to-eat meat**

3 Interpretation

In this Division –

control means a measure that prevents, eliminates or reduces to an acceptable level, a food safety hazard.

HACCP plan means the –

- (a) Codex HACCP plan, Annex to CAC/RCPI 1969, Revision 4 (2003); or
- (b) HACCP plan outlined in Australian Standard AS-4696-2002.

handling means slicing, shaving or dicing, where it is followed by the packaging of the product in a modified atmosphere package.

producer of ready-to-eat meat means a food business that engages in the –

- (a) making, manufacturing, producing, extracting, processing, preparing, treating, preserving, packing, cooking, thawing or handling of ready-to-eat meat; or
- (b) handling of ready-to-eat meat for retail sale.

ready-to-eat meat means meat products intended to be consumed without further heating or cooking, and includes –

- (a) cooked or uncooked fermented meat; and
- (b) pâté; and
- (c) dried meat; and
- (d) slow cured meat; and
- (e) luncheon meat; and
- (f) cooked muscle meat including ham and roast beef; and
- (g) other ready-to-eat meat that is susceptible to the growth of pathogens or the production of toxins.

4 Requirements on producers of ready-to-eat meat

A producer of ready-to-eat meat must implement a food safety management system that identifies, evaluates and controls hazards, and meets the requirements in Table 1 or Table 2 to this clause.

Table 1 to clause 4

Document all stages of production
Identify all food safety hazards and controls through the use of a HACCP plan
Document compliance with Standard 3.2.2 of this Code
Document the management system set out in clauses 3.3 to 3.10 of the Australian Standard AS4696-2002

Table 2 to clause 4

Comply with a food safety management system recognised by the relevant authority
--

Editorial note:

'Hazard' is defined in Standard 3.1.1 as a biological, chemical or physical agent in, or condition of, food that has the potential to cause an adverse health effect in humans.

'Relevant authority' is defined in Standard 1.1.1.

Examples of a food safety management system that a relevant authority may recognise are the Commonwealth Export Control (Meat and Meat Products) Orders 2005 or the Australian Standard AS4696-2002.

5 Additional requirements for uncooked comminuted fermented meat

(1) In this clause –

audit means a review or examination of any, or all requirements of a food safety program which has been conducted by a person approved as being competent in food safety matters relating to UCFM.

batter mix means all the ingredients in the UCFM recipe that have been combined prior to filling a casing.

starter culture means a preparation of micro-organisms prepared for the purpose of fermenting meat which –

- (a) successfully competes for the nutrients in the meat medium; and
- (b) produces microbial inhibitors; and
- (c) is microbiologically safe; and
- (d) produces a controlled reduction of the pH of the meat mix.

UCFM means a comminuted fermented meat which has not had its core temperature maintained at 65°C for at least 10 minutes or an equivalent combination of time and higher temperature during production. To avoid doubt, a UCFM includes comminuted fermented meat which has been heat treated.

validation means obtaining evidence to confirm that the food safety management system is complete and effective and will deliver the expected food safety outcomes.

verification means the use of methods, procedures and tests in addition to monitoring to determine compliance with the food safety management system.

(2) Unless expressly provided elsewhere in this Code, a UCFM must not be sold unless it is produced in accordance with this clause.

(3) For the purposes of subclause 5(2), a UCFM may be sold where it is produced using an alternative technology or method specified elsewhere in this Code, provided that the equivalent food safety outcome in this clause is achieved.

(4) A UCFM must be produced in accordance with a food safety management system under clause 4 which –

- (a) has been verified and audited to ensure the number of *Escherichia coli* organisms in the final UCFM comply with the microbiological limits in Standard 1.6.1 in this Code; and
- (b) demonstrates that the production process handles the variations of *Escherichia coli* contamination in the ingoing raw meat ingredients.

(5) As part of the validation or verification requirements of the food safety management system, the number of *Escherichia coli* organisms must be recorded for the –

- (a) raw meat ingredients used to make a UCFM; and
- (b) product after fermentation and any subsequent process.

(6) During UCFM production, the following matters must be monitored and recorded at suitable frequencies –

- (a) the pH of a fermenting UCFM; and
- (b) the temperature and time of fermentation of UCFM; and
- (c) the temperature and time of maturation/drying of UCFM; and
- (d) the temperature and time of smoking of UCFM; and
- (e) the weight loss or water activity.

(7) The measurements recorded under subclauses (5) and (6) must be kept for 12 months after the use-by date or best-before date of a UCFM.

(8) The fermentation of a UCFM must be initiated through the use of a starter culture.

(9) A previously fermented or fermenting meat must not be used as –

- (a) a starter culture; or
- (b) an ingredient in a UCFM.

(10) Meat and batter mix used in the preparation of a UCFM must, if stored by the manufacturer, be stored at 5°C or below prior to fermentation.

(11) The pH of a fermenting UCFM must be measured in accordance with Method 1 in the Schedule.

Editorial note:

UCFM food businesses should note the skills and knowledge requirements in clause 3 of Standard 3.2.2.

Editorial note for New Zealand:

For New Zealand the processing of UCFM is regulated under the *Food Act 1981*.

SCHEDULE**Methods of Analysis**

1 Meat Determination of pH.

Mince a representative portion of the sample of the UCFM and place that portion in a stoppered bottle with twice its weight of water. Shake at five-minute intervals for 30 minutes and determine the pH value of the liquid electrometrically at 20°C.

Alternatively, the pH can be determined through the use of calibrated, direct-contact pH probes or meters.

- Herbage and amenity seed, 0.8% of assessed value.
- Specialist vegetable seeds (such as hybrid brassicas, carrot, onion, celery, beet), 0.8% of an assessed value in relation to value and seed.
- Maize, 0.4%.
- All other small grain and seeds, 0.8%.

Qualifications Prescribed for Registration in a Scope of Practice

4. Educational Psychologist

Pursuant to section 12 of the Act, the following qualifications have been prescribed for registration as a psychologist in the educational scope of practice:

A minimum of a Masters degree in psychology³ from an accredited educational organisation and an accredited Postgraduate Diploma in Educational Psychology, or equivalent qualification. Eligibility for an educational scope of practice shall require a board approved practicum or internship involving 1500 hours of supervised practice.
