Before a body is eligible to have a charter considered for approval by the Minister or to be exempted from the requirement to have a charter, the body must first be identified by the Minister as an organisation for the purposes of Part 13A of the Education Act 1989, under section 159B of the Education Act 1989.

For the purposes of Part 13A of the Education Act 1989, the Associate Minister of Education (Tertiary Education)

identifies the following individual bodies that provide tertiary education-related services as organisations within the definition of section 159B (1) (c) of the Education Act 1989.

Identification of these bodies expires on 31 December 2005:

Auckland Regional Migrant Settlement Services Centre.  
New Zealand Council of Trade Unions.  
Youth Skills New Zealand.

For the purposes of Part 13A of the Education Act 1989, the Associate Minister of Education (Tertiary Education) identifies the following type of body that provides tertiary education-related services as an organisation within the definition of section 159B (1) (c) of the Education Act 1989 for so long as they receive workplace literacy funding from the TEC:

Employers that only receive workplace literacy funding from the TEC.
