### **Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand—Notice of Decision of the Disciplinary Tribunal (Member Guilty of Misconduct in a Professional Capacity and/or Conduct Unbecoming an Accountant and/or Breaching the Rules of the Institute of Chartered Accountants of New Zealand and/or Failing to Comply With an Order Made by the Professional Conduct Committee)**

At a hearing of the Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand held on the 5th day of April 2005, at which the member was in attendance without counsel, it was recorded that **Henry Esau Ropati**, of Auckland, pleaded guilty to the following charges (2) and (3) and admitted particulars (e) and (f).

Charge (1) was withdrawn by the prosecution and the tribunal found the member guilty of charge (4) and found particulars (a), (b), (c), (d) and (g) to be proven.

#### **Charges**

THAT in terms of the Institute of Chartered Accountants of New Zealand Act 1996 and the rules made thereunder, and in particular Rule 21.30, the member is guilty of:

- (1) (charge withdrawn);
- (2) conduct unbecoming of an accountant; and/or;
- (3) breaching the rules of the institute (Rule 21.3 (d)) and/or the institute's code of ethics; and/or
- (4) failing to comply with an order made by the professional conduct committee.

#### **Particulars**

IN THAT in his role as a chartered accountant while working for a firm of chartered accountants, the member:

- (a) used his employer's time and resources to service clients that were not his employer's clients;
- (b) promoted his professional services to his ex-employer's clients by making comparisons with his ex-employer's practice that were not based on verifiable fact;
- (c) attempted to acquire and/or acquired intellectual property that belonged to his ex-employer's practice;
- (d) improperly used his ex-employer's firm's intellectual property;
- (e) retained his listing as a tax agent with Inland Revenue while he was employed by the firm of chartered accountants in breach of his obligations to that firm;
- (f) offered and/or continued to offer accounting services to the public without holding a certificate of public practice;
- (g) failed to appear before the professional conduct committee at his final determination on two occasions despite a requirement to attend and despite the professional conduct committee

rescheduling his final determination to another date and to a location in Auckland.

#### *Orders of the Tribunal*

- (a) Pursuant to Rule 21.31 (g) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Henry Esau Ropati** engage a mentor at his own expense.
- (b) Pursuant to Rule 21.31 (k) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Henry Esau Ropati** be censured.
- (c) Pursuant to Rule 21.33 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Henry Esau Ropati** pay to the institute the sum of \$4,000.00 (inclusive of G.S.T.) in respect of the costs and expenses of the hearing before the disciplinary tribunal and the investigation by the professional conduct committee.

In accordance with Rule 21.35 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal directed that the decision be published in the *Chartered Accountants Journal*, the *New Zealand Gazette* and the *New Zealand Herald* with mention of the member's name and locality.

#### **Reasons**

The tribunal found that the member had used his employer's resources to service clients that were not his employer's clients and that the member acknowledged that he had promoted his professional services to his ex-employer's clients, and that it was a mistake for him to make such contact.

The member admitted that he had retained his listing as a tax agent while he was employed by a firm of chartered accountants in breach of his obligations to that firm and he also admitted that he offered accounting services to the public without a certificate of public practice.

The member admitted that he failed to appear before the professional conduct committee at his final determination hearing on two occasions.

The tribunal urged the member to seek a certificate of public practice at the earliest possible time and to make alternative arrangements for his existing clients until he has attained a certificate of public practice.

#### *Right of Appeal*

Pursuant to Rule 21.41 of the Rules of the Institute of Chartered Accountants of New Zealand which were in force at the time of the original notice of complaint, the member may, not later than 14 days after the notification of this tribunal to the member of the exercise of its powers, appeal in writing to the appeals council of the institute against the decision.

THAT in terms of the Institute of Chartered Accountants of New Zealand Act 1996 and the Rules made thereunder, and in particular Rule 21.30, the member is guilty of:

- breaching the rules of the institute (Rule 21.2(b)); and/or
- failing to comply with an order made by the professional conduct committee.

**Particulars**

IN THAT in relation to a complaint to the professional conduct committee, the member has failed within a reasonable and proper time to reply to requests and/or requirements of the committee as contained in a letter dated the 18th day of November 2004 and/or the 2nd day of December 2004 and/or the 24th day of December 2004 and/or the 31st day of 31 January 2005 and/or email of the 7th day of February 2005.

*Orders of the Tribunal*

- (a) Pursuant to Rule 21.31(c) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Edward Wayne Dick** pay a monetary penalty of \$5,000.00.
- (b) Pursuant to Rule 21.31(f) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Edward Wayne Dick's** practice be the subject of regular reviews by the practice review board who shall report their findings to the professional conduct committee.
- (c) Pursuant to Rule 21.31(k) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Edward Wayne Dick** be censured.
- (d) Pursuant to Rule 21.33 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Edward Wayne Dick** pay to the institute the sum of \$2,836.00 (inclusive of G.S.T.) in respect of the costs and expenses of the hearing before the disciplinary tribunal and the investigation by the professional conduct committee.

In accordance with Rule 21.35 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal directed that the decision be published in the *Chartered Accountants Journal*, the *New Zealand Gazette* and the *New Zealand Herald* with mention of the member's name and locality.

The tribunal found that the member had pleaded guilty to the charges and particulars.

Non response to the institute in relation to any matter but in particular professional conduct matters is particularly serious.

In making their orders, the tribunal noted that when a person becomes a member of the institute, they agree to abide by the rules of the institute and comply with professional and ethical standards.

A lack of commitment on behalf of a member, or the treatment of contempt by that member for the resolution of complaints, significantly undermines the professional conduct and disciplinary processes and erodes the public confidence in the profession and the tribunal endorses these provisions.

The tribunal noted that **Edward Wayne Dick** had appeared before the tribunal in April 2004 on a similar non-response matter and noted that if the member should appear before the tribunal for a third time on a non-response matter then the tribunal would take the previous appearances into account when determining its decision.

At a hearing of the Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand held on the 5th day of April 2005, which the member did not attend and was not represented by counsel, the disciplinary tribunal found **Ian Nigel Clarke**, of Auckland, guilty of the following charges and particulars.

**Charges**

THAT in terms of the Institute of Chartered Accountants of New Zealand Act 1996 and the rules made thereunder, and in particular Rule 21.30:

- the member has been convicted of an offence punishable by imprisonment and the conviction tends to bring the profession into disrepute.

**Particulars**

IN THAT on or about the 30th day of November 2004, at the North Shore District Court the member was convicted of various charges of dishonesty, including forgery and drawing a document without authority, and was sentenced to a term of imprisonment of three years and three months.

*Orders of the Tribunal*

- (a) Pursuant to Rule 21.31(a) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that the name of **Ian Nigel Clarke** be removed from the Register of members of the institute.

- (b) Pursuant to Rule 21.31(d) of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that the Certificate of Public Practice held by **Ian Nigel Clarke** be cancelled.
- (c) Pursuant to Rule 21.33 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Ian Nigel Clarke** pay to the institute the sum of \$2,401.00 (inclusive of G.S.T.) in respect of the costs and expenses of the hearing before the disciplinary tribunal and the investigation by the professional conduct committee.

In accordance with Rule 21.35 of the Rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal directed that the decision be published in the *Chartered Accountants Journal*, the *New Zealand Gazette* and the *New Zealand Herald* with mention of the member's name and locality.

### Reasons

Where a member commits dishonest acts such as fraud, it tends to bring the institute and the profession into disrepute and of paramount importance is the protection of the public.

Where the fraud is of such a magnitude involving 444 fraud related charges amounting to a total sum of \$1,059,598.31, there is no option for the tribunal other than to order the removal of the member's name from the institute's Register.

### Right of Appeal

Pursuant to Rule 21.41 of the Rules of the Institute of Chartered Accountants of New Zealand which were in force at the time of the original notice of complaint, the member may, not later than 14 days after the notification of this tribunal to the member of the exercise of its powers, appeal in writing to the appeals council of the institute against the decision.

ORDER IN COUNCIL

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

#### Reference

(1) Her Excellency the Governor-General refers to the Court of Appeal the questions of:

- (a) P's convictions for sexual offences against complainant A, entered in the High Court at Auckland on 8 August 1997; and
- (b) P's sentence for sexual violation against complainant B, imposed in the High Court at Auckland on 10 February 1999.

(2) Her Excellency the Governor-General makes this reference:

- (a) under section 406 (a) of the Crimes Act 1961;
- (b) on the advice and with the consent of the Executive Council; and
- (c) in the light of the background, and for the reasons, stated in the Schedule.

#### Schedule

##### 1. Interpretation—In this Schedule:

“the applicant” means P.

##### Background

**2. Trial, sentence and appeal for offences against complainant A—**(1) On 8 August 1997, the applicant was convicted in the High Court of the following sexual offences against complainant A:

- (a) two counts of sexual violation by rape;
- (b) three counts of sexual violation by unlawful sexual connection; and
- (c) four counts of inducing a girl to do an indecent act.

(2) The applicant's convictions were based entirely on the credibility of complainant A.



(3) On 9 September 1997, the applicant was sentenced in the High Court to 11 years' imprisonment.

(4) On 18 February 1998, the Court of Appeal dismissed the applicant's appeal against conviction and sentence.

**3. Trial, sentence and appeal for offences against complainant B**—(1) On 22 July 1998, the applicant was convicted in the High Court of the following sexual offences against complainant B:

- (a) one count of sexual violation by rape; and
- (b) one count of sexual violation by unlawful sexual connection.

(2) On 10 February 1999, the applicant was sentenced in the High Court to preventive detention.

(3) The sentencing Judge was entitled to sentence the applicant to preventive detention or to an additional term of imprisonment. The Judge's decision to impose preventive detention was influenced by the convictions described in clause 2 (1).

(4) On 26 July 1999, the Court of Appeal dismissed the applicant's appeal against sentence.

**4. Application for exercise of prerogative of mercy**—(1) The applicant applied to the Governor-General on 10 October 2003 for the exercise of the mercy of the Crown in respect of the convictions described in clause 2 (1).

(2) The Governor-General sought the advice of the Minister of Justice on the application.

(3) The Minister of Justice appointed a Queen's Counsel to advise him on the application.

**5. Complainant A's retraction**—(1) Since the applicant's convictions on 8 August 1997, complainant A has stated that:

- (a) the applicant did not sexually abuse her; and
- (b) the evidence she gave at the trial that she had been abused by the applicant was false.

(2) Complainant A made these statements:

- (a) in a letter dated 12 August 2002 from complainant A to the applicant;
- (b) in an affidavit dated 9 September 2002 by complainant A; and
- (c) in interviews with the Queen's Counsel referred to in clause 4 (3) on 26 April 2004 and 30 July 2004.

#### Reasons

**6. Reasons**—(1) The reason for the reference in respect of the applicant's convictions entered on 8 August 1997 is that the information in clause 5 indicates that evidence is now available that:

- (a) was not available at the time of the applicant's trial and appeal; and
- (b) could lead the Court to conclude that a miscarriage of justice might have occurred.

(2) The reason for the reference in respect of the applicant's sentence of preventive detention imposed on 10 February 1999 is that, as described in clause 3 (3), the imposition of the sentence was influenced by the convictions entered on 8 August 1997. If the convictions are overturned, the Court may wish to reconsider the sentence of preventive detention.

##### Interconnection Pricing Review Draft Determination

On 13 April 2005, the Commerce Commission ("the Commission") released its draft determination, under section 49 of the Telecommunications Act 2001 ("the Act"), reviewing the price for interconnection between the network of Telecom New Zealand Limited and the network of TelstraClear Limited, which was set by the Commission's determination of 5 November 2002 (Decision 477).

Decision 477 set the initial price for the two designated services in Schedule 1 of the Act: Interconnection with Telecom's fixed PSTN and interconnection with a fixed PSTN other than Telecom's, at 1.13 cents per minute.

The parties to Decision 477, Telecom and TelstraClear, applied to the Commission, under section 42 of the Act, for the price set for interconnection with Telecom's fixed PSTN to be reviewed. Telecom also applied for the price set for interconnection with a fixed PSTN other than Telecom's to be reviewed.

The Commission has calculated the price of interconnection to be 1.00 cent per minute, using a forward-looking cost model described as TSLRIC or Total Service Long-run Incremental Cost.

The Commission has proposed a duration for the determination extending from 1 June 2002, the effective date of commencement of Decision 477, until the date of public release of the Commission's final determination.

The Commission is seeking submissions from interested parties on the draft determination.

All submissions must be received before 12.00 midday on 9 May 2005.
