 - (ii) a beneficiary in receipt of a benefit; or
 - (iii) an applicant for special assistance under a welfare programme approved under section

124 (1) (d) of the Act that applies section 74 of the Act to the programme; or

- (iv) a recipient of special assistance under a welfare programme of the kind referred to in subparagraph (iii); and

(b) who:

- (i) is ordinarily resident in New Zealand; and
- (ii) migrated to New Zealand with the intention that he or she would be joined by his or her spouse; and

(c) whose spouse (**person B**)—

- (i) is not ordinarily resident in New Zealand; and
- (ii) is in one of the following situations:

(A) overseas and unable indefinitely to reside with person A in New Zealand because of circumstances beyond his or her control (for example, person B is detained in a refugee camp); or

(B) unable reasonably to be located and unable to be legally declared dead.

(3) This direction does not apply where you are satisfied there are sufficient grounds to regard person A and person B as unmarried under section 63 (a) of the Act.

5. Exercise of discretion under section 74 (1) (a)—(1) In the exercise of your discretion under section 74 (1) (a) of the Act, you should take into account the circumstances referred to in clause 4 (2) (c) (ii), the financial needs of person A, his or her absence of choice in regard to the residence of person B, and any other matters you consider relevant to the circumstances.

(2) Without limiting your discretion under section 74 (1) (a) of the Act, you should generally consider that person A should receive the benefit or special assistance concerned at the rate for an unmarried person or, as the case requires, a sole parent.

6. Apportionment of benefit—Where, in accordance with clause 5 (2), you determine that the rate of benefit or special assistance should be paid at the rate for an unmarried person or, as the case requires, a sole parent, you should, under section 83 (2) of the Act, allocate the proportion of the benefit payable to person A and person B in the ratio of 100:0.

Explanatory Note

This note is not part of the direction, but is intended to indicate its general effect.

This direction provides that an ordinarily resident person whose overseas and not ordinarily resident spouse cannot reside with him or her in circumstances beyond his or her control, or who cannot be located, should generally receive a benefit or special assistance under a welfare programme at the appropriate unmarried or sole parent rate.

Amendment Act 2002, the Tertiary Education Commission (TEC) gives the following notice.

1. This notice may be cited as the Education (Profiles 2006-08 for Tertiary Education Organisations) Notice 2005.
2. This notice applies from the date of its publication.

Introduction

To access funding from the TEC for the 2006 year, all tertiary education organisations (TEO), other than those exempted via this notice, are required to have an approved profile, as described in section 159W of the Education Act 1989, in place by 15 December 2005 that covers the period 2006-2008.

This profile will be referred to as "Profile 2006-08".

Profiles are multi-purpose documents. They first and foremost "profile" each TEO. That is, a profile is a TEO's document that outlines for its students and its other key stakeholders how it will give effect to its charter and what its contribution in terms of the Tertiary Education Strategy (TES) and Statement of Tertiary Education Priorities (STEP) will be.

Second, profiles, during the process of negotiation and agreement with the TEC, provide a means of identifying areas of duplication and gaps in delivery and once completed, inform decisions on the allocation of public funding.

Overall, profiles serve the following purposes. They:

- demonstrate how an organisation will give effect to its charter;
- provide the basis for monitoring organisational performance, accountability for the use of public funds, and meeting other statutory requirements;
- contribute to a system-wide map of tertiary provision which can inform the TEC in its role of giving effect to the TES;
- encourage relevance of educational provision to stakeholders' needs;
- encourage greater co-operation and collaboration; and
- provide information on existing and planned programmes and activities as a basis for allocating public funding.

Content, Criteria, Timeline and Process for Profiles 2006-08 for Tertiary Education Organisations

The content and criteria for Profile 2006-08 are based on the content requirements developed by the Charter and Profiles Working Party and endorsed by the Government.

Specific content and assessment criteria, and the timetable for profile submission apply for:

- universities;
- polytechnics;
- wananga;
- colleges of education;
- industry training organisations;
- private training establishments;
- rural education activities programmes (REAPs), other tertiary education providers (OTEPs) and community groups; and
- schools which provide tertiary education or tertiary-education related services.

The content and assessment criteria, process and profile submission date requirements for Profiles 2006-08 for each of the above TEO groupings are available on the TEC's web site at www.tec.govt.nz from 10 March 2005.
