#### Customs (Inward Report) Rules 2004 (CR 1A/2004)

Pursuant to sections 288 (1) (a) and (12) of the Customs and Excise Act 1996, the Chief Executive hereby makes the rules prescribing the form and content of, and the particulars to be verified by declaration in, inward reports required to be delivered under section 26 (2) (a) of the Act and revokes the Customs (Inward Report) Rules 1996 and amendments made thereto.

**1. Title and application**—(1) These rules are the Customs (Inward Report) Rules 2004.

(2) These rules shall apply for the purposes of the making of inward reports required to be delivered, under section 26 (2) (a) of the Act, in respect of every craft that arrives in New Zealand from a point outside New Zealand.

(3) These rules revoke the Customs (Inward Report) Rules 1996 and the amendments made thereto.

**2. Commencement**—These rules come into force on 1 December 2004.

**3. Interpretation**—(1) In these rules, unless the context otherwise requires:

“The Act” means the Customs and Excise Act 1996.

“Commercial cargo” means all goods, except the personal effects of crew and passengers and stores for the craft, carried in or on any craft that arrives in New Zealand on a journey from a point outside New Zealand whether in the course of international trade in, or for the sale or supply of, those goods whether in New Zealand or elsewhere.

“Comptroller” means the Comptroller of Customs who is the Chief Executive of the New Zealand Customs Service.

“Prescribed form” or “form” means a form (including, if any, an electronic message format) prescribed by the Comptroller and set out in the Schedule to these rules; and a reference to a numbered form is a reference to the form so prescribed and numbered.

“The regulations” means the Customs and Excise Regulations 1996.

“Small craft” means any ship or boat not used for hire or reward (for example privately owned and operated yachts and launches).

(2) Unless otherwise defined in these rules, any terms used in these rules and which are defined in the Act shall have the meanings given to them in the Act.

**4. Form and content of inward reports**—Every inward report required, under section 26 (2) of the Act, must be:

- (a) in Form C1 for ships or boats (other than small craft) and must contain the particulars specified in that form, accompanied by any applicable supporting documents as the Comptroller may require;
- (b) in Form C1A for aircraft and must contain the particulars specified in that form, accompanied by any applicable supporting documents as the Comptroller may require;
- (c) in Form C1B for small craft and must contain the particulars specified in that form, accompanied by any applicable supporting documents as the Comptroller may require.

**5. Provide answers and make declaration**—The person making an inward report in any form specified in Rule 4 must provide the answers pertaining to all matters as are required in or by that form and where the form requires a declaration to be made, make such declaration.

**6. Notes**—Where a prescribed form contains any explanatory or other notes such notes do not form part of the prescription but are intended for the guidance of the person making the inward report.

**7. Revocation**—The following rules are hereby revoked:

- (a) Customs (Inward Report) Rules 1996\*
- (b) Customs (Inward Report) Amendment Rules 2001\*\*
- (c) Customs (Inward Report) Amendment Rules 2002\*\*\*

“Prescribed form” or “form” means a form (including, if any, an electronic message format) prescribed by the Comptroller and set out in the Schedule to these rules; and a reference to a numbered form is a reference to the form so prescribed and numbered.

“The regulations” means the Customs and Excise Regulations 1996.

“Small craft” means any ship or boat not used for hire or reward (for example privately owned and operated yachts and launches).

(2) Unless otherwise defined in these rules, any terms used in these rules and which are defined in the Act shall have the meanings given to them in the Act.

**4. Form of certificates of clearance**—Every certificate of clearance issued, under section 33 (1) of the Act, must be:

(a) in Form C3 for ships or boats (other than small craft);

(b) in Form C3A for aircraft;

(c) in Form C3B for small craft.

2. This notice shall come into force on the day after publication.
3. I hereby establish in Mātāuri Bay a full primary school called Te Kura Kaupapa Māori o Whangaroa and designate the school as a Kura Kaupapa Māori.
4. The school will operate in accordance with Te Aho Matua.
5. The special characteristics of Te Kura Kaupapa Māori o Whangaroa are that:
  - Te Kura Kaupapa Māori o Whangaroa commit totally to the guiding principles outlined in Te Aho Matua;
  - the paramount purpose of the kura is the needs of tamariki and their learning;
  - all tamariki enjoy an education which respects their Tino Rangatiratanga, dignity, rights and individuality;
  - the tamariki will be educated through Te Reo Māori total immersion as the medium of instruction;
  - our tamariki develop a sensitivity and respect for all others; and
  - this education challenges them to reach their full potential in the pursuit of excellence.

#### Constitution of the Board of Trustees

The Establishment Board of Trustees of Te Kura Kaupapa Māori o Whangaroa shall comprise:

- (a) Five people appointed by the Minister of Education;
- (b) the principal, or principal designate; and
- (c) not more than four people co-opted by the board.

Pursuant to Regulation 9 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998, a senior fisheries management advisor of the Ministry of Fisheries (acting pursuant to a delegated authority in accordance with section 41 of the State Sector Act 1998) hereby gives the following notice.

#### Notice

**1. Title and commencement**—(1) This notice may be cited as the Fisheries (Kaimoana Customary Fishing) Notice (No. 17) 2004.

(2) This notice shall come into effect the day after the date of its notification in the *New Zealand Gazette*.

**2. Interpretation**—In this notice:

- (a) “customary food gathering” has the same meaning as defined in the Fisheries (Kaimoana Customary Fishing) Regulations 1998.
- (b) “Tāngata Kaitiaki” are local dialect words that have the same meaning as “Tāngata Kaitiaki/Tiaki”, a term that is defined in the Fisheries (Kaimoana Customary Fishing) Regulations 1998.
- (c) Any reference to “Tāngata Kaitiaki” means the person or persons appointed under Regulation 9 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998 for the management of customary food gathering within the area/rohe moana.
- (d) Any reference to “area/rohe moana” means the area described by a line commencing at a point on the coastline at Wairakei (37°42.9'S 176°20.2'E), then generally north-westerly following the coastline and Tauranga Harbour to a point on the coastline at Uretara (37°29.8'S 175°57.6'E), then north-easterly by a line to a point on the coastline at Kura-a-Maia (37°27.9'S 175°59.2'E), then generally north-easterly for 24 nautical miles to a point (37°10.3'S 176°19.7'E), then south-easterly to a point (37°25.3'S 176°40.7'E) then generally south-westerly for 24 nautical miles to the point of commencement.

Power to authorise the taking of fisheries resources for customary food gathering**—The Tāngata Kaitiaki may authorise any individual to take fisheries resources managed under the Fisheries Act 1996, other than those resources that are taken in fresh water, for customary food gathering purposes from within the whole or any part of the area/rohe moana. No customary food gathering of fisheries resources may take place in the area/rohe moana without an authorisation from a Tāngata Kaitiaki.

(c) Any reference to “Kaitiaki” means the person or persons appointed under Regulation 9 or 10 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998 for the management of customary food gathering within the area/rohe moana.

(d) Any reference to “area/rohe moana” means one or other of the following two areas:

- (i) Firstly, an area described by a line beginning on the coastline at Poroporo (40°27.0'S 176°37.5'E) east to the 12 nautical mile limit to reference point (40°27.0'S 176°53.0'E), then south-west along the 12 nautical mile limit to reference point (40°52.0'S 176°30.5'E), then west to Mataikona (40°47.0'S 176°16.0'E) and then north-east following the coastline to the point of commencement and;
- (ii) secondly, an area described by a line beginning on the coastline at Owahanga (40°41.0'S 176°21.5'E) then perpendicular to the coastline out to the 12 nautical mile limit (40°47.5'S 176°34.1'E), then south along the 12 nautical mile limit to reference point (40°57.5'S 176°29.9'E), then west towards Whareama to the coastline (40°57.5'S 176°09.0'E) and then north-east following the coastline to the point of commencement.

**3. Cancellation of Kaitiaki**—Te Hika o Papauma, being the tāngata whenua who nominated Matai Hamuera Broughton, Henry James Power, Pikihiua Monica Wilton and William Wright as Kaitiaki, has requested in writing the cancellation of the appointment of the late Henry James Power as a Kaitiaki.

Cancellation of appointment**—The Associate Minister of Fisheries (acting pursuant to a delegated authority) hereby confirms the cancellation of the appointment of the late Henry James Power as a Kaitiaki for managing customary food gathering within the area/rohe moana defined above in 2 (d) (i).

**5. Appointment of Kaitiaki**—The Associate Minister of Fisheries (acting pursuant to a delegated authority) hereby confirms the appointment of Wright Wiremu Broughton as a replacement Kaitiaki to manage customary food gathering for the area/rohe moana defined above in 2 (d) (i), and Patrick Michael Gilbert Dewar as an additional Kaitiaki for the area/rohe moana defined above in 2 (d) (ii).

**6. Confirmation of tāngata whenua**—Te Hika o Papauma is confirmed as the tāngata whenua of the area/rohe moana to which the appointment of Kaitiaki relates.

**7. Power to authorise the taking of fisheries resources for customary food gathering**—The Kaitiaki may authorise any individual to take fisheries resources managed under the Fisheries Act 1996, other than those resources that are taken in fresh water, for customary food gathering purposes from within the whole or any part of each area/rohe moana for which they have been appointed as Kaitiaki. No customary food gathering of fisheries resources may take place in the area/rohe moana without an authorisation from the Kaitiaki.

**Statement of Significant Accounting Policies for the Year Ended 31 March 2004****A. Basis of Preparation**

The Community Trust of Southland was formed under the Trustee Banks Restructuring Act 1988 and is incorporated under the Charitable Trusts Act 1957. The financial statements presented are those for The Community Trust of Southland (“the trust”), Southland Community Trust Charities Limited, making up the parent. The group consists of The Community Trust of Southland (“the trust”), and its wholly owned subsidiary companies, Southland Community Trust Charities Limited and Invest South Limited group.

The financial statements comply with the Financial Reporting Act 1993 and the Community Trusts Act 1999 and the Companies Act 1993. They comprise statements of the following: significant accounting policies, financial performance, movements in trust funds, financial position, cash flows, as well as notes to these statements.

The financial statements are prepared on the basis of historical cost except that investment assets are stated at valuation, as is the trust’s property at 62 Don Street, Invercargill.

**B. Consolidation Method**

The financial statements of the trust’s wholly owned company Southland Community Trust Charities Limited are included in the financial statements of the parent. The financial statements of the trust’s wholly owned company, Invest South Limited Group are included in the financial statements of the group using the purchase method of consolidation.

**C. Associates**

Associates are entities in which the group has significant influence, but not control over the operating and financial policies. The financial statements include the group’s share of the net surplus of associates since acquisition on an equity accounted basis.

**D. Goodwill Arising on Acquisition of Associates**

Goodwill arising on the acquisition of an associate represents the excess of the purchase consideration over the fair value of the identifiable assets acquired. Goodwill is stated at cost and amortised to the statement of financial performance on a straight line basis over the period during which benefits are expected to be derived – a period not exceeding 20 years.

**E. Trust Capital**

Following the sale of the trust’s shares in Trust Bank New Zealand Limited in April 1996 for \$158,460,000, the trustees agreed that the value of the trust at that time should be maintained for the benefit of current and future generations living in the region. For this purpose, the trustees agreed that \$158,460,000 would be considered as the “trust capital” value of the parent. Trustees further agreed that over the long term the net assets of the parent would not be allowed to reduce to a level below the inflation-adjusted real value of this trust capital.

**F. Capital Maintenance Reserve**

The capital maintenance reserve represents the additional amount necessary to preserve the real value of the trust capital allowing for inflation as measured by the Consumers Price Index (all groups) and payments of grants out of capital.

**G. Grants Maintenance Reserve**

While the trustees have adopted a long-term investment strategy, they accept that annual returns from investments are likely to fluctuate from year to year. In recognition of this, a grants maintenance reserve is maintained. In years when net income from investments is higher than the grant levels, surplus income will be transferred to this reserve. In years when there is insufficient income to sustain the level of grants, an appropriate amount will be transferred from the grants maintenance reserve to income.

**H. Basis of Recognising Components of the Financial Statements**

The following general accounting policies are adopted:

*Assets*

A transaction results in an asset being recognised in the statement of financial position when it will probably give rise to ongoing benefits for the group and those benefits can be measured with reliability.

*Liabilities*

A transaction results in a liability being recognised in the statement of financial position when it will probably give rise to the need for the group to sacrifice assets in the future and those sacrifices can be measured with reliability.

*Revenue*

Revenue is recognised in the statement of financial performance when a transaction gives rise to an increase in the value of the group's net assets, and that increase can be measured with reliability.

*Expenses*

An expense is recognised in the statement of financial performance when a transaction results in a decrease in the value of the group's net assets, and that decrease can be measured with reliability.

*Classification of Assets and Liabilities Between Current and Non-current*

An amount is classified as current when it is expected to be settled or extinguished within one year of the date of the financial statements. All other amounts are classified as non-current.

**I. Property, Plant and Equipment (Parent)**

Property, plant and equipment are initially stated at cost and then depreciated on a straight line basis. Land and buildings are stated at valuation as determined by an independent registered valuer. The basis of valuation of the land and buildings is highest and best use. The estimated useful lives of fixed assets are as follows:

Land	Indefinite
Buildings	30-40 years
Furniture and fittings	3-15 years
Office equipment	3-8 years
Motor vehicles	5-8 years

**J. Property, Plant and Equipment (Group)**

Property, plant and equipment are initially stated at cost and then depreciated using maximum rates approved for taxation purposes. The rates and method applied are as follows:

Furniture and fittings	11.4% – 18.0% diminishing value
Office equipment	22.0% – 60.0% diminishing value
Motor vehicles	7.5% diminishing value
Other assets	48.0% diminishing value

**K. Investments With Fund Managers**

Investments with fund managers are stated at market value and report realised and unrealised gains or losses on holding these investments in the statement of financial performance. These gains or losses are shown in the statement of financial performance as income from revaluation of investments.

**L. Other Investments**

Cash investments are stated at cost plus interest credited or accrued to balance date.

**M. Accounts Receivable**

Accounts receivable are stated at expected realisable value.

**N. Rental Payments**

Invest South Limited Group leases its premises in addition to certain items of plant and equipment. Operating lease payments, where the lessor effectively retains substantially all the risks and benefits of ownership of the leased items, are included in the determination of the operating surplus/(deficit) in equal instalments over the lease term.

**O. Debt Funding Advances**

Invest South Limited (a subsidiary) has advanced monies to non-related entities as part of its core business activity. Interest is charged on these advances and accrued where necessary. The investments are recorded at expected realisable value.

**P. Impairment**

If the estimated recoverable amount of an asset is less than its carrying amount, the asset is written down to its estimated recoverable amount and an impairment loss is recognised in the statement of financial performance.

**Q. Grants**

Grants are recognised when they are approved by the trustees. Unpaid grants are recorded as a liability.

**R. Goods and Services Tax**

The parent is not registered for goods and services tax. The parent financial statements are prepared using G.S.T. inclusive accounting. The subsidiary of Invest South Limited Group is registered for G.S.T and all assets and liabilities have been stated exclusive of G.S.T with the exception of receivables and payables which are stated inclusive of G.S.T.

**S. Income Tax**

The parent provides for income tax on its net income after adjusting for tax accounting differences and any beneficiaries' income determinations made pursuant to section OBI (226) of the Income Tax Act 1994.

Invest South Limited Group follows the income taxes payable method for accounting for income tax.

**T. Statement of Cash Flows**

Operating cash flows includes interest and dividends paid or credited to investment funds under management and any upward or downward revaluation of funds during the period. Cash movements in funds invested are recognised in investing activities.

**U. Changes in Accounting Policies**

Land and buildings of the trust have been stated at valuation this year. Last year, land was stated at cost and buildings were stated at cost, depreciated as outlined in the depreciation policy. This had the effect of decreasing the net surplus by \$251,228 and decreasing property, plant and equipment by \$251,228.

With the exception of the above change in accounting policy, uniform accounting policies have been applied throughout the trust and group and on a consistent basis with those of the previous period.

## 21. Segmental Information

The trust's specified area includes all of the areas of Invercargill City Council, Southland District Council and Gore District Council, the Heriot and Tapanui areas of Clutha District Council, and the Wakatipu Basin area of Queenstown Lakes District Council. The trust's principal activities are to invest the trust capital, both within the specified area and outside of the region, and to distribute grants for charitable, cultural, philanthropic, recreational and other purposes being purposes beneficial to the community principally within the trust's specified area.

## 22. Financial Instruments

### *General*

The group states its investments in managed funds at estimated market value. The trustees consider that the fair value of the financial assets is identical to the value in the statement of financial position.

### *Concentration of Credit Risk*

The group, from time to time, has significant funds in trading bank deposits. The group limits risk by spreading the deposits over several trading banks. The group has not required collateral or other security to support its financial statements. The group further limits risk through its policy of placing investment funds with five separate fund managers, with each fund manager having an investment mandate which requires that they diversify their investments on the group's behalf. The group has sought and obtained the advice of professional financial advisers prior to making its investment allocation and placement decisions.

### *Interest Rate Risk*

The bank deposits are sensitive to changes in interest rates, as are a proportion of the funds managed by the fund managers, and the loans to Topoclimate South Charitable Trust and Nga Hau E Wha Society.

## 23. Related Parties

There were no related party transactions during the year.



**24. Subsequent Events**

Subsequent to 31 March 2004, the following events took place which readers of the financial statements need to be aware:

Gas Hornby Limited was placed into receivership by Invest South Limited. Due to directors' assessment of the company's position post balance date, the full value of the loan has been written off as a doubtful debt as recovery of any portion of the debt is regarded as doubtful.
