  - (c) Relationship between the Minister of Fisheries and the ASDO, including dispute resolution.
  - (d) Development and use of approved forms.
  - (e) Information management and system requirements.
  - (f) The technical operating standards for exchange of electronic data and information from an ASDO (including data exchange dictionaries).
  - (g) Supply of information to the Ministry of Fisheries to assist with requests made under the Official Information Act 1982.
- **5. Service standards and specifications**—These standards and specifications relate to the operation and management of specific registry services by an ASDO including standards and specifications relating to:

- (a) Revoking and amending approvals for licences, approvals, authorities, permissions or decisions or a registration where false or misleading information has been supplied.
- (b) Monitoring and recording fishers' compliance with various reporting and record-keeping requirements.
- (c) Client registration.
- (d) Monitoring foreign ownership and quota aggregation provisions.
- (e) Maintaining and operating registers relating to quota, annual catch entitlements (ACE), registered fishing vessels, fishing permits and the transitional register of quota and forward trades.
- (f) Recording decisions regarding quota allocation on the quota and ACE registers.
- (g) Processing transfers of quota and ACE and calculating and comparing ACE with reported catch.
- (h) Processing applications for caveats and mortgages.
- (i) Recording decisions made by the Ministry of Fisheries on applications for fishing permits on the permit register.
- (j) Registering fishing vessels except for the granting of consent to register foreign owned or operated fishing vessels or fish carriers.
- (k) Processing and licensing licensed fish receiver (LFR) applications.
- (l) Receiving and processing of monthly harvesting returns, LFR returns, annual inventory returns from an LFR and annual audit reports from an LFR.

- (n) Issuing Section 80 (Conclusive Notification) notifications.
- (o) Amending catch balances.

- **1. Title and commencement**—(1) This notice may be cited as the Public Trust Common Fund Interest Rates Notice 23 September 2004.

- **2. Interpretation**—(1) Unless the context otherwise requires:
  - "agency deposit" means a deposit (not being an investment deposit) held as agent or attorney;
  - "call deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call:
  - "deposit" means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;
  - "investment deposit" means a deposit held at call or otherwise as an investment under section 51 of the Act;
  - "protection deposit" means a deposit, held at call, of tuition, boarding, accommodation or other fees by or on behalf of a student enrolled at a private training establishment within the meaning of Part 18 of the Education Act 1989;
  - "special deposit" means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

"trust deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.
- (2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.
- **3. Rates of Common Fund interest**—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.
- (2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.
- (3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.
- (4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.
- (5) Despite subparagraphs (1), (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on investment deposits, protection deposits or special deposits that is different from the rate specified in Schedules 1, 2 or 3 and the agreed rate then applies.
- **4.** Revocation of notice and transitional provisions—(1) The Public Trust Common Fund Interest Rates Notice 9 September 2004 is revoked.
- (2) The rates of interest specified in Schedules 1 and 2 to this notice do not apply to any period that ends with 14 September 2004 but otherwise operate as from 15 September 2004.

- (c) In the case of grapes sold, 0.75% plus G.S.T. of the farm gate price before the deduction of any costs or charges.
