 - "protection deposit" means a deposit, held at call, of tuition, boarding, accommodation or other fees by or on behalf of a student enrolled at a private training establishment within the meaning of Part 18 of the Education Act 1989;

- "special deposit" means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;
- "trust deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:
 - (i) for persons not of full age or capacity; or
 - (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.
- (2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.
- **3. Rates of Common Fund interest**—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.
- (2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.
- (3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.
- (4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.
- (5) Despite subparagraphs (1), (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on investment deposits, protection deposits or special deposits that is different from the rate specified in Schedules 1, 2 or 3 and the agreed rate then applies.
- **4.** Revocation of notice and transitional provisions—
 (1) The Public Trust Common Fund Interest Rates Notice 15 July 2004 is revoked.

- **2. Commencement**—This amendment comes into effect on the day after the date on which it is published in the *New Zealand Gazette*.
- **3. Interpretation**—Clause 4 (1) of the programme is amended by revoking the definitions of family credit income and net income.
- **4. New clause 7 substituted**—The programme is amended by revoking clause 7, and substituting the following clause:
 - "7 Financial means test for certain applicants
 - (1) An applicant meets the financial means test referred to in clause 6 (1) (c) (iii) and (d) (ii) if—
 - (a) either the applicant or the applicant's spouse holds a community services card issued under the Health Entitlement Cards Regulations 1993; and
 - (b) the value of the cash assets of the applicant and his or her spouse is less than the appropriate cash assets limit set out in subclause (2).
 - (2) The cash assets limit referred to in subclause (1)
 - (a) \$7,464.00 in the case of an applicant who is married or a sole parent; or
 - (b) \$4,300.00 in any other case.
 - (3) Where an applicant's spouse is receiving care in a hospital care institution or a rest home or a residential disability care institution (within the meaning of the Health and Disability Services (Safety) Act 2001), only 50% of the cash assets of the applicant and the applicant's spouse must be counted as their cash assets."
- **5. Revocation**—Clause 11 of the programme is amended by omitting the words "Social Security" and substituting the words "Social Welfare".
- **6. Transitional provision**—Nothing in this amendment affects any home help assistance granted to an applicant before this amendment comes into effect.

Explanatory Note

This note is not part of the amendment, but is intended to indicate its general effect.

This amendment, which comes into effect on the day after its publication in the **New Zealand Gazette**, simplifies the financial means test in clause 7 of the Home Help Programme to one based on holding a community services card and having cash assets less than \$7,464.00 for a married person or a sole parent, or \$4,300.00 in any other case.

The amendment consequentially revokes unnecessary definitions in clause 4 of the programme, and corrects an erroneous reference to the Minister of Social Security in clause 11.

Notes to the Financial Statements for the Year Ended 31 March 2004

1. Statement of Accounting Policies

The ASB Bank Community Trust ("the trust") is the reporting entity. The trust was formed on 30 May 1988 through the creation of a trust deed in compliance with the Trustee Banks Restructuring Act 1988. Under the terms of the trust deed, the trust was settled with 60 million \$1 fully paid ordinary shares in ASB Bank Limited representing 100% of the issued capital. As at 31 March 1988, the net tangible asset backing of those 60 million shares was \$147,655,000. In 1989, 45 million shares were sold to the Commonwealth Bank of Australia for \$252,000,000 which was then donated to the ASB Charitable Trust. In October 2000, the remaining 15 million shares were sold to the Commonwealth Bank of Australia for \$545,000,000.

The measurement basis adopted is that of historical cost adjusted for the revaluation of certain assets. Reliance is placed on the fact that the trust is a going concern. The financial statements have been prepared in accordance with the requirements of the Financial Reporting Act 1993.

Consolidated Financial Statements

Consolidated financial statements have not been prepared as the subsidiary companies have not traded since incorporation.

Bank

Bank is stated as the balance in the bank account rather than the balance as per the cash book.

Statement of Cash Flows

Cash comprises cash at bank and call deposits but does not include cash or deposits held by the fund managers. Therefore, the statement of cash flows does not reflect the cash flows within the fund managers' portfolios.

Dividends

Dividends are recognised as income when they are received by the trust. They are recorded net of any imputation tax credits.

Donations

Donations are accounted for as they are committed to be distributed to eligible organisations as approved by the trustees.

Expenses

Some expenses are shared jointly with the ASB Charitable Trust. Whilst each trust bears its own specific costs, the joint expenses are allocated between each trust on the basis of the number of applications processed by each.

Notes to the Financial Statements for the Year Ended 31 March 2004

Quota Allocation Systems Administration Changes

The New Zealand Meat Board has completed its consultation on administration changes for its existing Quota Allocation Systems (in terms of sections 26 and 27(2) of the Meat Board Act 2004) being European Union Sheepmeat and Goatmeat Tariff Rate Quota, European Union High Quality Beef Tariff Rate Quota and United States Beef and Veal Tariff Rate Quota.

The board has agreed that the existing allocation systems will remain in operation subject to the following changes:

European Union Sheepmeat and Goatmeat Tariff Rate Quota (226,700 tonnes carcass weight equivalent), European Union High Quality Beef Tariff Rate Quota (300 tonnes product weight) and United States Beef and Veal Tariff Rate Quota (213,402 tonnes product weight)

1. Redundant Provisions (EU Sheepmeat and Goatmeat, and US Beef and Veal only)

Production Weight Calculation Section 9B

This refers to production seasons up to 2000, which is no longer part of production history calculations. This reference is therefore removed.

Transitional Provisions Section 15 Page 1

This refers to production seasons up to 2000, which is no longer part of production history calculations. This reference is therefore removed

2. Changes to European Union Import Regulations (First Come First Served) (European Union Sheepmeat and Goatmeat Quota Allowance Allocation Mechanism Only)

From 1 May 2004, the European Union removed the requirement for import licensing and replaced the Document of Origin with a Certificate of Origin.

All reference to Documents of Origin is therefore removed and replaced with reference to Certificates of Origin.

3. New European Union States (Appendix 6 Page 1 European Union Sheepmeat and Goatmeat and a new Appendix 8 in the European Union High Quality Beef Quota Allowance Allocation Mechanisms)

On 1 May 2004, 10 new states joined the European Union and shipments to those states will require Certificates of Origin if sheepmeat, goatmeat or high quality beef is to be entered within quota. The appendices are updated to provide for up-to-date lists of countries requiring Certificates of Origin.

4. General Quota Applications—Requirements to Produce Production History Figures

The current application form for General Quota Applications requires applicants to provide the volume of qualifying product produced in the last three production seasons. As this information is held and audited by Meat New Zealand, this requirement is an unnecessary duplication of information and removed. The remainder of the application will still be required.

5. New Entrants—Information Requirements (Application by a New Entrant for Reserved Quota Allowance)

Forms 7 and 8 in the US Beef and Veal and EU High Quality Beef manuals and Forms 8 and 9 in the EU Sheepmeat and Goatmeat manual (Application by a New Entrant or New Entrant Consortium for Reserved Quota Allowance) in the existing Quota Manuals are now replaced with a new Form 7 Application for Reserved Quota Allowance for US Beef and Veal and EU High Quality Beef. A new Form 8 Application for Reserved Quota Allowance replaces the existing Forms 8 and 9 in the EU Sheepmeat and Goatmeat manual for EU Sheepmeat and Goatmeat.

In relation to the European Union Sheepmeat and Goatmeat and High Quality Beef Tariff Rate Quotas, the tariff rate applying to "in quota" imports is zero. The US Beef and Veal Tariff Rate Quota has a tariff rate applying to "in quota" imports of \$US0.044 per kilogram on most beef products.

All amendments come into effect as at 1 September 2004.

Consolidated Notes to the Financial Statements for the Year Ended 31 March 2004

1. Statement of Accounting Policies

Reporting Entity

The entity qualifies for differential reporting under the Institute of Chartered Accountants of New Zealand's Differential Reporting Framework due to size. The entity has taken advantage of all available differential reporting exemptions, except that a statement of cash flows has been prepared in accordance with Financial Reporting Standard No. 10.

Reporting Basis

The trustees have chosen to prepare general purpose financial reports which comply with generally accepted accounting practice.

Measurement Base

The measurement base adopted is historical cost with the exception of certain items for which specified accounting policies are identified.

Investment Income (Net)

Investment income (net) includes gross investment income less management fees payable to the fund managers.

Basis of Consolidation

The consolidated financial statements have been prepared using the purchase method of consolidation and include the financial statements of the parent and subsidiary company.

All significant inter-entity profits and transactions have been eliminated in preparing the consolidated financial statements.

Accounts Receivable

Accounts receivable are stated at expected realisable value.

Donations

Donations made from current year's income are recorded in the statement of financial performance when paid. Donations from prior years' income are recorded in the statement of movements in trust funds when paid.

Property, Plant and Equipment

Property, plant and equipment are stated at cost less accumulated depreciation.

Depreciation

Depreciation is charged at the maximum rates allowable by the Inland Revenue Department. The tax rates are as follows:

Furniture and office equipment 13.2 – 48.0 %DV

Goods and Services Tax

The Community Trust of Wellington financial statements are prepared on a G.S.T. inclusive basis.

Shares and Investments

Shares and other investments are stated at the market value. Changes in the market value of investments are taken to the statement of financial performance.

Financial Instruments

All financial instruments held by the trust are recorded in the statement of financial position. The financial instruments comprise equity securities, discounted securities, secured investments, borrowings, deposits and cash. Concentrations of credit risk arise as a result of holding equity securities as investments. These are subject to the normal market risk associated with investments of this nature. There are no significant differences between the fair value and book value of financial instruments.

Where possible, financial assets and liabilities are supported by collateral or other security. These arrangements are described in the individual policy statements associated with each item.

Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.

2. Nature of Business

The Community Trust of Wellington was incorporated as a charitable trust in accordance with the provisions of the Trustee Banks Restructuring Act 1988 and now superseded by the Community Trust Act 1999. The purpose of the community trust is to provide charitable, cultural, philanthropic and recreational benefits to the community, principally in the trust region.

The nature of business of the wholly owned company, Wellington Community Trust Charities Limited, is restricted by its constitution to providing charitable benefits to the community, principally in the region of The Community Trust of Wellington.

The Community Trust of Wellington and its subsidiary company operate under the trading name of "The Community Trust of Wellington".
