### **Radiocommunications Regulations 2001**

### Radiocommunications Regulations (General User Radio Licence for Visiting Amateur Radio Operators) Notice 2004

Pursuant to Regulation 9 of the Radiocommunications Regulations 2001 ("the regulations") made under section 116 (1) (b) of the Radiocommunications Act 1989, and acting under delegated authority from the chief executive, I give the following notice.

#### Notice

- 1. Short title and commencement—(1) This notice is the Radiocommunications Regulations (General User Radio Licence for Visiting Amateur Radio Operators) Notice 2004.
- (2) This notice comes into force on 8 July 2004.
- **2. General user radio licence**—A general user radio licence is granted for the transmission of radio waves by foreign radio amateur operators visiting New Zealand, for the purpose of communications in the amateur radio service in accordance with the terms, conditions and restrictions of this notice.
- **3. Terms, conditions and restrictions**—(1) Persons holding a current amateur certificate of competency, authorisation or licence issued by another administration may operate an amateur station in New Zealand for a period not exceeding 90 days, provided the certificate, authorisation or licence meets the requirements of Recommendation ITU-R M.1544, or CEPT T/R 61-01, or CEPT T/R 61-02, and is produced at the request of the chief executive.
- (2) The call sign used will be the national call sign allocated by the other administration to the person, along with the prefix or suffix "ZL", which is to be separated from the national call sign by the character "/" (telegraphy), or the word "stroke" (telephony).
- (3) The call sign must be transmitted at least once every 15 minutes during communications.
- (4) National and international communication is permitted only between amateur stations, and limited to matters of a personal nature, or for the purpose of self-training, intercommunication and radio technology investigation, solely with a personal aim and without pecuniary interest. The passing of brief messages of a personal nature on behalf of other persons is also permitted, provided no fees or other consideration is requested or accepted.
- (5) Communications must not be encoded for the purpose of obscuring their meaning, except for control signals by the licensees of remotely operated amateur stations.

- (6) Transmitter power output must not exceed 500 watts peak envelope power (pX), as defined in ITU Radio Regulation 1 157
- (7) In accordance with Article 3 of the International Radio Regulations, amateur stations must, as far as is compatible with practical considerations, comply with the latest ITU-R recommendations to the extent applicable to the amateur service.
- (8) In accordance with Article 25 of the International Radio Regulations, licensees are encouraged to prepare for, and meet the communication needs of, national and international disaster relief.
- (9) Amateur beacons, repeaters and fixed links may not be established pursuant to this licence.
- (10) Unwanted emissions outside the frequency bands specified in this schedule must comply with the requirements of ETS 300684.
- (11) The ranges of frequencies, and specific conditions of use, are those prescribed in the Schedule to this notice.

- **2.** The notice shall come into force on the day after its publication in the *New Zealand Gazette*.
- **3.** I hereby establish in Waikare, a primary school called Te Kura o Waikare and designate the school as a designated character school.

### Aims, Purposes and Objectives of Te Kura O Waikare

- **4.** The following aims, purposes and objectives constitute the character of Te Kura Toitu o Waikare:
- Te Reo Māori o Te Kapotai will be the principal language of this school (i.e. of instruction, of communication), and at the same time the board will acknowledge the importance of other languages, which will also be taught;
- To integrate positive Māori values and principles into every aspect of school activities, raising the academic achievement, self-esteem, self-confidence, pride and mana of our tamariki;
- To produce tamariki who become high achievers, who are able to make wise choices about their future and can contribute to whanau and hapu;
- To seek and provide effective and sufficient opportunities to learn Te Reo and Tikanga o Te Kapotai from the marae and rōpu kaumatua/kuia;
- To encourage parents and wider whanau to play an active role in the life of the school and be committed to its aims;
- The school will reflect a holistic learning environment acknowledging the physical, educational, social, cultural and spiritual components of the individual to promote and enhance their overall health and well-being; and
- Whilst the school's character is Te Reo and Tikanga o Te Kapotai, the school is open to all students who embrace these aims, purposes and objectives.

#### **Constitution of the Board of Trustees**

- **5.** The Board of Trustees of Te Kura o Waikare shall comprise:
  - (a) five people appointed by the Minister;
  - (b) the principal, or principal designate; and

Regulation 2 of the Fisheries (South Island Customary Fishing) Regulations 1999, being the 200 mile limit; and inland to the boundaries defined for Te Rūnanga o Awarua, Te Rūnanga o Oraka Aparima, Hokonui Rūnaka and Waihōpai Rūnaka in the First Schedule of Te Rūnanga o Ngāi Tahu Act 1996. The area/rohe moana therefore includes South Island fisheries waters about and within Rakiura and other offshore islands situated within the 200 mile limit

- **3. Nomination of Tāngata Tiaki/Kaitiaki**—Hokonui Rūnaka, being the tāngata whenua holding manawhenua manamoana over the area/rohe moana, has nominated Rodney Alfred Ryan as Tāngata Tiaki/Kaitiaki for the area/rohe moana.
- **4. Appointment of Tāngata Tiaki/Kaitiaki**—The Associate Minister of Fisheries hereby confirms the appointment of Rodney Alfred Ryan as Tāngata Tiaki/Kaitiaki for managing customary food gathering for the area/rohe moana. The appointment is for a term of five years commencing the day this notice comes into effect.
- 5. Power to authorise taking of fisheries resources for customary food gathering—The Tāngata Tiaki/Kaitiaki may authorise any individual to take fisheries resources managed under the Fisheries Acts 1983 and 1996 for customary food gathering purposes from within the whole or any part of the area/rohe moana. No customary food gathering of fisheries resources may take place in the area/rohe moana without authorisation of a Tāngata Tiaki/Kaitiaki.

#### Notice

- **1. Title and commencement**—(1) This notice may be cited as the Public Trust Common Fund Interest Rates Notice 8 July 2004.
- (2) The determinations and revocation notified in this notice take effect from and including 1 July 2004.
- **2. Interpretation**—(1) Unless the context otherwise requires:
  - "agency deposit" means a deposit (not being an investment deposit) held as agent or attorney;
  - "call deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call;
  - "deposit" means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;
  - "investment deposit" means a deposit held at call or otherwise as an investment under section 51 of the Act;

"protection deposit" means a deposit, held at call, of tuition, boarding, accommodation or other fees by or on behalf of a student enrolled at a private training establishment within the meaning of Part 18 of the Education Act 1989;

"special deposit" means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

"trust deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.
- (2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.
- **3. Rates of Common Fund interest**—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.
- (2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.
- (3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.
- (4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.
- (5) Despite subparagraphs (1), (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on investment deposits, protection deposits or special deposits that is different from the rate specified in Schedules 1, 2 or 3 and the agreed rate then applies.
- **4.** Revocation of notice and transitional provisions—(1) The Public Trust Common Fund Interest Rates Notice 24 June 2004 is revoked.
- (2) The rates of interest specified in Schedules 1 and 2 to this notice do not apply to any period that ends with 30 June 2004 but otherwise operate as from 1 July 2004.
- (3) The rates of interest specified in Schedule 3 to this notice:
  - (i) do not apply to investment deposits repayable at the end of a fixed term that commenced prior to 1 July 2004; but
  - (ii) do apply to investment deposits repayable at the end of a fixed term that commenced on or after 1 July 2004.

Clause 3

### Amendments to Direction on Advance Payment of Benefits, Recoverable Assistance Programme and Special Needs Grants Programme

#### Direction on Advance Payment of Benefits

Insert in clause 1.1, after the definition of **advance**, the following definition:

#### "beneficiary

- "(a) means the person granted a benefit; and
- "(b) includes the spouse of the person referred to in paragraph (a) if some or all of that benefit is payable to that spouse under section 83 of the Act."

#### Add the following clause:

- "7.3 Travel for stranded beneficiaries;
- 7.3.1 For the purpose of enabling the beneficiary to return to his or her usual place of residence, the chief executive may make an advance of not more than \$200.00 for travel to a beneficiary who is:
  - (a) stranded away from his or her usual place of residence; and
  - (b) unable to pay for that travel due to circumstances which could not reasonably be foreseen.
- 7.3.2 If any of the beneficiary's spouse or dependent children (a dependant) is, together with the beneficiary, also in the circumstances set out in paragraphs (a) and (b) of clause 7.3.1, the amount of an advance under that clause may be increased by not more than \$200.00 for each such dependant in those circumstances."

### Recoverable Assistance Programme

Insert, after clause 11.10, the following clause:

- "11.11 Travel for stranded persons
  - 11.11.1 For the purpose of enabling the applicant to return to his or her usual place of residence, the chief executive may grant a payment of not more than \$200.00 for travel to an applicant who is:
    - (a) stranded away from his or her usual place of residence; and
    - (b) unable to pay for that travel due to circumstances which could not reasonably be foreseen.
  - 11.11.2 If any of the applicant's dependent children is, together with the applicant, also in the circumstances set out in paragraphs (a) and (b) of clause 11.11.1, the amount of a payment under that clause may be increased by not more than \$200.00 for each such dependant child in those circumstances."

### Special Needs Grants Programme

Revoke clause 11.6.

#### Explanatory note

This note is not part of the instrument, but is intended to indicate its general effect.

This instrument, which comes into effect on 1 July 2004, amends the Direction on Advance Payment of Benefits, Recoverable Assistance Programme and Special Needs Grants Programme to provide that grants for travel for stranded persons who are beneficiaries are made as benefit advances, and for non-beneficiaries, as recoverable assistance payments.

### Notes to the Consolidated Financial Statements for the Year Ended 31 March 2004

### 1. Statement of Accounting Policies

#### 1.1 Reporting Entity

Eastern and Central Community Trust Inc. is a charitable trust incorporated in accordance with the provisions of the Community Trusts Act 1999.

The trust has a wholly owned company – Eastern & Central Community Trust Charities Limited – which is registered under the Companies Act 1993.

The consolidated financial statements have been prepared in accordance with the Financial Reporting Act 1993.

#### 1.2 Measurement Base

The measurement base applied is that of historical cost adjusted for the market valuation of investments.

#### 1.3 Specific Accounting Policies

The following are the particular accounting policies, which have a material effect on the measurement of results and financial position.

#### 1.3.1 Basis of Consolidation

The consolidated financial statements include the trust and its wholly owned company accounted for using the purchase method. All significant inter-entity transactions are eliminated on consolidation. The entities have a common balance date of 31 March.

- **1.3.2 Investment Income** is accounted for on an accruals basis recognising both realised and unrealised gains or losses in value.
- **1.3.3 Foreign Currency** balances are converted to NZD at the year end rate of exchange unless covered by a forward exchange contract. Where such contracts are in place, the contracted rate is adopted. Transactions completed during the year are converted at the rate applying at the approximate date of the transaction. Foreign exchange gains and losses are included within the statement of financial performance.
- **1.3.4** Investments are recorded at market value at year-end
- **1.3.5** Cash comprises cash at bank, call deposits and short-term deposits but does not include cash held by fund managers. Cash flows from operations include withdrawals of income from managed funds.
- **1.3.6 Donations** are recognised as a liability of the trust when they are approved by trustees and notified to applicants notwithstanding that the applicants may still have to fulfil some conditions.

#### 1.3.7 Fixed Assets

Fixed assets are recorded at cost less accumulated depreciation.

**1.3.8 Depreciation** is provided on a straight line basis on all tangible fixed assets at rates calculated to allocate the assets' cost less estimated residual value over their estimated useful lives.

The depreciation periods are:

Computer equipment three years
Fixtures and fittings nine years
Furniture ten years
Office equipment five years

- **1.3.9 Income tax** expense recognises the obligation payable to the Inland Revenue Department.
- **1.3.10** G.S.T. inclusive accounting has been adopted, as the trust is not registered for G.S.T.

#### 1.4 Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been consistently applied.

During the year, the trustees paid \$193,770 to the Inland Revenue Department on behalf of the beneficiaries. The trustees had made provision for the likely tax payable in 2002. No tax is payable this year as all applicants have presented an Inland Revenue letter of exemption from income tax.

#### 4. Trust Capital

The initial trust capital was set at \$90,000,000 in 1997. The trust capital has been increased over time as a surrogate for inflation and population growth within the region administered by the trust. The trustees periodically review the capital

maintenance transfer and this year the trustees have determined to increase the capital by \$1,200,000. Previous transfers have exceeded inflation and population increases.

The rent payable is dependent on the fit-out cost but will not exceed \$48,155 per annum initially. At the conclusion of the second and fourth years, the rental will be adjusted, if necessary, in accordance to any increase in the consumer price index.

#### 12. Related Part Transactions

#### 13. Segmental Reporting

The trust operates as a tax-exempt philanthropic trust distributing funds to the community in the central North Island region.

#### 14. Financial Instruments

Financial instruments include short-term deposits, New Zealand bonds, international bonds, derivatives and investments in managed funds both within New Zealand and overseas.

#### 14.1 Credit Risk

The trustees regularly review their investment strategy. The investment strategy ensures an appropriate diversification of investments so that the trust has no significant concentration of counterparty or credit risk.

#### 14.2 Fair Values

The trust has recorded its financial assets and liabilities at current market values, which represent estimated fair values and credit risk exposure.

#### 14.3 Currency Risk

The trust has exposure to currency risk through its investments in offshore equities managed funds. The current investment policy requires full hedging of currency risk for overseas bonds when held and 50% hedging of currency risk for overseas equities. Since October 2002, the trust has held a tactical hedging position with 100% cover on overseas equities. Since March 2003, the Australian equities have been unhedged. In March 2004, the hedging position on the remaining overseas equities was returned to the strategic 50% cover. Currency risk is managed by fund managers with a range of tolerance.

#### Notes to the Financial Statements for the Year Ended 31 March 2004

### 1. Statement of Accounting Policies

#### **General Accounting Policies**

The following general accounting policies have been adopted in the preparation of the financial statements.

(i) The Community Trust was incorporated as a charitable trust in accordance with the provisions of Community Trusts Act 1999. These financial statements have been prepared in accordance with applicable financial reporting standards.

(ii) The measurement base adopted is that of historical cost, except for the revaluation of investments. Reliance is placed on the fact that the trust is a going concern.

#### **Specific Accounting Policies**

#### **Depreciation**

Depreciation has been charged in the financial statements using rates allowed by the Inland Revenue Department which will write off the cost of assets less their estimated residual value over their estimated economic lives.

The depreciation rates used are:

Buildings 3% c.p.

Office equipment 6-60% c.p.

Furniture and fittings 14-40% d.v.

Computer 28-48% d.v

#### **Fixed Assets**

Fixed assets are recorded at cost less accumulated depreciation.

#### Investments

Investments are shown at market value. Net income including realised and unrealised gains or losses from holding or trading these investments is recorded in the statement of financial performance.

Investment properties are stated at open market value less estimated costs of disposal as determined by independent valuers at balance date. Unrealised changes in the value of investment properties are included in revenue. Investment properties are not depreciated.

#### **Donations**

Donations are accounted for on a cash basis.

#### **Dividend Income**

Dividend income is included in the statement of financial performance when it is received.

#### Income Tax

Income tax expense is recognised on the surplus available for distribution before taxation, adjusting for differences between taxable and accounting income.

#### **Goods and Services Tax**

The subsidiary of Community Trust Charities Limited, Canterbury Trust House Limited, is registered for G.S.T. Accordingly, its financial performance and financial position have been consolidated within the accounts on a G.S.T. exclusive basis.

Subject to the above, the trust is not registered for G.S.T. purposes and therefore, the financial statements have been prepared on a G.S.T. inclusive basis.

#### **Financial Instruments**

Foreign currency transactions are translated to New Zealand currency at the exchange rate ruling at the dates of the transactions. Amounts receivable and payable in foreign currencies at balance date are translated at the exchange rate at that date. Exchange differences arising from the translation of amounts payable and receivable in foreign currencies are recognised in the statement of financial performance.

Off-balance sheet financial instruments that are designated as hedges are recognised on the same basis as the underlying hedged item. Off-balance sheet transactions that do not constitute specific hedges are stated at market value and any resultant gain or loss is recognised in the statement of financial performance.

#### Cash

For the purpose of the statement of cash flows, cash comprises WestpacTrust balances only. Cash excludes bank deposits not used as part of the trust's day-to-day cash management.

#### **Basis of Consolidation**

The Community Trust, Community Trust Charities Limited and its subsidiaries, Canterbury Trust House Limited, Amateur Game or Sport Promoter Limited and District Improvement Organisation Limited have been consolidated using the purchase method of consolidation.

#### **Changes in Accounting Policies**

There have been no changes in accounting policies except the accounting for investment properties from which the trust is deriving rental income. From 31 March 2004 these properties, which were previously recorded at cost less accumulated depreciation, have been valued at market value. The effect of this change is an increase in revenue of \$401,630 and is included in the statement of financial performance. All other policies have been applied on bases consistent with those used last year.

For 2004, this was calculated based on inflation at 1.5% on a core real capital base reserve of \$398,665,315, being the original core real capital base reserve of \$358,000,000 plus the adjusted capital base reserve of \$40,665,315.

The core real capital adjustment recognises an amendment to the trust's capital position to capitalise previously set aside income reserves following the 1996 sale of the Trust Bank NZ Limited shareholding, and also includes an inflationary movement for that adjustment.

Ninety-eight percent (98%) of the assets of the trust are represented by investments held with a range of financial institutions. The trustees consider the risk of non-recovery of these investments to be mitigated by prudent investment strategies and an appropriately diversified portfolio.

#### **Currency Risk**

The trust incurs currency risk as a result of investment transactions entered into by fund managers. Such risks are mitigated by foreign currency hedges where appropriate.

#### **Interest Rate Risk**

The following investments of the trust are sensitive to changes in interest rates: Bank call accounts and deposits, government and local authority and securities held by fund managers.
