##### Accident Compensation Act 2001

Before the levies are set each year, ACC gives businesses, self-employed people and individuals the opportunity to submit feedback not only on the levy proposals, but on all aspects of the Scheme.

The consultation process for the 2015/16 levy year took place from 20 May to 17 June 2014.

The ACC Board would like to thank everyone who made a submission during the 2015/16 levy consultation. All of the submissions were considered and the ACC Board have made their recommendations to the Minister for ACC, Hon Judith Collins.

**What are the ACC Board's 2015/16 recommended levy rates?**

\*Self-employed people and non-PAYE shareholders also pay the non-work claims levy.

#These are average rates. Individual rates for industry groups and motor vehicle classes may be higher or lower than these rates.

Recommended levy rates are GST exclusive.

The ACC Board has also recommended some other changes, including:

- reducing the petrol levy by 2 cents per litre (from 9.90 cents to 7.90 cents).
- implementing “risk rating” of light passenger vehicles (cars) based on crash data (this groups cars into different bands and applies a different licensing levy to each band).
- increasing the minimum and maximum liable earnings limits (for Work and Earners’ levies).

### Fair Trading Act 1986

#### Unsafe Goods (Small High Powered Magnets) Indefinite Prohibition Notice 2014

Pursuant to section 31 of the Fair Trading Act 1986, the Minister of Consumer Affairs gives the following notice.

**Notice**

**1. Title**—This notice may be cited as the Unsafe Goods (Small High Powered Magnets) Indefinite Prohibition Notice 2014.

**2. Commencement**—This notice is effective from the date of publication in the *New Zealand Gazette*.

**3. Revocation**—This notice revokes the Unsafe Goods (Small High Powered Magnets) Notice 2013.

**4. Application**—This notice applies to new and second-hand magnetic objects as defined in clause 5 that are for personal, domestic or household use or consumption and which are supplied, offered for supply, or advertised for supply as:

- a toy, game, puzzle or novelty (including but not limited to an adult desk toy, an educational toy or game, a toy, game or puzzle for mental stimulation or stress relief); or
- a construction or modelling kit; or
- jewellery which may be worn in or around the mouth or nose.

This notice does not apply to hardware magnets, magnets used by educational institutions for teaching purposes, or those that are (or are intended to become) component parts of other products.

**5. Magnetic objects to be declared unsafe goods—**

The following are unsafe goods:

Separable or loose magnetic objects that are supplied in multiples of two or more where:

- At least two of these magnetic objects are each separately able to fit entirely, in any orientation, into the small parts cylinder provided by clause 5.2 and figure 17 of the Australian/New Zealand Standard, *Safety of toys – Part 1: Safety aspects related to mechanical and physical properties* (AS/NZS ISO 8124.1:2013); and
- subject to the changes to AS/NZS ISO 8124.1:2013 set out in clause (c) of this notice, at least two of those magnetic objects each separately have a magnetic flux index greater than  $50(\text{kG})^2\text{mm}^2$  determined as per clause 5.32 of AS/NZS ISO 8124.1:2013; and
- in clause 5.32.5 of AS/NZS ISO 8124.1:2013 omit “ $\text{kG}^2\text{mm}^2$ ” and replace with  $(\text{kG})^2\text{mm}^2$ .

#### **New Zealand Customs Service requirements**

All persons importing into New Zealand magnetic objects to which this notice applies must, on request, produce to a New Zealand Customs Service officer documentation showing that the magnetic objects will meet the relevant tests for size and strength set out in applicable parts of AS/NZS ISO 8124.1:2013 *Safety of toys – Part 1: Safety aspects related to mechanical and physical properties*. All persons bringing magnetic objects to which this notice applies into New Zealand must comply with the requirements of New Zealand Customs Service.

#### **Commerce Commission requirements**

All persons supplying, offering for supply or advertising magnetic objects to which this notice applies must, on request, produce to a Commerce Commission officer within 10 days, documentation showing that the magnetic objects meet the relevant tests for size and strength set out in applicable parts of AS/NZS ISO 8124.1:2013 *Safety of toys – Part 1: Safety aspects related to mechanical and physical properties*.

### **Radiocommunications Regulations (Prohibited Equipment – Animal Tracking and Training Devices) Notice 2014**

**1. Title and commencement**—(1) This notice is the Radiocommunications Regulations (Prohibited Equipment – Animal Tracking and Training Devices) Notice 2014.

(2) This notice comes into force on **24 July 2014**.

**2. Interpretation**—In this notice:

**animal tracking devices** means the radio apparatus described in the Schedule to this notice.

**animal training devices** means the radio apparatus described in the Schedule to this notice.

**licence** means a licence to supply, issued in accordance with the provisions of section 134 of the Radiocommunications Act 1989, providing for the supply and importation for supply of radio apparatus, and specifically allowing importation of animal tracking and training devices for modification.

**modification** means changing the radiocommunication characteristics of animal tracking and training devices so the devices comply with prescribed performance standards and radio licence requirements.

**permitted person** means a person holding a licence allowing importation of animal tracking and training devices for modification.

**3. Prohibition**—(1) Animal tracking devices and animal training devices are interfering equipment.

(2) Animal tracking devices and animal training devices are declared to be prohibited equipment.

(3) The installation, use, sale, distribution or manufacture of animal tracking devices and animal training devices is prohibited.

(4) The importation of animal tracking devices and animal training devices other than by a permitted person is prohibited.

**4. Consequential revocation of notice**—The Radiocommunications Regulations (Prohibited Equipment – Dog Tracking Devices) Notice 2014, dated the 15th day of January 2014 and published in the *New Zealand Gazette*, 23 January 2014, No. 8, page 225, is revoked.
