A “grower” means the occupier of land that is used for growing trees for the production of pipfruit, from which there was harvested at least 1000 kilograms of pipfruit during the year ending with the previous 31st day of October.

Growers are responsible overall for ensuring that levies are deducted from sale payments and that the correct amounts are submitted to PNZI.

A “collection agent” means a person or organisation whose business is or includes buying pipfruit from a grower for resale or export, or sells or exports on behalf of a grower.
