### Public Trust Act 2001

#### The Public Trust Common Fund Interest Rates Notice 4 March 2004

Pursuant to section 50 of the Public Trust Act 2001 ("the Act"), the following notice is given.

#### Notice

**1. Title and commencement**—(1) This notice may be cited as the Public Trust Common Fund Interest Rates Notice 4 March 2004.

(2) The determinations and revocation notified in this notice take effect from and including 1 March 2004.

**2. Interpretation**—(1) Unless the context otherwise requires:

"agency deposit" means a deposit (not being an investment deposit) held as agent or attorney;

"call deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call;

"deposit" means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;

"investment deposit" means a deposit held at call or otherwise as an investment under section 51 of the Act;

"protection deposit" means a deposit, held at call, of tuition, boarding, accommodation or other fees by or on behalf of a student enrolled at a Private Training Establishment within the meaning of Part 18 of the Education Act 1989;

"special deposit" means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

"trust deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Rates of Common Fund interest**—(1) The rate of Common Fund interest payable on a deposit (other than an investment deposit repayable at the end of a fixed term or a protection deposit) shall be that specified in Schedule 1 for the appropriate type of deposit.

(2) The rate of Common Fund interest payable on a protection deposit shall be that specified in Schedule 2 for the appropriate dollar range.

(3) The rate of Common Fund interest payable on an investment deposit repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate term and dollar range.

(4) Despite subparagraph (1), the rate of Common Fund interest payable on a deposit made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(5) Despite subparagraphs (1) (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on an investment deposit, a

protection deposit or a special deposit that is different from the rate specified in Schedules 1, 2 or 3 and the agreed rate then applies.

**4. Revocation of notice and transitional provisions—**  
(1) The Public Trust Common Fund Interest Rates Notice 12 February 2004 is revoked.

(2) The rates of interest specified in Schedules 1 and 2 to this notice do not apply to any period that ends with 29 February 2004 but otherwise operate as from 1 March 2004.

(3) The rates of interest specified in Schedule 3 to this notice:

- (i) do not apply to investment deposits repayable at the end of a fixed term that commenced prior to 1 March 2004; but
- (ii) do apply to investment deposits repayable at the end of a fixed term that commenced on or after 1 March 2004.

**Notice**

**1. Title and commencement—**(1) This notice may be cited as the Public Trust Common Fund Interest Rules Notice 4 March 2004.

**2. Interpretation—**(1) Unless the context otherwise requires:

"agency deposit" means a deposit (not being an investment deposit) held as agent or attorney;

"call deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call;

"deposit" means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;

"investment deposit" means a deposit held at call or otherwise as an investment under section 51 of the Act;

"protection deposit" means a deposit, held at call, of tuition, boarding, accommodation or other fees by or on behalf of a student enrolled at a Private Training Establishment within the meaning of Part 18 of the Education Act 1989;

"special deposit" means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

"trust deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Calculation and payment of Common Fund interest—**(1) Subject to paragraphs 4 and 5 of this notice, interest is calculated and paid on the balance of a deposit standing to the credit of any estate at the end of each day.

(2) Despite subparagraph (1), interest on an investment deposit repayable at the end of a fixed term:

- (i) is calculated daily; but
- (ii) is not payable (unless otherwise agreed by Public Trust and the principal) until the end of the fixed term.

**4. Criteria for determining the dates or times for starting or stopping Common Fund interest—**(1) Subject to subparagraphs (2), (3) and (4), interest on a deposit:

- (i) starts on the day the deposit is received by Public Trust; and



(ii) stops at the end of the day immediately preceding the day on which the deposit ceases to be held by Public Trust.

(2) A trust deposit representing income received by Public Trust (not being Common Fund interest) on terms requiring that income to be accumulated:

(i) is capitalised quarterly on the 1st days of January, April, July and October in each year; but

(ii) until so capitalised, does not bear interest.

(3) A deposit representing Common Fund interest paid on any other deposit (other than an investment deposit) on terms requiring that interest to be accumulated:

(i) is capitalised quarterly on the 1st days of January, April, July and October in each year; but

(ii) until so capitalised, does not bear interest.

(4) A deposit representing Common Fund interest paid on an investment deposit repayable at call, unless otherwise agreed by Public Trust and the principal:

(i) is capitalised quarterly on the 1st days of January, April, July and October in each year; but

(ii) until so capitalised, does not bear interest.

#### 5. Deposits that do not carry Common Fund interest—

(1) This paragraph applies to a deposit that is paid by Public Trust to the Crown Bank Account for the credit of the Treasury by virtue of:

(i) section 74 of the Public Finance Act 1989; or

(ii) any other authority.

(2) A deposit to which this paragraph applies does not carry interest.

(3) Despite subparagraph (2), interest shall be calculated and credited on a deposit to which this paragraph applies until that deposit has been so identified and set apart in the accounts of Public Trust.

(4) Upon a deposit to which this paragraph applies being so identified and set apart in the accounts of Public Trust all accumulations of interest (if any) on the deposit shall be refunded to Public Trust.

#### 6. Revocation of notice and transitional provisions—

(1) The Public Trust Common Fund Interest Rules Notice 7 March 2002 is revoked.

(2) The rules notified in this notice take effect from and including 1 March 2004.

**4. Amounts of grants**—Clause 8 of the programme is amended by revoking clauses 8.1 to 8.2A, and substituting the following clauses:

“8.1 The amount of a grant under clause 5.1 must not exceed:

- “(a) \$250.00; or
- “(b) if the applicant’s specific transition to work expenses are not met by the amount in paragraph (a), that amount and any additional amount (not exceeding \$250.00) required to meet those expenses.

“8.2 The chief executive may make more than one grant to an applicant under clause 5.1 in a 52 week period, but the total amount of the grants made in that period must not exceed:

- “(a) \$250.00; or
- “(b) if the applicant’s specific transition to work expenses are not met by the amount in paragraph (a), that amount and any additional amount (not exceeding \$250.00) required to meet those expenses.”

#### Explanatory Note

*This note is not part of the amendment but is intended to explain its general effect.*

*This amendment to the Work Start Grant Programme (which takes effect on the day after its publication in the New Zealand Gazette):*

- Prevents payment of work start grants to people employed in providing sex services, and
- clarifies that the maximum amount of any grant, and of the total of the grants that can be paid in a 52 week period is \$250.00, but this amount may be increased by up to \$250.00 where it is insufficient to meet an applicant’s specific transition to work expenses as defined in the programme.

## Tertiary Education Commission

### Education (Tertiary Reform) Amendment Act 2002

#### Requirements and Exemptions for Profiles 2005-07 for Tertiary Education Organisations

Under sections 159X (1) and 159Y (3) (b) of the Education Act 1989, and section 7 of the Education (Tertiary Reform) Amendment Act 2002, the Tertiary Education Commission (TEC) gives the following notice.

#### Notice

**1. Title and commencement**—(1) This notice may be cited as the Education (Profile 2005-07 for Tertiary Education Organisations) Notice 2004.

(2) This notice applies from the date of its publication.

**2. Introduction**—To access funding from the Tertiary Education Commission (TEC) for the 2005 year, all tertiary education organisations (TEOs), other than those exempted via this notice, are required to have an approved Profile, as described in section 159W of the Education Act 1989, in place by 15 December 2004 that covers the period 2005-2007. This Profile will be referred to as “Profile 2005-07”.

Profiles are multi-purpose documents. They first and foremost “profile” each TEO. That is, a Profile is a TEO’s document that outlines for its students and its other key stakeholders how it will give effect to its Charter and what its contribution in terms of the Tertiary Education Strategy (TES) and Statement of Tertiary Education Priorities (STEP) will be.

Second, Profiles during the process of negotiation and agreement with the TEC, provide a means of identifying and resolving areas of duplication and gaps in delivery and once completed, inform decisions on the allocation of public funding.

Overall, Profiles serve the following purposes, they:

- demonstrate how an organisation will give effect to its Charter;

- provide the basis for monitoring organisational performance, accountability for the use of public funds, and meeting other statutory requirements;
- contribute to a system-wide map of tertiary provision which can inform TEC in its role of giving effect to the TES;
- encourage relevance of educational provision to stakeholders' needs;
- encourage greater co-operation and collaboration; and
- provide information on existing and planned programmes and activities as a basis for allocating public funding.

### Guiding Principles for Profiles

To achieve all these purposes, the processes and requirements for Profile 2005-07 have been specifically designed to maximise the presence of following principles:

*Adding Value to the Tertiary System* – the system of Profiles must minimise bureaucracy and unnecessary compliance activities. It must provide the sector with useful information that assists TEOs in their own planning, monitoring, and review activities.

*Consistent but Responsive* – the system of Profiles must take a consistent but responsive approach to Profile requirements for different parts of the sector (*i.e.* the core requirements are common across the sector but the design also takes into account the particular operational and legislative characteristics of different parts of the sector).

*Reciprocity* – the system of Profiles involves working with the sector to facilitate implementation of the TES and the STEP and to achieve the results agreed with the sector. Profiles must ensure processes are of benefit to TEOs and to TEC.

*Autonomy of Tertiary Education Institutions (TEIs)* – the system of Profiles must recognise the legislative autonomy of TEIs and the multiple and distinct accountabilities of TEIs.

*Sector Involvement* – encouraging the involvement of the sector in the specification of the information and other requirements for Profiles.

### Content, Criteria, Timeline and Process for Profile 2005-07 for Tertiary Education Organisations

The content and criteria for Profile 2005-07 are based on the content requirements developed by the Charter and Profiles Working Party and endorsed by the Government.

Specific content, criteria, process and timeline requirements apply for:

- Universities;
- Polytechnics;
- Wananga;

- Private Training Establishments, Other Tertiary Education Providers (OTEPs) and Rural Education Activities Programmes (REAPs); and
- Schools that provide tertiary education or tertiary-education related services.

### Exemptions for Certain Organisations

The following TEOs are exempted from the requirement to prepare and submit to the TEC a Profile for the period 2005-07:

- organisations that receive up to \$50,000.00 of funding from the TEC in any one year; and
- organisations with which the TEC is contracting only pilot initiatives and which otherwise receive no funding from the TEC.
