- **1. Title and commencement**—(1) This notice may be cited as the Education (Domestic Students) Notice 2012.
- (2) This notice shall come into force on 1 July 2012.

    - (ii) who is the subject of an Interim Order of Adoption granted by the New Zealand Family Court under section 5 of the Adoption Act 1955 (where the Final Order will entitle that person to education as a domestic student).
  - (d) The dependent child of an international student who is enrolled in a Doctor of Philosophy programme at a New Zealand university.
  - (e) A person who is in the custody of the Chief Executive of the Ministry of Social Development pursuant to any of the following orders:
    - (i) An order, pursuant to sections 78, 101 or 238(1)(d) of the Children, Young Persons, and their Families Act 1989, in favour of the Chief Executive of the Ministry of Social Development.
    - (ii) An order, pursuant to section 110 of the Children, Young Persons, and their Families Act 1989, appointing the Chief Executive of the Ministry of Social Development as sole guardian.
    - (iii) An order, pursuant to section 33 of the Care of Children Act 2004, whereby a child or young person is placed under the guardianship of the Family Court or the High Court and the Chief Executive of the Ministry of Social Development is appointed as agent of the Court with power and discretion to place the child.
  - (f) The dependent child of an international student who is supported by a scholarship funded by the

- New Zealand Aid Programme administered by the Ministry of Foreign Affairs and Trade.
- (g) A person who has a letter from the Protocol Division of the Ministry of Foreign Affairs and Trade confirming that he or she is, for the time being, entitled to any immunity from jurisdiction by or under the Diplomatic Privileges and Immunities Act 1968 or the Consular Privileges and Immunities Act 1971 for the current school year, until the end of the year in which that status expires.
- (h) A person who holds a student visa and who is the dependent child of the holder of a valid military visa.
- (i) A person who has, or who is the dependent child of any person who has, made a claim to be recognised as a refugee or a protected person in accordance with Part 5 of the Immigration Act 2009, and who is the holder of a valid temporary visa.
- (j) A person who has, or who is the dependent child of any person who has, been recognised as a refugee or a protected person in accordance with Part 5 of the Immigration Act 2009, and whose application for residence is being processed.
- (k) A person who is the dependent child of any person who is a New Zealand citizen or the holder of a residence permit under the Immigration Act 1987 or of a residence class visa under the Immigration Act 2009 and whose own application for a residence class visa under the Immigration Act 2009 has been received and is being considered for approval by Immigration New Zealand at the time the student enrols.
- (1) A person who holds a student visa and who is the dependent child of a person who is the holder of a valid work visa (other than a work visa granted under the Crew of Foreign Chartered Fishing Vessels, Seasonal Work or Special 90 Day Trial Visa categories) until the end of the year in which the work visa expires¹.

  - (ii) Either the child has not been previously enrolled at a registered school in New Zealand or the child's most recent enrolment was as a domestic student.
  - (iii) Except for those children listed in paragraphs (A), (B) or (C) below, the child has not held an interim visa with study conditions, a visitor visa with study conditions, a limited purpose permit granted under the Immigration Act 1987 or a limited visa granted under the Immigration Act 2009.

- (A) Children who have held a student visa or permit issued under the Immigration Act 1987 or the Immigration Act 2009.
- (B) Children who have held a limited purpose permit issued under the Immigration Act 1987 for the purpose of study while the student's immigration status was being determined.
- (C) Children who arrived in New Zealand before 23 August 2011.
- **3.** Interpretation and transitional provisions—(1) For the purposes of paragraph (b) of clause 2 of this notice, an approved New Zealand student exchange scheme or an approved exchange programme organisation means a scheme or organisation holding an unexpired approval from the Ministry of Education dated on or after 1 July 2012.
- (2) Until 1 July 2013, a student exchange scheme or an exchange programme organisation approved by the Ministry of Education before 1 July 2012 is deemed to be an approved New Zealand student exchange scheme or an approved exchange programme organisation for the purposes of subclause (1) of this clause.
- (3) Any scheme or organisation with deemed approval under subclause (2) of this clause must apply to the Ministry of Education to continue their approval beyond 1 July 2013.

- (c) The fees charged for the provision of the names and addresses from the Motor Vehicle Register are duly paid;
- (d) Any identified instances of unauthorised access are immediately notified to the Secretary for Transport and the Privacy Commissioner;
- (e) Before being permitted to access the Motor Vehicle Register under section 241 of the Act, all staff must receive training that emphasises that such access must only be for the specified purpose, and refresher training of all staff also must be undertaken at appropriate intervals;
- (f) Access must be restricted solely to a centralised location and to members of staff for whom authorised access is essential to achieving the specified purpose;
- (g) The names and addresses obtained under this authorisation shall not be disclosed to any third party unless such disclosure is necessarily incidental to achieving the specified purpose;
- (h) In the first instance, an unnamed notice of breach must be placed on a vehicle to allow the person in charge of the vehicle a reasonable time to pay a fee or to appeal the imposition of the fee before the Motor Vehicle Register is accessed for name and address details;
- (i) Records must be kept of the purpose and occasions whenever names and addresses are accessed from the Motor Vehicle Register, and these records must be sufficient to establish that in each case a reasonable period has been allowed for payment before the Motor Vehicle Register has been accessed for name and address details;
- (j) Britomart Oriental Company (trading as Auckland Carpark Enforcement Services) must provide an annual report to the NZ Transport Agency on compliance with these conditions by 1 June in each year beginning with 1 June 2013 (this requirement may be incorporated into the company's usual audit practices); and

#### Electricity Industry (Exemption No. 137 (Clearing Manager)) Exemption Notice 2012

Pursuant to section 11 of the Electricity Industry Act 2010, the Electricity Authority ("Authority") gives the following notice.

#### Notice

- **1. Title and commencement**—(1) This notice is the Electricity Industry (Exemption No. 137 (Clearing Manager)) Exemption Notice 2012.
- (2) This notice comes into force on the day after the date it is notified in the New Zealand Gazette.
- **2. Exemption**—(1) The clearing manager is exempted, in respect of all trading periods on 26 March 2011, from compliance with the following timeframes specified in the Electricity Industry Participation Code 2010 ("Code"):
  - (a) The requirement in clause 13.197 of the Code that calculation of constrained off amounts for the previous billing period be completed by 1600 hours on the 8th business day of each billing period;
  - (b) the requirement in clause 13.198 of the Code that the sending of constrained off amounts and constrained off quantities to the system operator, for the previous billing period, be completed by 1600 hours on the 8th business day of each billing period;
  - (c) the requirement in clause 13.199 of the Code that publication of the details of constrained off amounts for each generator for the previous billing period be completed by 1600 hours on the 8th business day of each billing period;
  - (d) the requirement in clause 13.206 of the Code that calculation of constrained on amounts for the previous billing period be completed by 1600 hours on the 8th business day of each billing period;
  - (e) the requirement in clause 13.207 of the Code that the sending of constrained on amounts and constrained on quantities to the system operator, for the previous billing period, be completed by 1600 hours on the 8th business day of each billing period;
  - (f) the requirement in clause 13.208 of the Code that publication of the details of constrained on amounts in relation to each generator and ancillary service agent for the previous billing period be completed by 1600 hours on the 8th business day of each billing period;

- (g) the requirement in clause 14.36(1) of the Code that the issuing of invoices is completed two business days after receiving reconciliation information; and
- (h) the requirement in clause 14.36(2) of the Code that the issuing of invoices to each person to whom ancillary service costs have been allocated is completed two business days after receiving reconciliation information.
- (2) The clearing manager is exempted, in respect of trading periods 22 to 35 on 26 March 2011 and in respect of generation plant in the North Island, from compliance with the requirement in clause 13.212 of the Code for the clearing manager to include constrained on compensation in any invoice issued to generators or ancillary service agents.
- 3. Term—This exemption expires on 31 August 2012.
- **4. Reasons for granting the exemption**—The reasons for granting this exemption are:
  - (a) the Authority's decision to correct the undesirable trading situation ("UTS") on 26 March 2011 involves determining the final prices (and final reserve prices) for trading periods 22 to 35 on 26 March 2011;
  - (b) due to final prices and final reserve prices not being published until 17 May 2012, the clearing manager will not be able to comply with clauses 13.197, 13.198, 13.199, 13.206, 13.207, 13.208, 14.36(1) and 14.36(2);
  - (c) due to the UTS decision requiring the calculation of constrained on amounts under Part 13 of the Code for trading periods 22 to 35 on 26 March 2011 to be curtailed, so that no constrained on compensation will be paid in respect of generation plant in the North Island, the clearing manager will not be able to comply with clause 13.212;
  - (d) the exemption means the Authority's UTS decision can be implemented without the clearing manager breaching the Code;
  - (e) it is not necessary for the clearing manager to meet these requirements for the Authority to achieve its statutory objective; and
  - (f) granting the exemption will reduce overall administration and compliance costs as the clearing manager will not have to report its breaches and the Authority will not be required to investigate them.
