- (iii) The school will reflect a holistic learning environment (i.e. physically, educationally, socially, culturally, and spiritually) where emphasis will be placed on encouraging students to actively participate in all fields of traditional and modern sciences and technology within all curriculum areas.
- (iv) Students will be motivated to participate fully to the best of their abilities, in the learning programmes of this school.
- (v) Students will develop a global understanding of cultural, educational, and social development and advancement.

5. The Board of Trustees of Te Wharekura o Kirikiriroa shall comprise:

- (a) five people appointed by the Minister;
- (a) the principal, or principal designate;

“special deposit” means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

“trust deposit” means a deposit held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call (not being a special deposit).

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Rates of Common Fund interest—**(1) The rate of Common Fund interest payable on a deposit (other than an investment deposit repayable at the end of a fixed term) shall be that specified in Schedule 1 for the appropriate type of deposit.

(2) The rate of Common Fund interest payable on an investment deposit repayable at the end of a fixed term shall be that specified in Schedule 2 for the appropriate term and dollar range.

(3) Despite subparagraph (1), the rate of Common Fund interest payable on a deposit made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(4) Despite subparagraph (1), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on a special deposit that is different from the rate specified in Schedule 1 and the agreed rate then applies.

**4. Revocation of notice and transitional provisions—**

(1) The Public Trust Common Fund Interest Rates Notice 13 February 2003 is revoked.

(2) The rates of interest specified in Schedule 1 to this notice do not apply to any period that ends with 24 February 2003 but otherwise operate as from 25 February 2003.

Now therefore I, Dame Silvia Cartwright, the Governor-General of New Zealand, and as such the Governor of the Dependency, appoint

Douglas Bell

to be an officer of the Government of the Dependency while he acts as Senior New Zealand Representative at Scott Base during the period beginning with this appointment and ending with the close of 10 October 2003.

I confer on Douglas Bell, while he holds office as an officer of the Government of the Dependency, all the powers exercisable in New Zealand by a Justice of the Peace, and also the powers exercisable in New Zealand by a Coroner.

Douglas Bell is to exercise his functions at such places within the Dependency as may be directed by an officer of the Government of the Dependency who has the general executive and administrative authority in preserving Her Majesty’s rights and sovereignty and the laws in force in the Dependency.

As witness the hand of Her Excellency the Governor-General as the Governor of the Ross Dependency, this 17th day of February 2003.

(2) This notice has the status of a Regulation for the purposes of the Regulations (Disallowance) Act 1989.

#### Food Standards Australia New Zealand Act 1991

##### Food Standards Australia New Zealand Variations to the *Australia New Zealand Food Standards Code* (Amendment No. 65)

##### 1. Preamble

The variations set forth in the Schedule below are variations to the *Australia New Zealand Food Standards Code* (hereinafter called “the Code”) which was published by the National Health and Medical Research Council in the *Commonwealth of Australia Gazette*, No. P 27, on 27 August 1987, and which has been varied from time to time.

These variations are published pursuant to section 23A of the *Food Standards Australia New Zealand Act 1991*.

##### 2. Citation

These variations may be collectively known as Amendment No. 65 to the Code.

##### 3. Commencement

These variations commence on the date of gazettal.

[3] *Standard 2.2.1 of the Australia New Zealand Food Standards Code is varied by omitting clause 11, substituting –*

**11 Bovine meat and meat products must be derived from animals free from bovine spongiform encephalopathy**

(1) In this clause –

**minor ingredient** means an ingredient that comprises no more than 300 g/kg of the food.

(2) Subject to subclause (3), bovine meat and food ingredients derived from bovines must be derived from animals free from bovine spongiform encephalopathy.

(3) Subclause (2) does not apply to –

- (a) collagen from bovine skins and hides (including sausage casings produced from this type of collagen); and
- (b) a minor ingredient of a processed product, where that ingredient comprises –
  - (i) bovine fat; and/or
  - (ii) bovine tallow; and
- (c) gelatine sourced from bovine skins and hides; and
- (d) dairy products sourced from bovines.

**Editorial note :**

Clause 11 applies to Australia only. Bovine products imported for sale in New Zealand are regulated by the New Zealand Food Standards.

## Pipfruit Growers New Zealand Incorporated

### Commodity Levies (Pipfruit) Order 2000

#### Commodity Levies (Pipfruit) Order 2000

Pipfruit growers and collection agents are advised that the levy rate for the 1 November 2002 to 31 October 2003 season has been set at 1.0 cent per kilogram of pipfruit (plus G.S.T.). This is the same rate as for the previous year.

A “grower” means the occupier of land that is used for growing trees for the production of pipfruit, from which there was harvested at least 1000 kilograms of pipfruit

during the year ending with the previous 31st day of October.

Growers are responsible overall for ensuring that levies are deducted from sale payments and that the correct amounts are submitted to Pipfruit Growers New Zealand Incorporated (PGNZI).

A “collection agent” means a person or organisation whose business is or includes buying pipfruit from a grower for resale or export, or sells or exports on behalf of a grower.

A collection agent is required to deduct the levy from payments due to growers and to forward these amounts to PGNZI within 90 days of sale or export.
