The Rule proposes relatively minor changes, including: clarifying or modifying current requirements to assist understanding and enforcement, amending requirements or removing unnecessary or unintended requirements to reduce the burden of compliance (without diminishing safety standards), amending requirements to accord with current practices and technology, updating vehicle standards requirements to ensure that vehicles continue to be operated safely or to allow vehicles to comply with acceptable standards that, to date, have not been incorporated into Rules, and amending definitions of terms used in Rules to align with other legislation including other Rules.
