**Fisheries (Total Allowable Catch) Notice (No. 2) 2002 (No. F224)**

Pursuant to section 13 of the Fisheries Act 1996, the Minister of Fisheries makes the following notice.

**Notice**

- 1. Title**—This notice is the Fisheries (Total Allowable Catch) Notice (No. 2) 2002.
- 2. Commencement**—This notice comes into force on 30 September 2002.
- 3. Interpretation**—In this notice, the fishstock codes, quota management areas and quota management system codes have the same definition as in the Fisheries (Declaration of New Stock Subject to Quota Management System) Notice 2001 (S.R. 2001/318) and the Fisheries (Declaration of New Stocks Subject to Quota Management System) Notice 2002 (S.R. 2002/100).
- 4. Total allowable catches**—The total allowable catch for each quota management stock is that amount stated in the final column of the Schedule to this notice.
- 5. Revocation**—The Fisheries (Total Allowable Catch) Notice 2002 (No. F222) is revoked.
