### Fisheries (Kaimoana Customary Fishing) Regulations 1998

#### Fisheries (Kaimoana Customary Fishing) Notice (No. 2) 2012 (No. MPI01)

Pursuant to Regulation 10 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998, the Director Māori Partnership Implementation at the Ministry for Primary Industries (acting pursuant to a delegated authority in accordance with section 41 of the State Sector Act 1988) gives the following notice.

#### Notice

**1. Title and commencement**—(1) This notice may be cited as the Fisheries (Kaimoana Customary Fishing) Notice (No. 2) 2012.

(2) This notice shall come into effect on **4 May 2012**.

**2. Interpretation**—In this notice:

- (a) "customary food-gathering" has the same meaning as defined in Regulation 2 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998.
- (b) "Kaitiaki" is a local dialect word that has the same meaning as "Tangata Kaitiaki/Tiaki", a term that is defined in Regulation 2 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998.
- (c) "Kaitiaki" means the person or persons appointed under Regulation 9 or 10 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998 for the management of customary food-gathering within the area/rohe moana.
- (d) "area/rohe moana" means the area described by a line commencing on the coastline at Mataikona (40°47.0'S 176°16.0'E); then perpendicular to the coastline out to the 12 nautical mile limit (40°52.0'S 176°30.5'E); then south along the 12 nautical mile limit to a point (41°01.0'S 176°22.3'E); then west towards the Whareama River at (41°01.0'S 176°06.5'E); and then north-east following the coastline to the point of commencement. The geographical coordinates named are in terms of the WGS84 datum.

**3. Request to cancel appointment**—The Pāpāuma Māori Committee, acting for Te Hika o Pāpāuma, being the tangata whenua who nominated the late Pikihiua Monica Wilton as a Kaitiaki for the area/rohe moana, has requested in writing the cancellation of her appointment as a Kaitiaki.

**4. Cancellation of appointments**—On 16 April 2012, the Minister for Primary Industries cancelled, under Regulation 10(1) of Fisheries (Kaimoana Customary Fishing) Regulations 1998, the appointment of the late

Pikihuia Monica Wilton as a Kaitiaki for managing customary food-gathering within the area/rohe moana.

**5. Nomination of a Kaitiaki**—The Pāpāuma Māori Committee, acting for Te Hika o Pāpāuma, has nominated Thomas Wilton as a replacement Kaitiaki for managing customary food-gathering within the area/rohe moana.

**6. Appointment of a Kaitiaki**—On 16 April 2012, the Minister for Primary Industries appointed, under Regulation 10(2) of Fisheries (Kaimoana Customary Fishing) Regulations 1998, Thomas Wilton as a replacement Kaitiaki for managing customary food-gathering within the area/rohe moana.

**7. Power to authorise the taking of fisheries resources for customary food-gathering**—A Kaitiaki may authorise any individual to take fisheries resources managed under the Fisheries Act 1996 for customary food-gathering purposes from within the whole or any part of the area/rohe moana. No customary food-gathering of fisheries resources may take place in the area/rohe moana without an authorisation from a Kaitiaki.

#### Notice

**1. Title and commencement**—(1) This notice may be cited as the Public Trust Common Fund Interest Rates Notice 3 May 2012.

(2) Unless otherwise specified, the determinations and revocation in this notice take effect from and including 2 May 2012.

**2. Interpretation**—(1) Unless the context otherwise requires:

“agency deposit” means a deposit (not being an investment deposit) held as agent or attorney;

“call deposit” means a deposit (not being an agency deposit, an investment deposit, a protection deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call;

“deposit” means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;

“investment deposit” means a deposit held at call or otherwise as an investment under section 51 of the Act;

“protection deposit” means a deposit, held at call, of tuition, boarding, accommodation or other fees by or on behalf of a student enrolled at a private training establishment within the meaning of Part 18 of the Education Act 1989;

“special deposit” means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

“trust deposit” means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Rates of Common Fund interest**—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.

(3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.

(4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(5) Despite subparagraphs (1), (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on investment deposits, protection deposits or special deposits that is different from the rate specified in Schedules 1, 2, or 3 and the agreed rate then applies.

**4. Revocation of notice and transitional provisions**—(1) The Public Trust Common Fund Interest Rates Notice 26 April 2012 is revoked.

(2) Unless otherwise specified, the rates of interest specified in Schedules 1 and 2 to this notice do not apply to any period that ends with 2 May 2012 but otherwise operate as from 3 May 2012.

(3) The rates of interest specified in Schedule 3 to this notice:
