#### (b) Auckland Waitemata Harbour

In the navigable areas contained between a line drawn from the light on Orakei Wharf (occulting red every 6 seconds), 355° to North Head and a line drawn 035° from the head of Wynard Wharf to the light known as Bayswater light beacon (flashing red every 3 seconds).   - provide a summary of the audit report to the Ministry (refer to condition 9).
- 3. The DAA must provide in writing any information about the auditing of health care services pursuant to the Act if requested by the Ministry.
- 4. During the term of the DAA's designation, the DAA will allow the Ministry to audit or to commission the undertaking of audits or reviews of the DAA. This could also include attending audits being undertaken by the DAA. The Ministry may or may not notify the DAA of any audit or review.
- 5. The DAA must immediately notify the Ministry in writing of any significant change to the DAA, including but not restricted to:
  - any change in ownership and/or control of the legal entity;
  - any change in management personnel;
  - any change to the Auditor Register (refer to condition 8); and
  - any change in the status of any third party accreditation the DAA may hold, including evidence of such accreditation and copies of any Third Party Accreditation Audit Reports or notifications in respect of their accreditation.
- 6. The DAA must conduct as a minimum at least one annual:
  - internal audit that focuses on the DAA's auditing activities undertaken pursuant to the Act, together with a compliance audit against the requirements of the DAA as set out in the Act; and
  - management review in respect of the DAA's programmes operated pursuant to the Act.
- 7. The DAA shall at all times operate an internal appeals system which is documented and conveyed in writing to all clients. Auditable records of the facts and outcomes of all client appeals shall be maintained by the DAA. The DAA must provide these records in writing to the Ministry when requested by the Ministry.
- 8. The DAA must provide in writing, in a timely manner when requested by the Ministry, the details of the name, auditing qualifications and experience and, if relevant, the area of clinical or service competency of each auditor or technical expert approved by the DAA to undertake audits pursuant to the Act.
- 9. The DAA must provide all documentation to the Ministry in the form prescribed by the Ministry.
- 10. The DAA must hold third party accreditation with a Ministry approved third party accreditation body.
- 11. The DAA must notify the Ministry of any intent to audit district health boards' provision of hospital care services (as defined in section 4(1) of the Act), and satisfy the Ministry as per section 33(b) of the Act that it has:
  - (i) the technical expertise to audit the provision of services of that kind; and
  - (ii) effective systems in place for auditing the provision of services of that kind.

### **Commerce Act 1986**

### Notification of Amendment to Input Methodologies for Transpower

The Commerce Commission ("Commission") has amended the input methodologies applicable to electricity lines services supplied by Transpower under Part 4 of the Commerce Act 1986.

The amended input methodologies are:

• Transpower Input Methodologies Determination [2012] NZCC 17 • Transpower Capital Expenditure Input Methodology Determination [2012] NZCC 2

The amendment is set out in the *Transpower Input Methodologies Amendments Determination 2014* [2014] NZCC 22, and will apply to the determination of Transpower's individual price-quality path.

In summary, our decisions are:

**Specified asset lives**—we have removed the requirement to spread depreciation for "end-of-life" assets across a regulatory period from the asset valuation input methodology. We have made this amendment because it will reduce Transpower's compliance costs by aligning regulatory treatment with generally accepted accounting practice, and will not detract from investment incentives given the application of the *Transpower Capital Expenditure Input Methodology Determination*.

Definition of "commissioned"—we have clarified that land which is base capex under the *Transpower Capital Expenditure Input Methodology Determination* may enter the regulatory asset base upon acquisition. This amendment will reduce uncertainty by removing ambiguity about the appropriate treatment of land intended to be used to provide electricity transmission services, but which is purchased prior to use. The framework introduced by the *Transpower Capital Expenditure Input Methodology Determination* will provide adequate incentives for prudent acquisition of low-cost land acquired for strategic purposes.

Reconsideration of the individual price-quality path—we have amended the reconsideration of an individual price-quality path input methodology to reflect changes to terminology resulting from the Transpower Capital Expenditure Input Methodology Determination. These amendments will allow reconsideration of the revenue-linked grid output measures following a catastrophic event, error or change event. We have made this amendment to ensure consistency with the quality standards terminology used in the Transpower Capital Expenditure Input Methodology Determination.

Recoverable costs—we have amended the specification of price input methodology to allow expenditure, classified as opex under generally accepted accounting practice, to be treated as recoverable costs if originally forecast as approved major capex. We have made this amendment to preserve the neutrality of efficiency incentives irrespective of the accounting treatment ultimately adopted for expenditure incurred in major capex projects approved under the Transpower Capital Expenditure Input Methodology Determination. We have also allowed for the recovery of prudent additional net opex incurred as the result of a catastrophic event. We have made this amendment because there is currently no allowance for the additional costs incurred in responding to a catastrophic event, which may undermine incentives to respond efficiently and appropriately.

**Definition of "forecast CPI"**—we have updated the methodology for forecasting CPI with reference to the Reserve Bank's policy target for inflation. This amendment aligns with similar amendments to the input methodologies application to other regulated energy sectors for the purposes of setting capex allowances. We have made this amendment because it is a better indicator of inflation.

**Definition of "related party"**—we have updated the definition of related party to exclude parties that are related to Transpower by virtue of Crown ownership. We have made this amendment because it reduces compliance costs for Transpower by excluding parties that are related solely as a result of Transpower being a Crown-owned entity, while preserving the policy intent of the input methodologies that exclude certain related party transactions or arrangements.

Calculation of depreciation—we have amended the asset valuation input methodology to allow for part-year depreciation for newly-commissioned assets, and a transitional adjustment to align Transpower's regulatory asset base values with its asset values calculated under generally accepted accounting practice as at 1 July 2015, and established a depreciable pseudo-asset to preserve net present value neutrality. We have made this amendment as it will reduce Transpower's compliance costs by aligning regulatory treatment with generally accepted accounting practice on a net present value-neutral basis.

### Government Roading Powers Act 1989 Land Transport Act 1998

### New Zealand Transport Agency (Wellington Tunnels) Bylaw 2014

Pursuant to section 61(3) of the Government Roading Powers Act 1989 for the purposes specified in section 22AB(1)(c), (1)(h), (1)(o)(iv) and (1)(o)(vii) of the Land Transport Act 1998, the NZ Transport Agency makes the following bylaw.

### Bylaw

**1. Title and commencement**—This bylaw may be cited as the New Zealand Transport Agency (Wellington Tunnels) Bylaw 2014 and shall come into force 28 days after the date of its publication in the *New Zealand Gazette*.

### 2. Application and scope—

**Terrace Motorway Tunnel**—Where this bylaw applies to the Terrace Motorway Tunnel it will have effect as follows:

Northbound on State Highway 1 from the intersection of Willis Street / Abel Tasman Street and Karo Drive, along Karo Drive and through the Terrace Motorway Tunnel to the junction of the Clifton Terrace on-ramp; and

Southbound on State Highway 1 from the junction of the Terrace off-ramp and through the Terrace Motorway Tunnel to the Willis Street intersection.

**Arras Tunnel**—Where this bylaw applies to the Arras Tunnel it will have effect as follows:

Westbound from the intersection of Sussex Street and State Highway 1, through the Arras Tunnel to the intersection of State Highway 1 and Taranaki Street.

**Mount Victoria Tunnel**—Where this bylaw applies to the Mount Victoria Tunnel it will have effect as follows:

Northbound on State Highway 1 from the intersection of Ruahine Street and Taurima Street to the Mount Victoria Tunnel, through the Mount Victoria tunnel and up to the intersection of Paterson Street and Dufferin Street; and

Southbound from the intersection of Dufferin Street and Paterson Street along State Highway 1 to the Mount Victoria Tunnel, through the Mount Victoria tunnel and up to the intersection of Ruahine Street and Taurima Street.

**3.** Interpretation—In this bylaw, unless the context otherwise requires:

**Agency** has the same meaning as in section 2(1) of the Land Transport Act 1998.

**cycle** has the same meaning as in clause 1.6 of the Land Transport (Road User) Rule 2004.

**dangerous goods** has the same meaning as in Part 2 of Land Transport Rule: Dangerous Goods 2005.

**enforcement officer** has the same meaning as in section 2(1) of the Land Transport Act 1998.

**Highway Manager, Wellington,** means the person authorised by the Agency to give consent under clause 5.

**overdimension motor vehicle** means a motor vehicle or combination vehicle (including any load) that exceeds one or more of the dimension limits in section 4 of Land Transport Rule: Vehicle Dimensions and Mass 2002.

**pedestrian** has the same meaning as in clause 1.6 of the Land Transport (Road User) Rule 2004.

**special traffic** means a vehicle operated in a tunnel in accordance with consent given under clause 5.

**tunnel** means the Arras Tunnel, the Mount Victoria Tunnel or the Terrace Motorway Tunnel, as the case may be.

**U-turn** means to undertake a turn which involves turning from facing or travelling in one direction to facing or travelling in the opposite direction.

- **4. Classes of traffic restricted**—(1) No person may operate a vehicle that is carrying dangerous goods in a tunnel for any purpose (including for hire or reward).
- (2) Clause 4(1) does not apply if the quantity of dangerous goods does not exceed the maximum threshold specified in Schedule 1 of the Land Transport Rule: Dangerous Goods 2005 (whether or not that Schedule applies to the transport of the dangerous goods) and all relevant requirements of that Rule are complied with.
- (3) No person may operate an overdimension motor vehicle in a tunnel.
- **5. Special traffic permitted with consent**—(1) Clause 4 does not apply where a vehicle is operated in a tunnel in accordance with written consent given by the Highway Manager, Wellington.
- (2) A consent for special traffic under clause 5(1) may be given:
  - (a) in respect of any specified vehicle or class of vehicles;
  - (b) in respect of a specified occasion, or a specified period, or within specified times, or generally;
  - (c) subject to conditions that the Highway Manager, Wellington, considers appropriate in the interests of public safety, efficient traffic management or to prevent property damage, including damage to the tunnel
- (3) Where the Highway Manager, Wellington, considers it appropriate, he or she may require that:

- (a) special traffic be escorted through a tunnel by a Class 1 Pilot vehicle, an enforcement officer, or other escort;
- (b) other traffic be excluded from a tunnel while special traffic is in or near the tunnel.
- **6. Pedestrian traffic**—A pedestrian must not be within a tunnel unless:
  - (a) on the footpath of the Mount Victoria Tunnel; or
  - (b) in the tunnel to carry out maintenance authorised by the Agency; or
  - (c) as a result of any crash, breakdown or other emergency; or
  - (d) that pedestrian is an enforcement officer or a person acting with the consent or at the request or direction of an enforcement officer.
- 7. Cycles—No person may ride a cycle in a tunnel, except on the footpath of the Mount Victoria Tunnel from the intersection of Taurima Street and Ruahine Street through the Mount Victoria Tunnel to the intersection of Paterson Street and Brougham Street.
- **8.** Activity within tunnel regulated—No person may do any of the following in a tunnel, unless directed by an enforcement officer:
  - (a) Tow any vehicle other than a trailer;
  - (b) propel any vehicle by pushing it with another vehicle;
  - (c) change any tyre or wheel on a vehicle;
  - (d) repair any vehicle;
  - (e) fuel any vehicle;
  - (f) alight from any vehicle except in accordance with clause 6;
  - (g) make, or attempt to make, a U-turn;
  - (h) stop any vehicle without good cause.
- **9. Behaviour in tunnel restricted**—(1) No person may:
  - (a) remain in a tunnel after being requested to leave by an enforcement officer or member of the fire service or ambulance service;
  - (b) leave any vehicle unattended in a tunnel;
  - (c) climb on any part of a tunnel;

except where clause 6 or clause 8 applies.

- (2) Any vehicle left unattended in a tunnel will be removed by towing and the reasonable costs of the removal will be recovered from the vehicle owner.
- **10. Offences** and penalties—Without limiting any provision of any other enactment, a person who breaches clauses 4, 6, 7, 8 or 9 of this bylaw commits an offence and is liable to a fine not exceeding \$500.
- **11. Revocation**—The Transit New Zealand (Wellington Tunnels) Bylaw 2003/12: Bylaw Concerning Wellington Tunnels (*New Zealand Gazette*, 13 November 2003, No. 154, page 4319) is hereby revoked.
- **12. Savings**—Any resolution, approval, permit or other act of authority made pursuant to the bylaw referred to in clause 11 remains in force until revoked by the Agency.
- **13. Authority to make bylaw**—This bylaw was made by the Group Manager, Highway and Network Operations, under the delegated authority of the Agency.
