Pursuant to section 200A(3)(d) of the Maritime Transport Act 1994, I give notice that I have received from the Auckland Council an application to declare the Volvo Ocean Race 2011/12 Auckland Stopover to be an event to which section 200B of the Maritime Transport Act 1994 applies for the period from **5 March 2012** to **18 March 2012** inclusive, and that I intend to make a declaration to that effect by notice in the *New Zealand Gazette*.

Proposed Area Affected by the Application

The area in respect of which the application is made is defined as follows:

General Designated Area

Waitemata Harbour, bounded in the west by an approximate north/south boundary between Chelsea Wharf and Watchman Island and bounded in the east by an approximate north/south boundary between North Head and Bastion Point, and includes all navigable waters within this area.

Rangitoto Channel and the area directly to the east of the North Shore, from Bastion Point in the south, to an approximate east/west boundary in the north between Toroa Point and the point 3.5 nautical miles north-east of Torbay. Proposed Conditions and Requirements

Within the designated area defined above, the following conditions and requirements apply:

1. No vessel may enter the area known as the Viaduct Basin, except with the specific approval of the Harbourmaster, or persons acting under delegated authority from the Harbourmaster.
2. Only vessels authorised by the Ports of Auckland Port Facilities Security Manager, or the Harbourmaster, may enter the navigable waters south of a line from the northern-most point of Ferguson Wharf and extending to the northern-most point of Queens Wharf.
3. Only authorised commercial vessels, or other vessels authorised by the Harbourmaster, may enter the Auckland ferry terminal basin between Princes Wharf and Queens Wharf, and extending 50 metres north from the northern end of each wharf.
4. The Auckland Harbourmaster's Direction 3-07, which applies to the Auckland ferry terminal basin (or Down Town ferry terminal basin), applies at all times. This Direction is available at:
www.aucklandcouncil.govt.nz/SiteCollectionDocuments/services/harbourmaster/hmdirectiondowntownferryterminalbasin.pdf
5. No vessel may enter the naval defence area at Devonport, as identified in Auckland Harbour Chart NZ5322, unless authorised by the Royal New Zealand Navy.
6. All vessels are restricted to a maximum speed of 12 knots within the areas defined above, excluding vessels competing in the Volvo Ocean Race 2011/12 Auckland Stopover and fast passenger ferries on a scheduled passage, showing a flashing orange light, and where such vessels hold a written exemption from the

Harbourmaster stating where and when they may exceed 12 knots.

7. No vessel under 500 gross tonnes may impede the navigation of any vessel over 500 gross tonnes.
8. No vessel is to approach, or remain, within 50 metres of any vessel over 500 tonnes which is moored or not underway at any time.
9. The moving prohibited zone specified in the Auckland Regional Council Navigation Safety Bylaw 3.14 will apply at all times.
10. No vessel may approach within 100 metres of competing yachts.
11. The wake provisions of the Auckland Regional Council Navigation Safety Bylaw 3.25 will apply at all times. This may mean that recreational vessels will need to reduce their speed below the 12 knot maximum to comply in the vicinity of the race course in use.
12. All vessels must be navigated in accordance with Maritime Rules Part 22: Collision Prevention.
13. No person may jump, dive or swim from any wharf or structure within the permit area, unless the person has been authorised by the Harbourmaster or a member of the New Zealand Police.
14. In all areas defined above, the Auckland Council may:
 - (a) order the suspension or abandonment of racing operations if, in the opinion of the Auckland Council's Harbourmaster, adequate levels of public safety cannot be guaranteed. This power will be exercised in consultation with the New Zealand Police, the event organiser and Ports of Auckland Limited.
 - (b) specify and vary conditions and requirements for the day-to-day management and conduct of activities within each area, for the purpose of protecting the safety of the public and competing yachts.

Additional Restrictions

All vessels must comply with any temporary restrictions or directions issued by the Auckland Harbourmaster. Temporary restrictions or directions will be broadcast on VHF channel 12 as soon as practicable after the restriction or direction is issued, and every hour at approximately 15 minutes past the hour while it is in force. In addition, advice to vessels to listen to these broadcasts will be transmitted on VHF channel 16.

Proposed Hours of Operation

The proposed declaration will apply 24 hours per day for the entire period from **5 March 2012** to **18 March 2012** inclusive.

Means of Enforcement

Compliance with the above conditions and requirements will be enforced by appointed enforcement officers, as defined in section 200B(6) of the Maritime Transport Act 1994.

The enforcement officers will be identified officers of the New Zealand Police and authorised employees of the Auckland Council acting under the direction of the Auckland Harbourmaster.

The above restrictions do not apply to vessels operated by enforcement officers in their professional capacity.

Under section 200B(5) of the Maritime Transport Act 1994, any person in charge of a ship, craft or seaplane who contravenes this notice commits an infringement offence and is liable to the relevant penalty prescribed in the Maritime Transport (Infringement Fees for Offences Relating to Major Maritime Events) Regulations 1999.

Notification of Proposal to Make Ordinary Rules

In accordance with section 34(1)(a) of the Civil Aviation Act 1990, the Minister of Transport hereby gives notice of his intention to make the following ordinary Civil Aviation Rules:

The purpose of this rule-making proposal is to improve protection from aviation security threats affecting the travelling public.

The proposal addresses strengthening flight deck barriers on aircraft of more than 30 passenger seats including those that operate domestically; the establishment of security committees at airports that service regular air transport passenger services on aircraft of 19 or more passenger seats; enhancing the education and training for airline and airport staff; vehicle security identification systems; security controls for international transit operations; and operations under the Australia New Zealand Aviation (ANZA) Mutual Recognition Principle.

Commerce Act 1986

Notification of Transpower Capital Expenditure Input Methodology Determination

Pursuant to section 52W of Part 4 of the Commerce Act 1986 (“the Act”), the Commerce Commission (“the Commission”) gives the following notice.

On 31 January 2012, the Commission made the Transpower Capital Expenditure Input Methodologies Determination (“the Determination”) as required by section 54S of the Act.

The Determination sets out a capital expenditure input methodology that specifies the process for Transpower to submit, and the Commission to approve, Transpower’s capital expenditure proposals.

The Determination comes into force on the day following the date of publication of this notice.

Nature of the Input Methodology and the Goods or Services to Which it Applies

The Determination applies to the supply by Transpower of “electricity lines services”, as defined in section 54C of the Act, under Transpower’s individual price-quality path determined in accordance with Part 4, subpart 7 of the Act.

In summary:

- (a) Capital expenditure must be classified as either base capital expenditure (“Base capex”) or major capital expenditure (“Major capex”).
- (b) The Determination will apply to all capital expenditure intended to enter Transpower’s Regulatory Asset Base (RAB), including both Base and Major capex.
- (c) Transpower must consult with interested parties on Major capex projects, which must be assessed and approved by the Commission on a project-by-project basis using the requirements set out in the Transpower capital expenditure input methodology (“Capex IM”).
- (d) Transpower cannot substitute any Major capex between individual Major capex projects or to Base capex.
- (e) Base capex must be approved in advance of each regulatory period.
- (f) Transpower may substitute Base capex between years and across categories.
- (h) An incentive regime will apply to both Base capex and Major capex.
- (i) Transpower must publish an integrated transmission plan that explains Transpower’s view about the long-term development of the grid.

- (j) Transpower must consider transmission alternatives in its development of all Major capex proposals.
- (b) The Capex IM will not usually apply to capital expenditure relating to either new investment contracts or the System Operator Service Provider Agreement.

Reasons for Determining the Input Methodologies

The reasons for determining the capital expenditure input methodology are set out in detail in the *Transpower Capital Expenditure Input Methodology Reasons Paper*, 27 January 2012.

The key reasons for the input methodology are:

- (a) The difference in nature, timing and magnitude of base and major capital expenditure is such that a different approval process is appropriate.
- (b) Given the importance of the RAB in determining Transpower's revenues, all capital expenditure entering the regulatory asset base should be subject to the requirements of the Capex IM.
- (c) Transpower must consider the trade-off between transmission alternatives and capital expenditure because making use of transmission alternatives may be an economically efficient decision where it avoids or defers expenditure on transmission investment.
- (d) Allowing substitution of expenditure within one Major capex project to another would distort the effectiveness of the approval process and the incentives that are applied on a project specific basis.
- (e) Incentive mechanisms will encourage downward pressure on costs, as well as consideration of non-transmission solutions.
- (f) Requiring Transpower to provide an integrated transmission plan will help stakeholders assess Base capex and Major capex proposals. The purpose of the integrated transmission plan is to explain Transpower's view of the long-term operation and development of the grid.
- (g) The Commission will not interpose itself between Transpower and its contract counterparties by requiring the revenue associated with New Investment Contracts to be subject to an individual price-quality path, provided certain conditions are met around workable competition.

Explanatory Note

The Electricity Industry Act 2010 introduced section 54S to the Commerce Act 1986 ("the Act"), which requires the Commission to determine an input methodology for capital expenditure proposals made by Transpower New Zealand Limited ("Transpower"). The purpose of input methodologies is to promote certainty for suppliers and consumers in relation to the rules, requirements and processes applying to the regulation of goods or services under Part 4 of the Act.

The purpose of Part 4, as set out in section 52A of the Act, is to promote the long-term benefit of consumers in markets where there is little or no competition and little or no likelihood of a substantial increase in competition, by promoting outcomes that are consistent with outcomes

produced in competitive markets such that suppliers of regulated goods or services:

- (a) *have incentives to innovate and invest, including in replacement, upgraded, and new assets; and*
- (b) *have incentives to improve efficiency and provide services at a quality that reflects consumer demands; and*
- (c) *share with consumers the benefits of efficiency gains in the supply of the regulated goods or services, including through lower prices; and*
- (d) *are limited in their ability to extract excessive profits.*

The electricity lines services provided by Transpower are regulated under an individual price-quality path, which applies from 1 April 2011. The Commission's determination in December 2010 that set the price-quality path was required to include reference to the input methodologies that Transpower is required to apply. This included provision for an input methodology for capital expenditure approvals that would be determined and applied to Major capital expenditure projects during the first regulatory period.

The Act requires the Commission to set an input methodology for Transpower's capital expenditure proposals that includes:

- (a) *requirements of Transpower with respect to information and consultation;*
- (b) *the criteria the Commission will use in evaluating the proposals; and*
- (c) *the timeframes and processes for the Commission to evaluate the proposals, and any consequences for not meeting those timeframes.*

The new capital expenditure input methodology replaces the existing approval process for capital expenditure, which currently follows the Electricity Governance Rules 2003.

The Capex IM Determination provides an integrated approach to the development and approval of Transpower's investment in the national grid. It is a methodology for reviewing and approving Transpower's capital expenditure proposals. New incentive mechanisms will provide Transpower with an incentive to invest and to deliver improved performance in terms of outputs and cost efficiency.

The approval procedures and incentive mechanisms applying to Major capital expenditure proposals by Transpower apply from the date of commencement of the Capex IM Determination. Under the Act, Transpower's individual price-quality path may not be changed except in accordance with the Act and the Commerce Act (Transpower Input Methodologies) Determination 2010. The procedures and incentives applying to minor capital expenditure projects may therefore only apply with effect from the next regulatory period commencing on 1 April 2015.

Notification of Amendment of the Commerce Act (Transpower Individual Price-Quality Path) Determination 2010

Pursuant to section 52Q(5)(b) of Part 4 of the Commerce Act 1986 ("the Act"), the Commerce Commission ("the Commission") gives the following notice.

On 31 January 2012, the Commission made an amendment ("the Amendment") under section 52Q of Act to the Commerce Act (Transpower Individual Price-Quality Path) Determination 2010, Decision 714 ("the Determination").

The Amendment includes minor drafting changes to the Determination to assist with interpretation and application of the individual price-quality path in accordance with the new approval process for Transpower capital expenditure set out in the Transpower Capital Expenditure Input Methodology Determination ("Capex IM determination").

The Amendment makes the following changes to the Determination:

- (a) Updates Transpower's quality reporting requirements for planned and unplanned interruptions, aligning the reporting with the Electricity Information Disclosure Regulations;
- (b) removes references to the old approval process for major capital expenditure, as those provisions are now redundant in light of the new Capex IM Determination approval process;
- (c) clarifies the actual v forecast MAR wash-up to make it easier to follow in light of the new Capex IM Determination approval processes;
- (d) adjusts major and minor capex expenditure where a minor capital expenditure becomes approved as a major capital expenditure so that there is no unintended double-recovery or non-recovery; and
- (e) gives effect to the "at risk" conditions that affect the major capital expenditure approved in accordance with the Commission's Capex IM Determination, which provides for a reduced recovery where conditions attached to the approval are not met.

These changes do not alter the price-quality path, as the new approval process is in accordance with the Act and the applicable input methodologies.

The Amendment is effective on the day following the date of publication of this notice.
