The above provisions make “rules of origin” changes applicable to imports from Australia (under the ANZCERTA), Hong Kong, China and Malaysia that are the subject of claims for preferential tariff treatment upon entry to New Zealand.

These changes follow one of the World Customs Organisation’s periodic (every five or six years) review of the Harmonized System Commodity Description and Coding System (HS).

As a signatory to the HS Convention, New Zealand is obliged to make certain changes to product-specific rules of origin because our rules of origin are linked to the product numbering and descriptions in the HS.

Ministerial Direction on Compulsory Student Services Fees for 2012

Pursuant to sections 227A(1) and 235D(1) of the Education Act 1989, I give the following direction to institutions and registered private training establishments (together referred to in this direction as “providers”):

Objective

1. The objective of the direction is to ensure accountability in the use of compulsory fees for student services.

Coverage

2. All providers that charge a compulsory student services fee to domestic students must comply with the provisions of this direction.

Effective date

3. Providers must give effect to this direction as soon as reasonably practicable after 1 January 2012 and by no later than 1 July 2012.

Decision-making

4. Providers must establish adequate arrangements for decisions to be made jointly, or in consultation with the students enrolled at the provider, or their representatives, on the following matters:
 - (a) the maximum amount that students may be charged for student services; and
 - (b) the types of services to be delivered (within the categories set out under paragraph 8 of this direction); and
 - (c) the procurement of these services; and
 - (d) the method for authorising expenditure on these services.

Accounting for the use of compulsory student services fees

5. Providers must either hold compulsory student services fees in a separate bank account, or ensure that all income and expenditure associated with the provision of such services is separately accounted for in the provider’s accounting system.

Reporting on compulsory student services fees

6. Institutions must include a description of the services funded out of the compulsory student services fee and a statement of the fee income and expenditure for each type of student service in their annual report.
7. Registered private training establishments must provide students with a written report, describing the services that have been funded out of the compulsory student services fee and a statement of the fee income and expenditure on each type of student service.

8. Providers may charge compulsory student services fees to support the delivery of the following categories of services:

The following notice is given pursuant to section 50 of the Public Trust Act 2001 ("the Act").

Notice

1. Title and commencement—(1) This notice may be cited as the Public Trust Common Fund Interest Rates Notice 24 November 2011.

(2) Unless otherwise specified, the determinations and revocation in this notice take effect from and including 23 November 2011.

2. Interpretation—(1) Unless the context otherwise requires:

"agency deposit" means a deposit (not being an investment deposit) held as agent or attorney;

"call deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call;

"deposit" means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;

"investment deposit" means a deposit held at call or otherwise as an investment under section 51 of the Act;

"protection deposit" means a deposit, held at call, of tuition, boarding, accommodation or other fees by or on behalf of a student enrolled at a private training establishment within the meaning of Part 18 of the Education Act 1989;

"special deposit" means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

"trust deposit" means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

3. Rates of Common Fund interest—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.

(3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.

(4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(5) Despite subparagraphs (1), (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on investment deposits, protection deposits or special deposits that is different from the rate specified in Schedules 1, 2, or 3 and the agreed rate then applies.

4. Revocation of notice and transitional provisions—

(1) The Public Trust Common Fund Interest Rates Notice 17 November 2011 is revoked.

(2) Unless otherwise specified, the rates of interest specified in Schedules 1 and 2 to this notice do not apply to any period that ends with 22 November 2011 but otherwise operate as from 23 November 2011.

(3) The rates of interest specified in Schedule 3 to this notice:

- (i) do not apply to investment deposits repayable at the end of a fixed term that commenced prior to 23 November 2011; but
- (ii) do apply to investment deposits repayable at the end of a fixed term that commenced on or after 23 November 2011.

Research, Science, and Technology Act 2010

Criteria for the Assessment of Proposals for Capability in Independent Research Organisations Funding by the Science Board

Pursuant to the Research, Science, and Technology Act 2010, this notice should be read in conjunction with the Establishment of Innovation Board and Science Board and Other Related Notices Supplement to the *New Zealand Gazette*, 31 January 2011, No. 9, page 177.

1. Notice to the Science Board

In this notice, I set the criteria for the assessment by the Science Board ("the Board") of proposals for *Capability in Independent Research Organisations* funding.

2. Investment Tool

2.1 The *Capability in Independent Research Organisations* funding tool sits within the Long-term Non-contestable funding tool.

2.2 However, the criteria for Long-term Non-contestable funding set out in the Supplement at page 195, do not apply in respect of proposals for *Capability in Independent Research Organisations* funding.

3. Policy Objective

The policy objective of the *Capability in Independent Research Organisations* funding tool is to fund research, science and technology and related activities, and to support capability in the non-Crown Research Institute and non-Tertiary Education Institute sector that has the potential to:

- (a) contribute to major economic, environmental, or social benefits for New Zealand; or
- (b) contribute to the mitigation of major risks to New Zealand's economy, environment, or society that the Government has a role in mitigating.

4. Eligibility Criteria

4.1 The Board must assess all proposals for *Capability in Independent Research Organisations* funding against the following eligibility criteria:

- (a) The proposal must be made by an Independent Research Organisation, which for the purposes of this notice is an organisation that:
 - (i) is not funded by a commodity or industry levy; and
 - (ii) operates as an independent legal entity and is not owned, recently established, or primarily funded by a Crown Research Institute, a Tertiary Education Institute, or a business; and
 - (iii) primarily carries out scientific research, development, or technology transfer activities that are not for the development of its own products and services; and
 - (iv) has a unique R&D capability that is not duplicated elsewhere; and
 - (v) has staff and equipment of a sufficient scale and capacity to carry out the proposal; and
 - (vi) has demonstrated that it has linkages with end users of its research, which may include industry users and the public sector;
- (b) the organisation must be currently receiving Vote Science and Innovation funding, and have been receiving that funding for more than one contestable funding cycle. This can include funding that an organisation receives via a sub-contract that it has with an organisation that receives Vote Science and Innovation funding.

4.2 If an organisation does not meet the criteria in clause 4.1(a)(i), the Board may nevertheless determine that the organisation is eligible if the organisation has a unique R&D capability of national importance, but is unable to be supported adequately by the income generated by the levy.

5. Judgement Criteria

The Board must assess all proposals that meet the eligibility criteria against the following judgement criteria:

- (a) The proposal must benefit New Zealand by contributing to the achievement of beneficial economic, social, or environmental outcomes;
- (b) the proposal must demonstrate a pathway to application, which means that the proposal must demonstrate that the organisation will engage with users and that it is likely that the research will be taken up by research users;
- (c) the persons involved in the proposal must have the ability to deliver research results (outputs), taking into account the track record of those persons and the involvement of appropriate collaborators;
- (d) the proposal must be of high research quality, which means that the proposed team must be of sufficient size and capacity, and the proposal must support building or maintaining capability to achieve strategic outcomes that would be difficult to replace if lost.

6. Weightings

The Board must apply the following weightings to the judgment criteria:

| Ability to deliver research results (outputs) | 20% |

7. Other Criteria

7.1 In assessing proposals for *Capability in Independent Research Organisations* funding, the Science Board must:

- (a) make funding decisions that are consistent with the Public Finance Act 1989 and the relevant vote administered by the Ministry of Science and Innovation; and
- (b) take into account the relevant Sector Investment Plans (if any).

7.2 The Board may allocate funding for proposals for *Capability in Independent Research Organisations* funding from any one of the following output expenses:

- (a) Biological Industries Research
- (b) High Value Manufacturing and Services Research
- (c) Energy and Minerals Research
- (d) Environmental Research
- (e) Hazards and Infrastructure Research
- (f) Health and Society Research (except that funding that is administered by the Health Research Council may not be allocated to such proposals).

7.3 The Board may approve proposals for funding for up to seven years, at which time the contracts will be reviewed and renegotiated, subject to a successful review and subject to the organisation meeting the eligibility criteria in this notice.
