Social Security Act 1964**Maximum Contribution Applying in Each Territorial Local Authority Region from 1 October 2014**

Under section 152 of the Social Security Act 1964, the Director-General of Health is required to notify the maximum contribution that applies in each region for long-term aged residential care.

The maximum contribution is the maximum weekly amount (inclusive of GST) that a resident assessed as requiring long-term residential care (through a needs assessment and service coordination agency) is required to pay for contracted care services provided to them in the region in which their rest home or continuing care hospital is located.

The maximum contribution is the same for all residents regardless of the type of contracted care services they receive. It is equivalent to the rest home contract price applying to residential care facilities in each territorial local authority region.

The maximum contribution set by this notice applies from **1 October 2014** and replaces the previous maximum contribution notice published in the *New Zealand Gazette*, 19 June 2014, No. 65, page 1857.

The daily GST exclusive contract price for rest home services has been increased by 5%, GST has been added and the result has been multiplied by seven to determine the new maximum contribution. The calculations are rounded to two decimal places at each step.

Inquiries Act 2013

Establishment of the Government Inquiry into Allegations Regarding The Honourable Judith Collins and a Former Director of the Serious Fraud Office

Pursuant to section 6(3) of the Inquiries Act 2013, I, The Right Honourable John Key, Prime Minister, hereby establish the Government Inquiry into Allegations Regarding The Honourable Judith Collins and a Former Director of the Serious Fraud Office ("Inquiry").

Background

The Cabinet Manual provides that a Minister of the Crown is, at all times, expected to act lawfully and to behave in a way that upholds, and is seen to uphold, the highest ethical standards.

Ultimately, Ministers are accountable to the Prime Minister for their behaviour (Cabinet Manual para 2.53).

There are recent allegations that, during her time as Minister of Police with responsibility for the Serious Fraud Office, The Honourable Judith Collins acted inappropriately to undermine the then Director of the Serious Fraud Office, Adam Feeley.

I have determined that a Government Inquiry with full powers of inquiry under the Inquiries Act 2013 should be held into these allegations.

Membership

The Honourable Lester Hugh Chisholm, CNZM, is appointed to and constitutes the Inquiry.

Terms of Reference

This Inquiry will inquire into and report upon allegations that The Honourable Judith Collins was involved in efforts to undermine Adam Feeley during his tenure as Director of the Serious Fraud Office, including whether:

- (1) there is any evidence Judith Collins acted inconsistently with the conduct expected of a Minister by undermining or attempting to undermine Adam Feeley's tenure as Director of the Serious Fraud Office; and

- (2) Judith Collins provided information about Adam Feeley during his tenure as Director of the Serious Fraud Office to Cameron Slater or any other party who did not have a proper entitlement to receive such information; and
- (3) Judith Collins inappropriately sought or received information about Adam Feeley from Cameron Slater or any other party; and will
- (4) identify and report on any other issues relevant to the above matters, to the extent necessary to provide a complete report on those matters.

Reporting

The Inquiry is to report findings and opinions to the Prime Minister in writing no later than **28 November 2014**.

Consideration of Evidence

The Inquiry may begin considering evidence on **12 September 2014**.

(2) An Amateur Jockey may bet or have any interest in a bet, or facilitate a bet, on any Race, or any contingency which includes or relates to any Race other than any such Race in which he or she is riding. For the purpose of this Rule, the reference to bet includes Laying any horse.

(3) A Rider shall upon request by a Stipendiary Steward or Investigator, supply written or electronic records of all bets made through that Rider's betting accounts, including written or electronic records of that Rider's mobile phone and other electronic communication devices.

(4) For the purpose of Rule 801(t), any breach of this Rule 707 is deemed to be a Serious Racing Offence.
