### Proposed conditions to be attached to Student Achievement Component Funding (SAC) allocated and paid for by the Tertiary Education Commission (TEC) to Tertiary Education Organisations (TEOs)

#### General

1. These conditions apply to fees charged for SAC funded provision in all TEOs.

2. The fees associated with a particular course are subject to these conditions if:

(a) the TEO is the sole source of the item to which the fee relates; and

(b) all domestic students validly enrolled in the course are required to pay the fees.

#### Annual Maximum Fee Movement (AMFM)

3. For 2016, the AMFM is a 3% increase on the fees (GST exclusive) charged in 2015 for a course at Level 3 and above on the New Zealand Qualifications Framework (NZQF) for which a TEO receives SAC funding.

4. The AMFM applies to any new courses at Level 3 and above on the NZQF established by a TEO in substitution for an existing course dealing with the same or similar subject matter, at a same or similar level on the NZQF, for which SAC funding can be used.

*Exceptions to the AMFM*

5. A TEO may apply for an exception from the 2016 AMFM for a SAC-funded course that is part of a programme that leads to a qualification at Level 3 or above on the NZQF on the basis of exceptional circumstances. Any exception granted will not exceed an additional 3% increase over and above the permitted 3% increase.

6. In considering exceptional circumstances, the TEC must only have regard to the following criteria:

- (a) the TEO is unable to support the course(s) while remaining financially viable;
- (b) for courses at Levels 3–8 on the NZQF, the completion rate for the qualification met or exceeded the median performance benchmark for that level in the previous year;
- (c) the TEO can demonstrate that the course is in some way unique or special, for example, that there are no available local alternatives to the course; and
- (d) not allowing an exception will prevent the TEO from making a significant contribution to the achievement of one or more of the Government’s priorities, as set out in the Tertiary Education Strategy 2014–2019.

7. An application must satisfy all criteria to gain an exception.

*Low or Zero Fee Courses*

8. If the fees for a SAC-funded course that is part of a programme that leads to a qualification at Level 3 or above on the NZQF are less than \$511.11 (GST inclusive) (\$444.44 (GST exclusive)) per Equivalent Full-Time Student (EFTS) in 2015, then for 2016, the TEO may increase the fee to up to \$511.11 (GST inclusive) (\$444.44 (GST exclusive)) per EFTS, or can increase the fee for the course by 3%, whichever is the greater.

*Fees for SAC Funded Level 1 and 2 Provision*

9. Conditions on fees for courses that are at Levels 1 or 2 on the NZQF and funded under the SAC Qualifications at Levels 1 and 2 of the NZQF (competitive allocation) funding mechanism, are detailed in the Tertiary Education Fees-Free Conditions Notice 2015.

10. Conditions on fees for students aged under 25 years old enrolled in courses that are at Levels 1 or 2 on the NZQF funded through the SAC Provision at Levels 1 and 2 on the NZQF (non-competitive allocation) funding mechanism, are detailed in the Tertiary Education Fees-Free Conditions Notice 2015.

11. For all other SAC funded provision at NZQF Levels 1 and 2 that is delivered under the non-competitive allocation process, a TEO may not charge a higher fee for any course in 2016 than it charged for the same course the last time that course was offered.

## **2015 Review of Intelligence and Security Agencies**

Under section 22 of the Intelligence and Security Committee Act 1996 ("the Act"), the Acting Attorney-General, Hon Amy Adams, has appointed Hon Sir Michael John Cullen, knzm, and Dame Patricia (Patsy) Lee Reddy, dnzm, to carry out a review of the intelligence and security agencies, the legislation governing them, and their oversight legislation.

The Acting Attorney-General has specified, under section 22(3)(c) of the Act, that the review is to be concluded by 29 February 2016.

Under section 22(3)(a) of the Act, the Acting Attorney-General has specified the following terms of reference for the review.

### *Terms of reference*

The purpose of the review, taking into account that subsequent reviews must occur every 5-7 years, is to determine:

1. Whether the legislative frameworks of the intelligence and security agencies - the Government Communications Security Bureau (GCSB) and New Zealand Security Intelligence Service (NZSIS) - are well placed to protect New Zealand's current and future national security, while protecting individual rights; and
2. whether the current oversight arrangements provide sufficient safeguards at an operational, judicial and political level to ensure the GCSB and NZSIS act lawfully and maintain public confidence.

The review will have particular regard to the following matters:

3. Whether the legislative provisions arising from the Countering Foreign Terrorist Fighters Legislation Bill,

- which expire on 31 March 2017, should be extended or modified;
4. whether the definition of “private communication” in the legislation governing the GCSB is satisfactory; and
  5. any additional matters that arise during the review as agreed by the Acting Attorney-General and notified in writing in the *New Zealand Gazette*.

Under section 22(3)(b) of the Act, the Acting Attorney-General specifies that, when determining how to conduct the review, the reviewers will take into account:

6. the need to ensure that a wide range of members of the public have the opportunity to express their views on issues relating to the review;
7. the need for the law to provide clear and easily understandable parameters of operation;
8. the Law Commission’s work on whether current court processes are sufficient for dealing with classified and security sensitive information;
9. previous relevant reviews and progress towards implementing their recommendations;
10. relevant overseas reviews to identify best practice in areas relevant to this review, including oversight arrangements; and
11. that traditionally, signals and human intelligence have been carried out separately and the Government does not intend to consider merging those functions within a single agency.

## **Medicines (Designated Prescriber - Dietitians) Notice 2015**

Pursuant to the Medicines (Designated Prescriber - Dietitians) Regulations 2015 made under the Medicines Act 1981, the Dietitians Board of New Zealand ("Board") gives the following notice.

### **Notice**

**1. Title and commencement**—This notice is the Medicines (Designated Prescriber - Dietitians) Notice 2015 and comes into force 3 August 2015.

**2. The purpose**—The Schedule to this notice sets out the requirements that the Board has determined must be met by registered dietitians who wish to prescribe a dietetic prescription medicine. These requirements are imposed under Regulation 5 of the Medicines (Designated Prescriber - Dietitians) Regulations 2015.

### **Schedule**

#### **A. Requirements for Prescribing (Regulation 6)**

The Board requirements for education and training that Registered Dietitians must undertake before commencing prescribing are as follows:

- a. A Master of Dietetics degree (University of Otago) or Master of Science (Nutrition and Dietetics) degree (Massey University) or Master of Health Sciences in Nutrition and Dietetics degree (University of Auckland), conferred after January 2014; or
- b. for all other New Zealand registered dietitians the successful completion of the Dietitians Board Prescriber Training Course - consisting of an online course and a face to face workshop with a summative assessment which demonstrates knowledge to safely prescribe dietetic prescription medicines and knowledge of the regulatory framework for prescribing.

#### **B. Other training to be undertaken (Regulation 7)**

Registered dietitians who prescribe must:

- a. be in an ongoing supervised prescribing relationship and advise the Board of their supervision arrangements; and
- b. include prescribing and prescribing related developments as part of their continuing professional development; and
- c. complete the Board's online Annual Prescriber Update on an annual basis.

**C. Continuing Competency (Regulation 8)**
