 - (d) one permanent member of the professional (general) staff of Massey University appointed by the Council following an election (conducted in accordance with Statutes made by the Council) by the permanent members of that staff;
 - (e) one member who must be appointed following an election (conducted in accordance with Statutes made by the Council) by students enrolled at Massey University; and
 - (f) up to four members appointed by the Massey University Council on the nomination of the Vice-Chancellor in accordance with Statutes established under section 171C of the Education Act 1989 that will ensure that at least one of these members shall be Māori.
3. The term of office of members of the Council, vacation of office, disclosure of members’ interest and casual vacancies are covered in sections 173–176 of the Education Act 1989.
4. Subject to section 173, the maximum number of occasions on which a person, other than the Vice-Chancellor, may be appointed as a member of the Council is the number that, for that person, ensures that the total period for which they are a member of the Council does not exceed 12 years.
5. No act or proceeding of the Massey University Council shall be invalidated by the vacancy in the membership thereof, or by any other matter referred to in section 171F of the Education Act 1989.

 - (d) one person being a permanent member of the academic staff of the University of Auckland elected by the permanent members of that staff;
 - (e) one person being a permanent member of the professional staff of the University of Auckland elected by the permanent members of that staff;
 - (f) one person being the person elected by the student body to be President of the Auckland University

Students' Association Inc or its successor association;

(g) one person being an alumnus of the University of Auckland appointed by the Council following a call for expressions of interest from alumni; and

(h) two persons able to provide skills specified by the Council to be appointed by the University of Auckland Council following a call for expressions of interest.

4. Prior to calling for nominations or expressions of interest, the Council shall publish a statement of the skills and experiences it is seeking from members to be so appointed.

5. With the exception of the Vice-Chancellor, each person may be appointed, elected or co-opted as a member of the Council under the foregoing provisions for any period of not more than four years, and for no more than three such periods. In such cases where a person is a member of the Council on 31 December 2015, and has not completed their current term, they may serve up to four periods of no more than four years each.

Direction by the Minister Responsible for the Earthquake Commission to the Earthquake Commission Pursuant to Section 103 of the Crown Entities Act 2004 - Natural Disaster Fund Investment Policies

1. Under section 103 of the Crown Entities Act 2004 and in accordance with section 12 of the Earthquake Commission Act 1993 (“Act”), the Minister Responsible for the Earthquake Commission (“Minister”) directs the Earthquake Commission (“Commission”) to give effect to government policy as specified in this direction (“direction”).
2. This direction comes into effect on 27 July 2015 (“Commencement Date”).
3. On the Commencement Date, the direction issued by the Minister to the Commission on 30 October 2001 under section 12 of the Act (as subsequently amended) is revoked, except as provided for in paragraphs 10 and 11 of this direction.

Purpose

4. The purpose of this direction is to ensure the Commission invests the Natural Disaster Fund (“Fund”) conservatively and maintains its liquidity to meet claims in the aftermath of the Canterbury earthquake sequence.
5. Prior to making the direction, the Minister consulted with the Commission.

Investment Policies

6. The Fund’s investments must comprise any or all of the following (“Portfolio Composition”):
 - a. Treasury bills, Government nominal bonds and Government inflation indexed bonds (“New Zealand Government Securities”), such New Zealand Government Securities to be traded only through the New Zealand Debt Management Office; and
 - b. New Zealand bank securities, including New Zealand bank bills and deposits, held only in banks which (“New Zealand Bank Securities”):

- i. are registered under the Reserve Bank of New Zealand Act 1989;
 - ii. have a short term credit rating of A-1, Prime 1 or higher; and
 - iii. if rated by both the Moody's and Standard & Poor's credit rating agencies, ratings from both which equal or exceed the foregoing ratings.
7. Funds invested in New Zealand Bank Securities shall be held across a number of banks.
8. The Commission shall invest the Fund with the objective of achieving an average rate of return of at least the rate of change in the ANZ 90-day Bank Bill Index (or any successor to that index) for each financial year less 25 basis points per annum.
9. The Commission must invest the Fund on a prudent, commercial basis, and in doing so, must manage and administer the Fund in a manner consistent with:
 - a. best practice portfolio management;
 - b. maximising return without undue risk to the Fund as a whole; and
 - c. avoiding prejudice to New Zealand's reputation as a responsible member of the world community.
10. Subject to paragraph 11, the Commission must continue to adhere to the Statement of Investment Policies, Standards, and Procedures ("SIPSP") for the Fund, prepared pursuant to the direction issued by the Minister to the Commission on 30 October 2001 under section 12 of the Act.
11. Subject to paragraph 14, and as soon as practicable after the Commencement Date, the Commission must review and, if necessary, amend the SIPSP to ensure it satisfies the requirements of this direction.
12. The Commission must review the SIPSP on one or more occasions in each financial year.
13. The SIPSP must address or outline the following matters:
 - a. The classes of investments in which the Fund is to be invested and the selection criteria for investments within those classes;
 - b. the determination of benchmarks or standards against which the performance of the Fund as a whole, and classes of investments, will be assessed;
 - c. standards for reporting the investment performance of the Fund;
 - d. ethical investment for avoiding prejudice to New Zealand's reputation as a responsible member of the world community;
 - e. the balance between risk and return in the overall Fund portfolio;
 - f. the fund management structure;
 - g. the use of options, futures, and other derivative financial instruments;
 - h. the management of credit, liquidity, operational, currency, market, and other financial risks;
 - i. the retention, exercise, or delegation of voting rights acquired through investments;
 - j. the method of, and basis for, valuation of investments that are not regularly traded at a public exchange;
 - k. prohibited or restricted investments or any investment constraints or limits; and
 - l. any other matters the Commission considers relevant to the SIPSP.
14. The Commission must consult with the Minister if it intends to modify the SIPSP to any substantive degree.
15. The Commission must consult with the Minister before it modifies the Portfolio Composition.
16. The Commission must not cover its pre-disaster currency exposures through a hedging strategy without the Minister's approval.
17. Should the net assets of the Fund decrease to less than \$200 million, the Commission must notify the Minister of this fact as soon as practicable after the occurrence of this event.
18. In the event of a natural disaster likely to involve claims on the Commission in excess of \$250 million, the Commission must consult with the Minister before liquidating any part of the investment portfolio of the Fund apart from the holdings of New Zealand bank bills.
19. If the Commission considers at any time that any provision in this direction is inconsistent with another provision in this direction or any other direction under section 12 of the Act or any provision under that Act it shall advise the Minister of that inconsistency.

Ministerial Exemptions Under the Anti-Money Laundering and Countering Financing of Terrorism Act 2009

In accordance with section 157(6)(b) of the Anti-Money Laundering and Countering Financing of Terrorism Act 2009 (“the Act”), the Associate Minister of Justice hereby gives notice that he has granted the following exemption from the Act:

Ministerial Exemption: Goldman Sachs New Zealand Limited

1. In my capacity as the Associate Minister of Justice and pursuant to section 157 of the Anti-Money Laundering and Countering Financing of Terrorism Act 2009 (“the Act”), I exempt the GSNZ Reporting Entities (as that term is defined in 2 below) from section 56(2) of the Act, in so far as the Anti-Money Laundering and Countering Financing of Terrorism (AML/CFT) compliance officer must be an **employee** of the reporting entity.
2. “**GSNZ Reporting Entities**” means:
 - a. Goldman Sachs New Zealand Limited; and
 - b. each company incorporated in New Zealand which is:
 1. directly or indirectly a wholly-owned subsidiary of Goldman Sachs New Zealand Limited; and
 2. a reporting entity under the Act.
3. This exemption is made subject to the following conditions, which apply to each GSNZ Reporting Entity relying on this exemption:
 - a. the AML/CFT compliance officer of the GSNZ Reporting Entity must be a Sydney-based employee of Goldman Sachs Holdings ANZ Pty Limited (or a wholly-owned subsidiary of Goldman Sachs Holdings ANZ Pty Limited).
 - b. The AML/CFT compliance officer must administer and maintain the AML/CFT programme of the GSNZ Reporting Entity.
 - c. The AML/CFT compliance officer must be appropriately qualified, have adequate resources to perform his or her role, and have full access to all information relevant to the AML/CFT compliance affairs of the GSNZ Reporting Entity.
 - d. The AML/CFT compliance officer must report regularly and fully on all relevant AML/CFT compliance matters to a senior manager of the GSNZ Reporting Entity.
 - e. The staff of the GSNZ Reporting Entity must have ready access to the AML/CFT compliance officer in order to raise and discuss AML/CFT compliance-related matters.
4. This exemption has been granted as there are low risks of money laundering and terrorist financing associated with this specific exemption. It will allow the GSNZ Reporting Entities to use existing Australasian compliance expertise, within related Goldman Sachs entities, to assist in their compliance with their New Zealand AML/CFT obligations.
5. All other provisions and requirements of the Act will apply to the GSNZ Reporting Entities.

6. This exemption comes into force on the day after the date I grant this exemption (**28 July 2015**). This exemption will expire on **30 June 2018**, and/or if the conditions of the exemption are breached.
