## Notice of the Electricity Industry Participation Code Amendment (Transmission Pricing) 2015

1. Under section 38(3)(b) of the Electricity Industry Act 2010, and having complied with section 39 of that Act, the Electricity Authority gives notice of making the Electricity Industry Participation Code Amendment (Transmission Pricing) 2015 (“amendment”).
2. The amendment comes into force on **1 April 2017**.
3. The amendment is the result of a review of the transmission pricing methodology in Schedule 12.4 of the Electricity Industry Participation Code (“Code”). The review was initiated by Transpower under clause 12.85 of the Code.
4. The amendment changes the definition of regional peak demand periods so that the calculation of the periods for the Upper North Island and the Upper South Island regions is based on the 100 highest regional

demands in the relevant capacity measurement period. This means that the calculation of regional peak demand periods for all four regions will be based on the 100 highest regional demands. The description of each region has also been clarified.

5. The amendment changes the definition of capacity measurement period for the purpose of determining regional peak demand periods, so that summer trading periods are excluded for the Lower South Island, Lower North Island, and Upper North Island regions.
6. HVDC charges (charges for the HVDC link) will continue to be paid by South Island generators. The amendment provides for a transition from the current HAMI-based charge to a charge based on the total injection by each South Island generator at each South Island generation connection location, averaged over five years.
7. Finally, the amendment requires Transpower to make adjustments to minimise the effect on transmission charges of reverse flow that occurs as a result of a GXP tie.

  - (a) Subject to clause 5(b), appointments to the Council, other than of the Vice-Chancellor, shall be for not less than one year and not more than four years. The number of occasions on which a person may be appointed as a member of the Council is the number that, for that person, ensures that the total period for which they are a member of the Council does not exceed 12 years.
  - (b) Any person who is a member of the Council at the date of this notice may be appointed on the number of occasions provided for in clause 5(a) or the number of occasions which allows them to remain on the Council until 31 December 2017, whichever is the greater.

**2. Interpretation**—(1) Unless the context otherwise requires:

“investment deposit” means a deposit held at call or otherwise as an investment under section 51 of the Act;

“protection deposit” means a deposit, held at call, of tuition, boarding, accommodation or other fees by or on behalf of a student enrolled at a Private Training Establishment within the meaning of Part 18 of the Education Act 1989;

“special deposit” means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

“trust deposit” means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Rates of Common Fund interest**—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular Private Training Establishment shall be that specified in Schedule 2.

(3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall

be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.

(4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(5) Despite subparagraphs (1), (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on investment deposits, protection deposits or special deposits that is different from the rate specified in Schedules 1, 2, or 3 and the agreed rate then applies.

**4. Revocation of notice and transitional provisions**—(1) The Public Trust Common Fund Interest Rates Notice 11 August 2015 is revoked.

(2) Unless otherwise specified, the rates of interest specified in Schedules 1 and 2 to this notice do not apply to any period that ends with 24 August 2015 but otherwise operate as from 25 August 2015.

(3) The rates of interest specified in Schedule 3 to this notice:

(i) do not apply to investment deposits repayable at the end of a fixed term that commenced prior to 25 August 2015; but

(ii) do apply to investment deposits repayable at the end of a fixed term that commenced on or after 25 August 2015.
