### Open Season for Game in Fish and Game Regions

#### Wildlife Act 1953

#### Wildlife Regulations 1955

#### New Zealand Game Bird Habitat Stamp Regulations 1993

Under sections 15 and 16 of the Wildlife Act 1953, the Minister of Conservation declares an open season for game in the Fish and Game regions, subject to the conditions specified in the First and Second Schedules of this notice.

The Minister of Conservation gives consent, under section 17(2) of the Wildlife Act 1953, to the hunting or killing of game in the manner set out in this notice.

#### New Zealand Game Bird Habitat Stamp

A game bird habitat stamp must<sup>1</sup> be affixed to every licence to hunt or kill game or (in the case of licences issued in the form of plastic cards) a reproduction of the stamp incorporated within it. The following form of the 2016 Game Bird Habitat Stamp is approved.<sup>2</sup>



The 2016 Game Bird Habitat Stamp has a face value of ten dollars (\$10.00). A fee of two dollars (\$2.00) only is payable<sup>3</sup> for every game bird habitat stamp supplied with a licence to hunt or kill game.

**First Schedule** Hunting conditions generally common to all Fish and Game Regions.

**Second Schedule** Regionally specific hunting conditions, bag limits, closed and open game areas, and the like.

#### First Schedule

##### *Hunting Conditions Generally Common to All Fish and Game Regions*

#### 1. Bag limits

1. No person shall possess on any one day more than the number of game birds specified as the daily bag limit for the Fish and Game Region in which the game is taken, except on Sunday 8 May 2015, when that person may have in his or her possession twice the number of game birds specified as the daily bag limit for Saturday 7 May 2015.
2. A person may possess more game than specified in sub-clause 1 of this Schedule if all such game is labelled with the following details:
  - a. The name and address of the person by whom the game was taken;
  - b. The number of the licence to hunt or kill game held by the person by whom the game was taken;
  - c. The name of the Fish and Game Region by which that licence was issued;
  - d. The name of the Fish and Game Region in which the game was taken; and

- e. The date on which the game was taken.

## **2. Waiver of Restrictions on Baiting for Waterfowl**

A person<sup>4</sup> may hunt or kill game of the family Anatidae (waterfowl) during the open season for game in all Fish and Game Regions, except Auckland/Waikato, where food has been cast, thrown, placed or planted any time during the year. In the Auckland/Waikato Fish and Game Region, Special Condition 4.9 in the Second Schedule applies instead to restrictions on baiting.

## **3. Magazine Shotguns**

A person may hunt or kill game birds, as specified, in any Fish and Game Regions with any magazine shotgun of a calibre 10 gauge or less, which includes magazine extensions,<sup>5</sup> other than in:

- a. Auckland/Waikato Fish and Game Region; and
- b. Wellington Fish and Game Region.

For these three Regions special conditions in the Second Schedule apply

## **4. Shot Size**

No person shall use, in any shotgun used for the purposes of hunting and killing game, any cartridge containing any shot size having a larger retained, per-pellet energy at 90 metres than lead BB.

## **5. Use of Lead Shot Prohibited**

1. No person may possess lead shot, or use lead shot, while hunting or killing waterfowl within 200 metres of open water, with any gun using a 10 or 12 gauge cartridge. Non-toxic alternative shot may be used, including steel.
2. For the purposes of this requirement, "waterfowl" means any of the following game species:
  - Black swan (*Cygnus atratus*)
  - Grey duck (*Anas superciliosa*) and any cross of that species with any other species, variety, or kind of duck
  - Mallard duck (*Anas platyrhynchos*) and any cross of that species with any other species, variety, or kind of duck
  - Paradise shelduck (*Tadorna variegata*), also known as Paradise duck
  - Spoonbill duck (New Zealand shoveler) (*Anas rhynchotis*)
  - Pukeko (*Porphyrio porphyrio melanotus*)
3. For the purposes of this requirement, "open water" means either:
  - a. any area of land or seabed covered permanently or seasonally by water wider than 3 metres; or
  - b. any area which is temporarily covered by water wider than 3 metres at the time of such possession or use, and that is contiguous to an area referred to in paragraph 3(a).

## **6. Guns of a Calibre Less Than 12 Gauge and Muzzle Loaders Exempt in Relation to Use of Lead Shot**

Hunters may use lead shot in guns of a calibre less than 12 gauge or muzzle loaders for the 2016 season. No exemptions for any breech loading 12 gauge (or greater) firearm is to be provided for waterfowl hunting.

## **7. Camouflaged Rowboats**

A person<sup>6</sup> may hunt or kill game within the following Fish and Game Regions from unmoored camouflaged rowboats, subject to the excluded periods for the regions specified below:

- Northland - no excluded period
- Auckland/Waikato - excluding 7 and 8 May 2016
- Eastern - excluding 7 and 8 May 2016
- Hawke's Bay - excluding 7 and 8 May 2016
- Taranaki - no excluded period
- Wellington - excluding 7 and 8 May 2016
- Nelson/Marlborough - no excluded period
- West Coast - no excluded period

North Canterbury - excluding 7 and 8 May 2016

Central South Island - excluding 7 and 8 May 2016

Otago - excluding Clutha River 7 to 15 May 2016 inclusive

Southland - no excluded period

### 8. Restriction on Taking of Game

No person shall use any vehicle propelled by mechanical power (including motorised watercraft)<sup>7</sup> to chase or kill game, except in such circumstances and at such times as authorised by the Conservation Act 1987 and Wildlife Act 1953.

### 9. Pegging Day

1. Stand claimants who claimed and occupied a stand during the 2015 Game Season may claim that stand at any time prior to pegging day (up to 10.00am on 10 April 2016) following the purchase of the 2016 game licence. If you are in the Auckland/Waikato Region, then the above-mentioned applies **only to Adult Whole Season Licence Holders** and does not apply to Junior Licence Holders as it does in all other Fish and Game Regions.
2. Otherwise, unclaimed stands can only be claimed any time after 10.00am on 10 April 2016 in all Fish and Game Regions.
3. A stand may be claimed by planting on it a stake having either a board or identifying label attached, plainly identifying the name of the claimant and the number of his/her licence. The hunting stand claim tag provided with the licence must be completed with the name of the claimant and affixed to the board or identifying label.
4. The licence holder claiming a stand must be present in person at the stand when marking it up.
5. No one can claim more than one stand.
6. A stand cannot be claimed closer than 90 metres to a stand already claimed by another person without that person's consent.
7. Any stand not occupied by the claimant within one hour after the opening hour of hunting, on any day, can be occupied by another licence holder for the remainder of the day.

### 10. Conditions

These conditions will expire at the end of the open season for game specified under the Second Schedule for each Fish and Game Region.

## 2. Definition of Area A

All lands north of a line running east/west, north of the Whangape Harbour, then along the main ridgeline of the Maungataniwha Range and out to and including all lands north of Whangaroa Harbour.

## 3. Shooting Hours

1. 6.30am to 6.30pm, except the hunting of:
  - a. Paradise shelduck on 25 February and 26 February 2017 will be from 6.00am to 8.00pm.
  - b. Pukeko and black swan from 25 February to 5 March 2017 inclusive will be from 6.00am to 8.00pm.

## 4. Decoy Limit

No limit.

## 5. Special Conditions

1. No person shall wilfully leave on the hunting ground any game bird(s) shot or parts of any game bird(s) shot.
2. Camouflaged rowboats: Persons may hunt or kill game from an unmoored camouflaged rowboat.
3. During the 25 February and 26 February 2017 special paradise shelduck open season, no person shall hunt within 300 metres of any urban sewage oxidation ponds.
4. During the 25 February to 5 March 2017 special pukeko and black swan season, no person shall hunt within 300 metres of any urban sewage oxidation ponds.

## 2. Shooting Hours

6.30am to 6.30pm.

## 3. Decoy Limit

No limit, except on Lake Waikare - a total decoy limit of 50 decoys per stand and no decoys to be placed within 50 metres of those placed by another hunter.

## 4. Special Conditions

1. From 7 May to 6 June 2016 inclusive, no person may use or cause to be used for the hunting or killing of game on Lake Waikare any drifting or temporarily moored floating stand or any stand, hide or maimai which is permanently fixed to the lake bed except within 180 metres of the outer margin of the lake or the shoreline of Motu Nuia Island (Grape Island).
2. No person may use or cause to be used for the hunting or killing of game on Lake Ngारoto any fixed stand, pontoon, hide or maimai except within 85 metres of the margin of the lake.
3. No person may use or cause to be used for the hunting or killing of game on Lake Rotokauri any fixed stand, pontoon, hide or maimai on any open water of the lake.
4. No person may wilfully leave on the hunting ground any game bird(s) shot or parts of any game birds shot.
5. No person may herd or drive waterfowl for the purpose of hunting or killing them.
6. No person may shoot game from any unmoored boat on the Waikato River north of the boat ramp at the confluence of the Mangawara Stream and the Waikato River at Taupiri on any of the first three days or the second weekend of the open season.
7. No person may possess a firearm in or on any unmoored vessel, except a rowboat, unless the firearm is dismantled or secured in a case, gunslip or other secure compartment, except when in use to retrieve

wounded game.

8. On public land, the last tagged owner must remove any maimai not tagged up for two years from the date of the last mark-up.
9. No person may hunt or kill game<sup>10</sup> of the family Anatidae (waterfowl) in all the area contained within a distance of 100 metres from the margins of any waters together with the area covered by those waters where food has been cast, thrown, placed or planted any time during the period 7 April to 26 June 2016 inclusive.
10. No person may hunt or kill game birds, as specified, within the Auckland/Waikato region with any magazine shotgun of a calibre 10 gauge or less unless the shotgun:
  - a. has a magazine of any type adjusted with a one-piece filler which is incapable of removal without disassembling the gun; or
  - b. the magazine is pinned in accordance with Regulations made under this Act
 so that the magazine shotgun is incapable of holding more than two shells in the magazine, with no more than three shells in the magazine and chamber combined at any one time.
11. Any licensed game bird hunter who has a Department of Conservation permit to take or kill wildlife for the purpose of hawking may hunt with an Australasian Harrier (*Circus approximans*) to take pukeko. This is subject to the season length and bag limit for pukeko in clause 1 of this notice for this region and subject to any conditions imposed by the Director-General of Conservation under such a permit.

#### 5. Closed Game Areas

1. All that area of the Waikato River below Mean High Water Spring Tide from the Tasman Sea inland to an imaginary line commencing from a marker at the exit of the Fisherman's Road drain on the north-western side of the river in Block VII Maoro Survey District, bearing 126 degrees true to a marker on the south-eastern side of the river.
2. All DP 23519, being part Maungatapu Block, Blocks II and VI Maungakawa Survey District, being 15 hectares, the property of A. C. Allen, "Riverdale", Piako, Morrinsville.
3. The township of Te Aroha.
4. All that area lying to the east of the Southern Motorway and known as Pahurehure Inlet.
5. 129 hectares, being part of the Manukau Harbour known as Waimahia Creek.
6. Lots 1-6 DPS 81922, subdivision of part Lot 7 DP 9441 and part Section 19 Block II Whitianga Survey District, 53.3353 hectares. Property of Andrew Hill.
7. Lake Puketirini (Weavers Lake) at Huntly.

#### 6. Upland Game Properties with Special Conditions

1. This clause applies to the following properties only:
  - a. **Tui Ridge:** The property is located at 131A Hall Road, RD 2, Te Kauwhata, being some 259 hectares comprising Lots 1-5 DPS 83930, Part Lots 3 and 4 DPS 85071 and Lot 2 DP 397361 Block Maramarua Survey District owned by G. & C. Holmes and leased by D. & C. Brown, and Lot 10 DPS 85071, Lot 4 DPS 386081 and Lot 1 DPS 86132 Block XIV Maramarua Survey District owned by D. & C. Brown, and Lots Part Allotment 310 Whangamarino Parish SO 590, Part Allotments 329 and 372 Whangamarino Parish DP 16254, Allotment 465 Whangamarino Parish SO 6253, and Lot 1 DPS 12119 owned by Joint Venture 2009 Limited.
  - b. **Leigh Barton property** at 314 Aspin Road, Cambridge. The property is owned by J. & C. Erkkila Family Trust, located north-east of Cambridge. The boundaries are Aspin Road to the north, and private farm land to the east and west with Mangakawa Reserve to the south. The property is 211 hectares, more or less, and contained in Certificate of Title SA674/278.
  - c. **Glen Burn Farm** at 381 Valley Road, RD 7 Otorohanga, being some 73 hectares comprising Lot 2 DP 416788, owned by Robert Johnston.
2. Where hunting takes place in any specified property defined in this notice, no person shall have in that



person's possession outside that specified property any game taken from that specified property unless affixed to the game is a label with the name of the specified property where that game was taken or killed written legibly on it, and the additional words on the label "for personal consumption, not for sale or profit" written legibly on it.

3. Birds released on any specified property shall not have their wings clipped after six weeks of age.
4. Birds released on any specified property shall not have their beaks clipped at any time.
5. Pheasants released shall not be hunted before 18 weeks of age and red legged partridges shall not be hunted before 16 weeks of age.
6. Waterfowl shall not be hunted on specified property on the same day that a pheasant or red legged partridge hunt takes place on that property.
7. The unlimited daily bag for any specified property shall only apply when at least 400 pheasants and/or red legged partridges have been released on to that specified property within five months of the opening day of the season; otherwise the daily bag limit shall be three birds.
8. The property owner or leasee shall keep a register of the names and addresses of hunters and all other persons who take game from that property, the number and type of birds taken by that person, and the description of that person's role in the hunt and kill of game birds on that day.

## 2. Definition of Areas

The following descriptions refer to Local Authority Boundaries described on the Infomap 242B-2 Land Information New Zealand for the Eastern Fish and Game region.

1. **Area A1:** Tauranga District, Western Bay of Plenty District, that part of the South Waikato District within the Eastern Fish and Game region and east of State Highway 1, Rotorua District, Kawerau District, Whakatane District and Opotiki District.
2. **Area A2:** Those parts of the South Waikato District west of State Highway 1 within the Eastern Fish and Game region, Taupo District and Ruapehu District, which lie within the Eastern Fish and Game region.
3. **Area B1:** Gisborne District.
4. **Area B2:** That part of Wairoa District within the Eastern Fish and Game region.

## 3. Shooting Hours

6.15am to 6.15pm in all areas for all species during their respective seasons.

## 4. Decoy Limit

No limit.

## 5. Special Conditions

1. Unpinned magazine shotguns may be used.
2. Hunters in the Eastern Region are encouraged to observe a voluntary limit to magazine shotguns capable of holding no more than three shells with no more than two shells in the magazine and one shot in the chamber. A voluntary phase-in period is in place for the 2016 season, with it to become compulsory in the 2017 season.
3. No maimai shall impede the use of navigable channels in the Tauranga Harbour, Ohiwa Harbour, Little Waihi Estuary, Lake Aniwhenua and Lake Taupo.
4. Maimais erected in the Little Waihi Estuary, Lake Aniwhenua, Ohiwa Harbour, Stump and Waihi Bays of Lake Taupo must be dismantled and removed within two weeks of the close of the season (i.e. by 11 September 2016).
5. Any licensed game bird hunter who has a Department of Conservation permit to take or kill wildlife for the purpose of hawking may hunt with an Australasian Harrier (*Circus approximans*) to take Pukeko. This is subject to the season length and bag limit for Pukeko specified in clause 1 of this notice for this Region and subject to any condition imposed by the Director-General of Conservation under such a permit.

## 6. Upland Game Properties with Special Conditions

1. **Pirini Family Trust:** The property is located eight kilometres up the Bush Road from Pongokawa. It is bounded by Pongakawa River, Rotoehu Forest and Bush Road, Sections 4, 5 and 7 SO 7437 Block IX Waihi South Survey District. The property is leased by N. Raven.
2. **Equine Farm:** The property is located approximately six kilometres in a north-west direction from Lake Rotoehu with Rotoehu Road and Fletcher Challenge's Rotoehu Forest on the main boundaries. It is made up

of 283 hectares being entirely enclosed within deer fence, DPS 17091. The property is owned by Equine Estate Limited.

3. **Prime Pine:** The property is located on the Matata Highway and consists of some 120 hectares of pine forest. DPS 58240. It is bounded by Hingston, Fraser, Prinz and Knight properties. The property is owned by Prime Pine Partnership.
4. **Harakeke Station:** 1034 State Highway 1, RD 1, Wairakei, being 946.37 hectares in total and consisting of Tatua East No. 25 Block, Tatua East No. 27 Blocks I, II and VI Tatua Survey District, Tatua East No. 29 Blocks V and VI Tatua Survey District, Tatua East No. 28 Block V Tatua Survey District, Part X2A Block V Tatua Survey District, Lot 1 DP 330092, Lot 2 DPS 11900, Part Tatua East 11E1B MI 16902, Block V, Tatua Survey District, Lot 1 DPS 90819, Lot 1 DPS 10147, Part Tatua East 8 ML 14696, Block V, Tatua Survey District, Tatua East 11C1 ML 14696 Block V, Tatua Survey District 11B ML 14696, Tatua East Survey District 11A ML 14696, Tatua East Survey District Tatua East 12E1 MI. The property is owned by Harakeke Company Limited.

- No person shall use or cause to be used on any water within the region for the hunting or killing of game any fixed stand, pontoon, hide, loo or maimai, except within a distance of 10 metres from the water margin in non-tidal waters, or from the low water mark in tidal waters, or from the outside edge of the raupo growth where raupo abounds, without the prior consent of the Otago Fish and Game Council.
- No person may leave on the hunting ground the bodies or parts of bodies of Black swan or other game shot

in the Otago Fish and Game region.

3. Shooting from a boat is prohibited on the Clutha River from 7 to 15 May 2016 (refer to First Schedule clause 7).
4. The summer paradise duck season is open for one day on 4 March 2017 for junior licence holders only, and is restricted to locations 200 metres or more from open water.
