If the dispute is not resolved within one month of the date on which the parties begin their negotiations, the parties must submit at the request of either party to the arbitration of an independent arbitrator appointed jointly by the parties, or if the parties cannot agree on an independent arbitrator within 14 days, the parties will submit to the arbitration of an independent arbitrator appointed by the President for the time being of the New Zealand Law Society. The arbitration will be determined in accordance with the Arbitration Act 1996 and its amendments or any statute which replaces it.

8. Where there is a conflict between the provisions of Schedule 4 of the Land Transfer Regulations 2002 and the modification by this notice to Schedule 4 of the Land Transfer Regulations 2002, the modification in this notice is to prevail
