- a. To assist in verifying the registered person details in respect of a motor vehicle when purchasing that vehicle;
- b. to check or confirm that a change of registered person has been completed correctly in relation to a transaction in which the motor vehicle trader has a business interest;
- c. in the case of wholesalers only, to obtain names and addresses of persons registered in respect of vehicles that are the subject of a safety recall; and
- d. any other purpose that is necessary to facilitate the sale or purchase of a motor vehicle in relation to a transaction in which the motor vehicle trader has a business interest, other than marketing purposes.
- 5. Authorisation—A motor vehicle trader is authorised to access the Motor Vehicle Register if the trader:
  - a. is a member of a representative body with disciplinary powers which has applied for access to the Motor Vehicle Register on behalf of its members;
  - b. is a member of a representative body without disciplinary powers where the individual members have been authorised to access the Motor Vehicle Register; or
  - c. has been otherwise authorised to access the Motor Vehicle Register.

#### 6. Conditions

- Names and addresses are accessed only by the motor vehicle trader on the trader's own behalf, and solely for the trader's own use;
- b. names and addresses may only be accessed for a specified purpose;
- c. the fees charged for the provision of the names and addresses from the Motor Vehicle Register are duly paid;
- d. any instances of unauthorised access must immediately be notified to the Registrar of Motor Vehicles (currently the NZ Transport Agency), the Privacy Commissioner, and the individual(s) whose information has been accessed without authorisation or disclosed in breach of these conditions.
- e. before being permitted to access the Motor Vehicle Register under section 241 of the Act, all staff must receive training that emphasises that such access must only be for a specified purpose, and refresher training of all staff must be undertaken at appropriate intervals (such as annually);
- f. access must be restricted solely to members of staff for whom authorised access is essential to achieving a specified purpose;

- g. the names and addresses obtained under this authorisation shall not be disclosed to any third party unless such disclosure is necessarily incidental to achieving a specified purpose; and
- h. the motor vehicle trader must comply with the terms and conditions of their chosen digital access provider.

#### 7. Records and Audit

- a. The motor vehicle trader is required to keep summary records of each section 241 enquiry for one year, from the date on which register data was accessed; and
- b. the motor vehicle trader must provide information to the Registrar of Motor Vehicles and in all other respects assist with any audit of their access to name and address information.

#### 8. Interpretation

motor vehicle trader and trader means a person or company who is registered under the Motor Vehicle Sales Act 2003 to carry out the activities described in section 7 of that Act.

wholesaler has the meaning given to that expression in section 6 of the Motor Vehicle Sales Act 2003.

**9. Expiry**—This notice expires at midnight on 16 March 2022, but may be revoked at any time either generally or in relation to a specific motor vehicle trader.

This authorisation will not apply to any motor vehicle trader who ceases to be registered as a motor vehicle trader.

- 2.4 replacing the speed limit on the section of State Highway 7 from the intersection with State Highway 1S to 500m north of the intersection with State Highway 1S with "80";
- 2.5 in the section relating to State Highway 7, replacing "90m north of Stock Road, Culverden" with "90m south of Stock Road, Culverden" in both places; and
- 2.6 in the section relating to State Highway 7, replacing "930m south of the south end of the Glenallan Stream bridge" with "1500m north of the intersection with State highway 7A" in both places.



Now therefore I, The Right Honourable Dame Patsy Reddy, the Governor-General of New Zealand, and as such the Governor of the Ross Dependency, appoint

#### Rosemary Forrester

to be an officer of the Government of the Ross Dependency while she acts as Senior New Zealand Representative at Scott Base during the period beginning with the date of this appointment and ending with the close of 20 October 2017.

I confer on Rosemary Forrester, while she holds office as an officer of the Government of the Ross Dependency, all the powers exercisable in New Zealand by a Justice of the Peace.

Rosemary Forrester is to exercise her functions at such places within the Ross Dependency as may be directed by an officer of the Government of the Dependency who has the general executive and administrative authority in preserving Her Majesty The Queen's rights and sovereignty and the laws in force in the Ross Dependency.
