Pursuant to Regulation 87 of the Electricity (Safety) Regulations 2010 ("Regulations"), I, Mark Stephen Wogan, Manager, Energy Safety, WorkSafe New Zealand, give the following notice.

##### **Notice**

##### **1. Short title and commencement**

This notice is the Electricity (Safety) - (Unsafe 10A - 15A Adaptor) Notice 2017.

This prohibition takes effect on and from **2 June 2017**.

**2. Prohibited activities**

1. The manufacture, importation, sale (including an offer to sell), and use (including installation) of the 10A - 15A Adaptor described below are prohibited.
2. This notice does not prohibit the manufacture, importation, sale (including an offer to sell), or use (including installation) of the individual items that make up this fitting.

**3. Description of fitting**—The fittings meeting the definition of a 10A - 15A Adaptor to which this notice applies are further described below:

- a. The adaptor is manufactured out of a 15A socket outlet face plate, with or without a spacer plate, a blank face plate and two (2) or more 10A plugs in the “3 pin, flat pin” configuration compatible with AS/NZS 3112, or parts thereof.
- b. The adaptor is being supplied for use with an In Cord - Control and protection device (IC-CPD) for use in the charging of electric vehicles.
- c. Characteristics of the prohibited adaptor are below:
  - it has a plastic body;
  - it may have a sticker saying “15A”;
  - it has two (2) or more 10A plugs in the “3 pin, flat pin” configuration compatible with AS/NZS 3112 or parts of these plugs;
  - the faceplates may be removable;
  - components of the plugs may feature the Regulatory Compliance Mark (RCM);
  - the live pins of the plugs may be half insulated;
  - the plugs are or may be attached to a blank face plate;
  - the rear of the plugs may be removed; and
  - there may be holes in the blank faceplate to allow wires to be installed connecting the plugs to the 15A socket outlet.
- d. The images below show views of one sample of the prohibited adaptor for identification purposes.

#### **4. Reasons for prohibition**

1. I believe that the fitting described in this notice is, or may be, electrically unsafe, in that there is a significant risk that a person may suffer serious harm as a result of dangers arising from use of, or passage of electricity through, the fitting.

  - a. the fitting allows the possibility of electric shock in that if one of the plugs is connected to a socket outlet the other will be live.

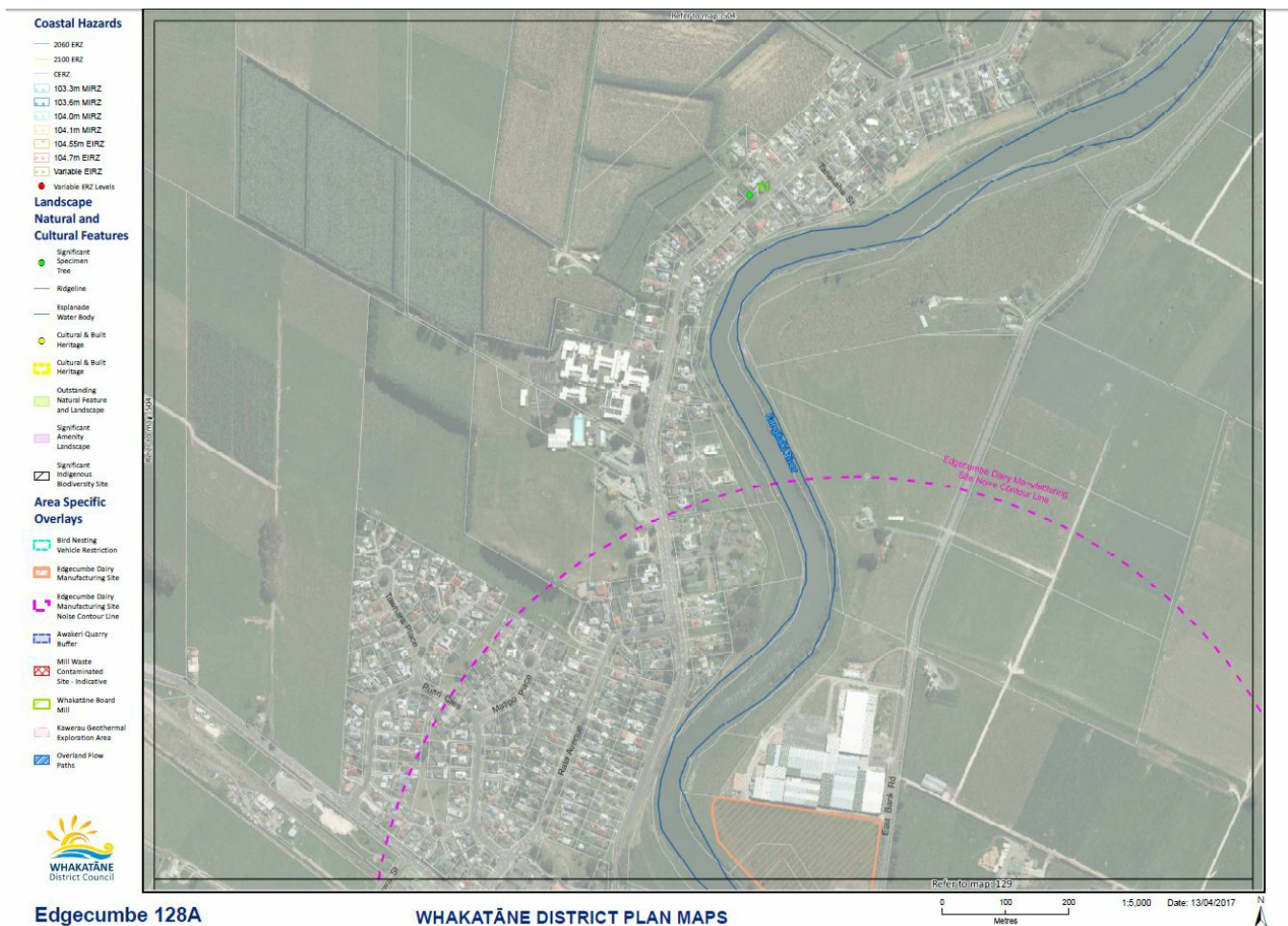

3. The Commission’s additional function under paragraph 2 is subject to the following:

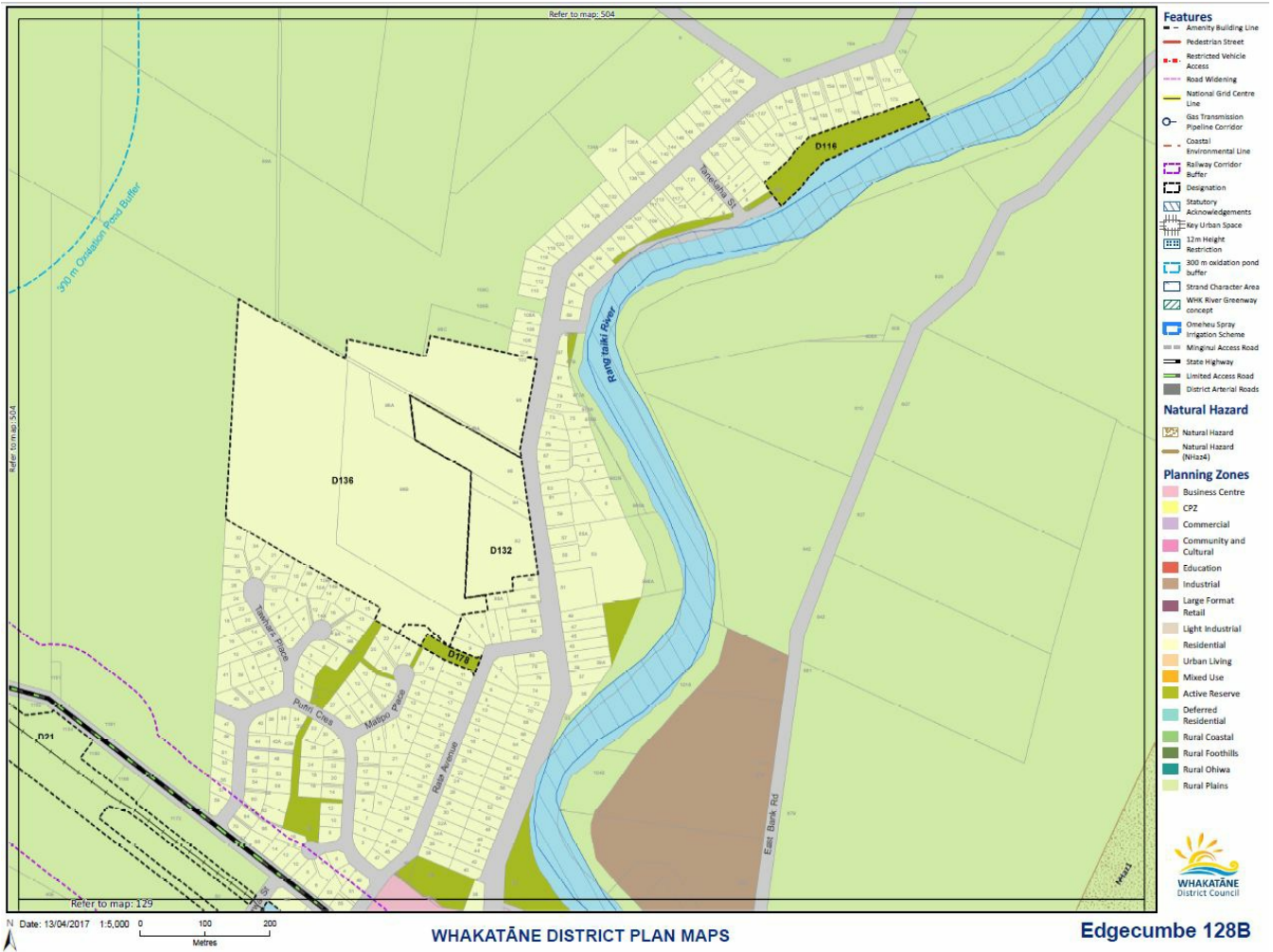
The Commission must exercise the additional function for the purpose of assisting in the recovery of the Edgumbe community from damage as a result of storms and floods occurring in April 2017.
4. For the avoidance of any doubt, when performing the Commission’s additional function under paragraph 2:
  - a. the Commission is not required to carry out the function on any land where the owner or occupier



- refuses the Commission’s reasonable request for access;
- b. the Commission may determine how and to what extent it will reinstate the land in the Edgecumbe community that has been damaged as a result of the storms and floods occurring in April 2017, and may consult with the Whakatane District Council and any other person the Commission considers appropriate;
  - c. the Commission is not required to reinstate all or any part of the land, or to reinstate the land exactly or completely; and
  - d. the Commission may enter into such arrangements as it thinks fit for carrying out the additional function, including performing the function (in whole or in part) for the Whakatane District Council or another person for a fee.
5. For these purposes:
- a. **debris** includes silt, wreckage, rubble, rubbish and remains;
  - b. **Edgecumbe community** means the area shown on Maps 128B and 129B of the Whakatane District Council Operative District Plan (13 April 2017) as at 27 April 2017, and the adjoining parcels of land located at 28 and 48 Edgecumbe Soldiers Road;
  - c. **land** includes public and private land including the land underneath any buildings or structures, but does not include the buildings and structures themselves; and
  - d. **reinstate** includes remove and dispose of debris situated on land, and fill and relevel land that is scoured.
6. This direction expires on **4 April 2018** unless revoked earlier.

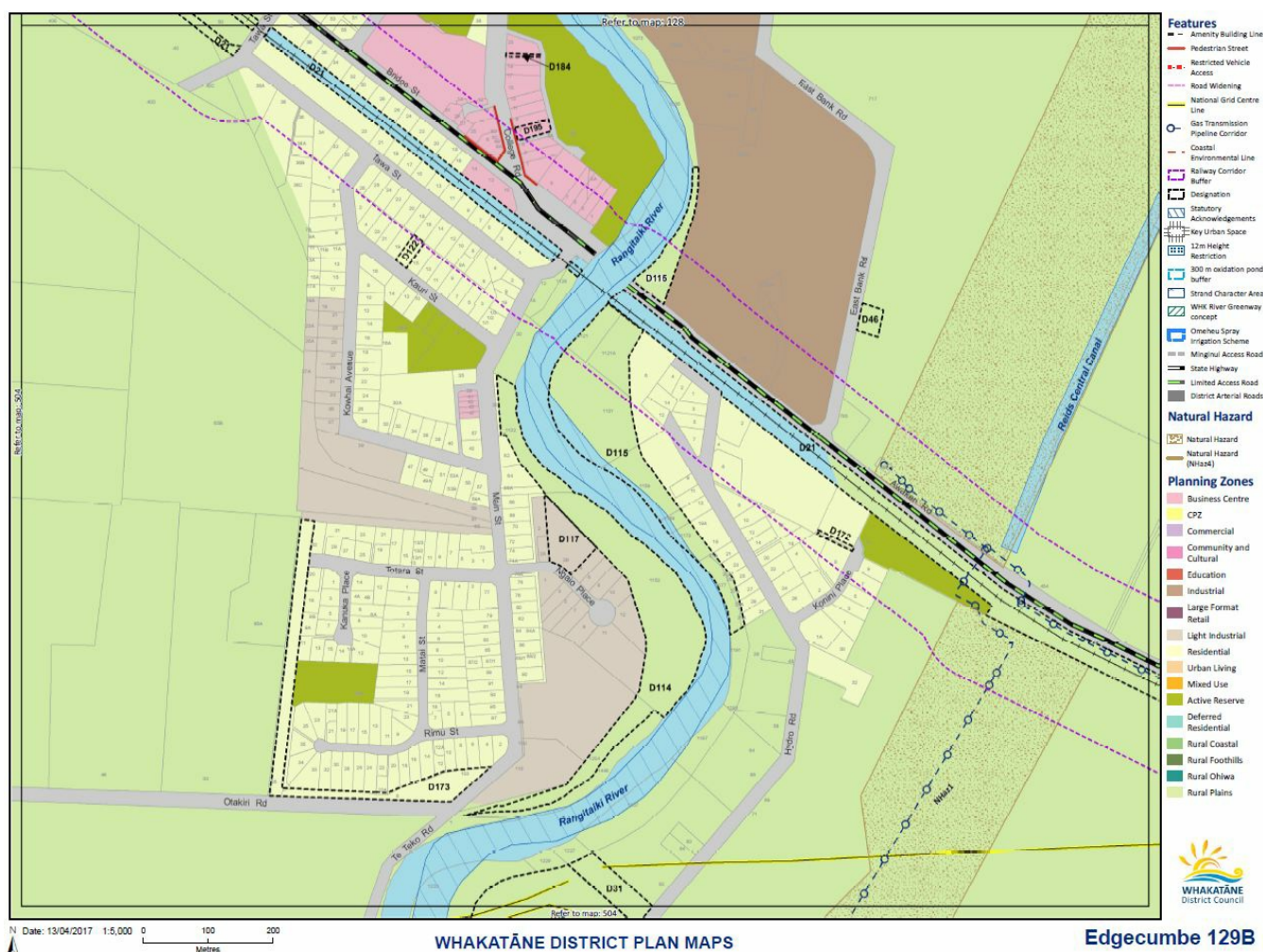




Edgecumbre 129A

## Land Transport Rule: Setting of Speed Limits 2003 and Land Transport Rule: Traffic Control Devices 2004—Rural Intersection Active Warning System Variable Speed Limit—State Highway 1, Designation Road Intersection, Warkworth

Pursuant to clause 6.1 of the Land Transport Rule: Setting of Speed Limits 2003, clause 4.4(4) of the Land Transport Rule: Traffic Control Devices 2004 and delegations from the NZ Transport Agency, I, Glenn Bunting, Network Manager, approve a rural intersection active warning system variable speed limit on State Highway 1, at the intersection with Designation Road (the construction access road to the Puhoi to Warkworth bypass, approximately 530m south of Perry Road), near Warkworth, in accordance with the conditions set out in this notice.

### Conditions

**1. Variable speed limit**—The NZ Transport Agency (Highways and Network Operations Group) may set a variable speed limit of 70km/h on State Highway 1, at the intersection with Designation Road, to manage the safety of traffic when vehicles are turning or merging at the intersection.

**2. Operation of the variable speed limit**—The variable speed limit, which must be displayed on variable speed limit signs, may operate when a vehicle is detected approaching the intersection on Designation Road or turning right on State Highway 1 and may continue to operate until those vehicles have cleared the intersection or merged with traffic on State Highway 1. When the variable speed limit is not operating, the variable speed limit signs must either display the permanent speed limit or be blank.

**3. Signs**—Speed limit signs that comply with the Land Transport Rule: Traffic Control Devices 2004 must be installed to identify the section of road subject to the variable speed limit as follows:

- a. Two R1-2.1, Option B “Variable speed” signs, one on each side of the road and each installed above a W11-4 intersection warning sign, at the beginning of the variable speed limit on State Highway 1, facing road users on each approach to the intersection with Designation Road; and
- b. R1-1 “Standard” or R1-1.1 “100km/h” signs at the end of the variable speed limit, facing road users on each road that leaves the intersection, to indicate the permanent speed limit that applies beyond that point.

**4. Length of variable speed limit**—The variable speed limit on State Highway 1 must be a minimum length of 300m, but must not be longer than 500m.

**5. Bylaw**—The NZ Transport Agency (Highways and Network Operations Group) must set the variable speed limit by making a bylaw in accordance with the Land Transport Rule: Setting of Speed Limits 2003.

## **Notice of the Electricity Industry Participation Code Amendment (Shortened Gate Closure and Revised Bid and Offer Provisions) 2017**

1. Under section 38(3)(b) of the Electricity Industry Act 2010 (“Act”), and having complied with section 39 of that Act, the Electricity Authority (“Authority”) gives notice of making the Electricity Industry Participation Code Amendment (Shortened Gate Closure and Revised Bid and Offer Provisions) 2017 (“amendment”).
2. The amendment comes into force on **29 June 2017**.
3. The amendment makes changes to Parts 1 and 13 of the Electricity Industry Participation Code 2010 (“Code”) to reduce the gate closure period to one hour for situations in which a two hour gate closure period currently applies.
4. The amendment also makes changes to Part 13 to:
  - a. clarify the drafting and readability of a number of clauses relating to the submission and revision of bids, offers, and reserve offers;
  - b. remove references to the cancellation of bids, offers, and reserve offers as these duplicate the references to revisions;
  - c. clarify the process for participants to permanently cease providing bids, offers, or reserve offers at a particular location (for example, if generating plant is being decommissioned);
  - d. clarify that the total megawatts (“MW”) specified in each offer must not exceed the total MW that a generator expects to be capable of generating at the relevant point of connection to the grid for the relevant trading period;
  - e. provide that a generator must not revise certain offer parameters during a gate closure period (for example, ramp rates);
  - f. reduce and simplify the minimum MW change that requires a generator to immediately submit a revised offer;
  - g. require intermittent generators, when submitting persistence-based offers, to take account of information about any expected changes in the availability and capability of the relevant intermittent generating station;
  - h. during the two hours immediately preceding the trading period to which an offer relates, require intermittent generators to submit a persistence-based offer at least once per trading period;
  - i. require generators to ensure that any revision to an offer during a gate closure period revises the MW specified in the offer only to the extent necessary to ensure that the MW specified reflects the MW that the generator expects to be capable of generating, and that the reduction is deducted from the MW offered in the highest price bands first;
  - j. remove the obligation for the grid owner to provide a report to the Authority on any revised grid information submitted during a gate closure period; and
  - k. remove the obligation on the Authority to consider reports made to it in relation to certain types of

revised bids, offers, and reserve offers to assess whether the revisions were compliant with the relevant provisions in the Code.

Pursuant to sections 288(1)(a) and 288(12) of the Customs and Excise Act 1996, the chief executive hereby makes the following amendments to the Customs (Advance Notice of Departure) Rules 2014.

#### Rules

**1. Title and Commencement**—(1) These rules may be cited as the Customs (Advance Notice of Departure) Amendment Rules 2017.

(2) These rules shall come into force on **30 June 2017**.

**2. Interpretation**—In these rules, unless the context otherwise requires:

- a. **Act** means the Customs and Excise Act 1996.
- b. **Principal Rules** means the Customs (Advance Notice of Departure) Rules 2014.

Any terms used in these rules which are defined in section 2 of the Act shall have the meanings given to them by that section.

**3. Principal Rules Amended**—(1) Rule 3 is revoked and substituted with the following:

**3. Form and Content of Advance Notices of Departure**

Every advance notice of departure required under section 34(a) of the Act shall be in any one of the following forms:

- a. For ships or boats (other than small craft):
  - i. In Electronic Message Format E6 if made using the JBMS and must contain the particulars specified in that form, accompanied by any applicable supporting documents as the chief executive may require; or
  - ii. in Form C2 in all other cases and must contain the particulars specified in that form, accompanied by any applicable supporting documents as the chief executive may require.
- b. In Form C2A for aircraft and must contain the particulars specified in that form, accompanied by any applicable supporting documents as the chief executive may require.
- c. In Form C2B for small craft and must contain the particulars specified in that form, accompanied by any applicable supporting documents as the chief executive may require.

(2) Form C2 in the Schedule of the Principal Rules is hereby revoked and substituted with the form set out in Schedule 1 to these rules.

(3) In the Schedule of the Principal Rules, after Form C2B, insert Electronic Message Format E6 set out in Schedule 2 to these rules.

**4. Rules to Continue in Force**—(1) The Principal Rules remain in force, except to the extent amended by these rules.

**Customs (Excisable Goods Entry) Amendment Rules 2017**

Pursuant to sections 288(1)(f) and 288(12) of the Customs and Excise Act 1996, the Chief Executive hereby makes the following amendments to the Customs (Excisable Goods Entry) Rules 1997.

**Rules**

**1. Title, Commencement, Application and Purpose**—(1) These rules may be cited as the Customs (Excisable Goods Entry) Rules 2017.

(2) These rules shall come into force on **30 June 2017**.

(3) These rules shall apply for the purpose of prescribing the form in which entries of excisable goods may be made using the JBMS should the licensee or the owner of the goods elect to do so.

**2. Interpretation**

In these rules, unless the context otherwise requires:

- a. **Act** means the Customs and Excise Act 1996.

- b. **prescribed form** or **form** means a form prescribed by the chief executive and set out in Schedule 1 to these rules, and a reference to a numbered form is a reference to the form so prescribed and numbered.
- c. **Principal Rules** means the Customs (Excisable Goods Entry) Rules 1997.

Any terms used in these rules which are defined in section 2 of the Act shall have the meanings given to them by that section.

### 3. Principle Rules Amended

(1) In Rule (2) of the Principal Rules, insert new Rules 2(d) and 2(e) as follows:

(d) **legacy message** means the message lodgement and content provided to the New Zealand Customs Service in Electronic Message E3 using electronic declarations provided by existing legacy systems.

(e) **KTC** means kilos of tobacco content.

(2) Rule 4(a)(ii) of the Principal Rules is hereby revoked and substituted with new Rule 4(a)(ii) as follows:

(ii) If submitted electronically to Customs, either:

(A) In Electronic Message Format E3, for home consumption entries made using the legacy message, or

(B) In Electronic Message Format E3A for home consumption entries made using the JBMS.

(3) In Rule 4(c) of the Principal Rules, delete “a Customs computerised entry processing system” and replace with “the legacy message”.

(4) In Rule 4 of the principal Rules, after Rule 4(c), insert new Rule 4(ca) as follows:

(ca) Every entry made by the use of the JBMS shall be completed in accordance with the requirements set out in the Electronic Message Format E3A, and in accordance with Schedule 2 to these rules.

(5) Form C6 in Schedule 1 of the Principal Rules is hereby revoked and substituted with the form set out in Schedule 1 to these rules.

(6) Form C6CS in Schedule 1 of the Principal Rules is hereby revoked and substituted with the form set out in Schedule 2 to these rules.

(7) In Schedule 1 of the Principal Rules after the Electronic Message Format, insert Electronic Message Format E3A set out in Schedule 3 to these rules.

(8) Schedule 2 of the Principal Rules is hereby revoked and substituted with the new Schedule 2 set out in Schedule 4 to these Rules.

### 5. Rules to Continue in Force

The Principal Rules to continue in force except to the extent they are amended by these rules.

- i. Licensees/owners have been allocated reporting periods on a monthly, six monthly, and annual basis.

## **The Tertiary Education (2018 Annual Maximum Fee Movement) Notice 2017**

Under sections 159L(3)(d) and 159M(b) of the Education Act 1989, the Minister for Tertiary Education, Skills and Employment gives notice of the proposed conditions setting limits on the annual increases that tertiary education organisations may make to fees charged to domestic students in 2018.

### **Notice**

**1. Title**—This notice may be cited as the Tertiary Education (2018 Annual Maximum Fee Movement) Notice 2017.

**2. Commencement**—The proposed conditions outlined in this notice apply for the 2018 academic year only.

**3. Proposal**—I propose to specify conditions under section 159L(3)(d) that the Tertiary Education Commission (TEC) must attach to funding provided under the relevant funding mechanisms, in particular to specify:

- a. the annual limits by which Tertiary Education Organisations (TEOs) can increase fees charged to domestic students enrolled in courses that are leading to short awards, certificate, diploma, degree, and postgraduate qualifications that receive Student Achievement Component (SAC) funding for provision at Level 3 or above on the New Zealand Qualifications Framework (NZQF) in 2018 (including provision at Information and Communications Technology (ICT) Graduate Schools and provision funded through the SAC Levels 3 and 4 competitive allocation pilot); and
- b. the other conditions in relation to fees that the TEC must attach to SAC funding for provision at Level 3 or above (including provision at ICT Graduate Schools and provision funded through the SAC Levels 3 and 4 competitive allocation pilot).

The proposed conditions do not apply to fees for SAC-funded courses that are at Levels 1 and 2 on the NZQF, which remain subject to the conditions as set out in the Tertiary Education Fees-Free Conditions Notice [2015] and The Tertiary Education Fees-Free (Levels 1 and 2) Conditions Notice [2016].

**4. Application**— The conditions set out in this notice refer to:

- a. Fees as including the following items: tuition fees, compulsory course costs, examination fees, other charges associated with a programme of study, material charges, cost of field trips and any compulsory purchase of equipment or books through the organisation.
- b. TEOs as organisations as defined in section 159B, include tertiary education institutions (TEIs), private training establishments (PTEs) and rural education activities programme providers (REAPs).

**5. Call for submissions**—Any TEO and any other person, body or organisation having an interest in the matter is invited to make a submission on the proposed Annual Maximum Fee Movement (AMFM) and other proposed conditions set out in this notice.

**Proposed Conditions to be Attached to Student Achievement Component Funding (SAC) Allocated and Paid for by the Tertiary Education Commission (TEC) to Tertiary Education Organisations (TEOs)**

*General*

1. These conditions apply to fees charged for SAC funding for provision at Levels 3 and above in all TEOs (including ICT Graduate Schools and the provision funded through the SAC Levels 3 and 4 competitive allocation pilot).
2. The fees associated with a particular course are subject to these conditions if:
  - a. the TEO is the sole source of the item to which the fee relates; and
  - b. all domestic students validly enrolled in the course are required to pay the fees.

*AMFM*

3. For 2018, the AMFM is a 2% increase on the fees, (GST exclusive) charged in 2017 for a course that is part of a programme that leads to a qualification at Level 3 and above on the NZQF for which a TEO receives SAC funding.
4. The AMFM applies to any new courses at Level 3 and above on the NZQF established by a TEO in substitution for an existing course dealing with the same or similar subject matter, at a same or similar Level on the NZQF, for which SAC funding can be used.

*Exceptions to the AMFM*

5. A TEO may apply for an exception from the 2018 AMFM for a SAC-funded course that is part of a programme that leads to a qualification at Level 3 or above on the NZQF on the basis of exceptional circumstances. Any exception granted will not exceed an additional 2% increase over and above the permitted 2% increase.
6. In considering exceptional circumstances, the TEC must only have regard to the following criteria:
  - a. the TEO is unable to support the course(s) while remaining financially viable;
  - b. for courses at Levels 3–8 on the NZQF, the completion rate for the qualification met or exceeded the median performance benchmark for that level in the previous year;
  - c. the TEO can demonstrate that the course is in some way unique or special, for example, that there are no available local alternatives to the course; and
  - d. not allowing an exception will prevent the TEO from making a significant contribution to the achievement of one or more of the Government's priorities, as set out in the Tertiary Education Strategy 2014–2019.
7. An application must satisfy all criteria to gain an exception.

*Low or Zero Fee Courses*

8. If the fees for a SAC-funded course that is part of a programme that leads to a qualification at Level 3 or above on the NZQF are less than \$511.11 (GST inclusive) (\$444.44 (GST exclusive)) per Equivalent Full-Time Student (EFTS) in 2017, then for 2018, the TEO may increase the fee to up to \$511.11 (GST inclusive) (\$444.44 (GST exclusive)) per EFTS, or can increase the fee for the course by 2%, whichever is the greater.

---

**Note: Effect of this notice**

These notes do not form part of this notice, but are intended to indicate its general effect.

A. Section 159L(3)(d) of the Education Act 1989 ("Act") provides that the Minister, when determining the design of a funding mechanism, may specify the conditions that the TEC must attach to funding provided under the mechanism, including conditions that limit the fees that an organisation may charge domestic students.

B. Under section 159M(b) of the Act, the Minister may not specify conditions that set limits on the fees that organisations may charge domestic students until:

- i. the Minister has published a notice in the *New Zealand Gazette* that:
  - A. states that the Minister proposes to specify such conditions;
  - B. sets out the proposed conditions;



- C. invites submissions on the proposed conditions; and
  - D. specifies the date by which submissions must be received, which must be a date no later than 21 days after the date of the *New Zealand Gazette* notice; and
- ii. the date by which submissions must be received has passed.

C. The conditions setting limits on fees subsequently specified by the Minister in accordance with section 159L(3)(d) of the Act must be imposed as conditions on funding payable by the TEC to an organisation under section 159YA and 159ZC of the Act.

D. Under sections 227(1A) and 234A of the Act, TEIs and PTEs respectively must not charge domestic students a fee that exceeds the maximum specified as a condition on funding approved by the TEC under section 159YA and section 159ZC of the Act.
