Increase in fees

The Council resolved, at its meeting on 13 and 14 June 2017, to adopt an increase of 2.2 % across all gazetted fees, with effect from 1 September 2017.

The main reason for the fee increase was to provide Council with a break even budget while ensuring that any fee increase was limited to the current year's inflation rate. Council was also mindful of the increasing cost pressure through ongoing disciplinary cases taken against doctors.

From 1 September 2017, this notice replaces these earlier notices:
