Proposed Ministerial Direction on Compulsory Student Services Fees 2014

Pursuant to sections 227A(1) and 235D(1) of the Education Act 1989, I give the following direction to institutions and private training establishments (together referred to in this direction as "providers"):

Objective

1. The objective of the direction is to ensure accountability in the use of compulsory fees for student services.

Coverage

2. All providers that charge a compulsory student services fee to domestic students must comply with the provisions of this direction.

Effective date

3. Providers must give effect to this direction as soon as reasonably practicable after 1 November 2013.

Decision-making

- 4. Providers must establish adequate arrangements for decisions to be made jointly, or in consultation with the students enrolled at the provider, or their representatives, on the following matters:
 - (a) the maximum amount that students will be charged for student services; and
 - (b) the types of services to be delivered (within the categories set out under paragraph 9 of this direction); and
 - (c) the procurement of these services; and
 - (d) the method for authorising expenditure on these services.

Accounting for the use of compulsory student services fees

5. Providers must either hold compulsory student services fees in a separate bank account, or ensure that all income and expenditure associated with the provision of such services is separately accounted for in the provider's accounting system.

Reporting on compulsory student services fees

- 6. Institutions must provide information on compulsory student services fees through their annual report or in the case of registered private training establishments through a written report to students.
- 7. Institutions must include the following information in their annual report or report to students:
 - a description of the services funded out of the compulsory student services fee;
 - a statement of the fee income and expenditure for each type of student service;
 - the compulsory student services fee levy charged per equivalent full time student; and
 - a note to their reporting stating how they are complying with the accounting requirements of the direction.

New Zealand Public Health and Disability Act 2000

The Funded Family Care Notice 2013

Name

1. This is the Funded Family Care Notice 2013.

Authority

- 2. This Notice is a legal document issued by the Minister of Health, for the Crown.
- 3. This Notice is issued under section 88 of the New Zealand Public Health and Disability Act 2000.
- 4. This Notice is part of a family care policy made under Part 4A of that Act. This Notice must be read with that policy.

Parties to the Notice

5. This Notice is between the Ministry of Health and the disabled person; it also recognises the responsibilities of the family carer and Ministry's agents.

Acceptance of terms and conditions

- 6. The disabled person² accepts these terms and conditions when they accept their first payment for the funding.³
- 7. These terms and conditions can only be amended by the Minister of Health; and at any time.⁴

Effective date and application

8. This Notice is effective from 1 October 2013, and applies to funded family care from that date.

Overview

- 9. This Notice sets out the funding arrangements of the Government's family care policy⁵ that are required to enable the Ministry to pay a disabled person to receive funded family care, and for that disabled person to use that funding to employ a family carer.
- 10. Funded family care is described in the Funded Family Care Operational Policy. 6 Essentially it is:
 - (a) for personal care and household management services;
 - (b) provided by a family carer to a disabled person who meets the eligibility criteria;
 - (c) provided to the disabled person up to a maximum of 40 hours a week; and
 - (d) paid at the rate of the minimum wage for adults.⁷
- 11. Funded family care is provided through a 5-way partnering relationship among the disabled person, family carer, Ministry, and Ministry's agents (NASC and Host), requiring:
 - (a) the Ministry to pay the disabled person for funded family care;
 - (b) the disabled person to use the funding to employ a family carer to provide the funded family care;
 - (c) the disabled person and the family carer to prepare an individual service arrangement;
 - (d) the family carer to provide the funded family care according to the arrangements reflected in the individual service arrangement; and
 - (e) the Ministry's agent to:

NASC

- (i) assess and co-ordinate the disability support services needs of the disabled person;
- (ii) monitor the delivery of the funded family care;
- (iii) assist with the management of problems; and
- (iv) audit the payment and service arrangements.

Host

- (v) assist with the set-up of the funded family care;
- (vi) help the disabled person and family carer prepare the individual service arrangement; and
- (vii) assist with initial and on-going advice on the employment relationship between the disabled person and the family carer.

Principles

- 12. For the Notice to work effectively in a family care setting, the parties acknowledge that:
 - (a) the disabled person has the right to accept and manage their responsibilities; 10
 - (b) choices in how disabled people live their lives at home are respected;
 - (c) the unique dynamics of the home and family/whānau/aiga setting are respected;
 - (d) the contribution of family carers, with the assistance of other members of the family, is valued; and
 - (e) a partnering relationship among the parties will better ensure that the interests of the disabled person are promoted.
- 13. The parties also acknowledge that they must:
 - (a) act in the best interests of the disabled person;
 - (b) respect the individual autonomy and choice of the disabled person;
 - (c) respect the personal privacy of the disabled person;
 - (d) treat each other with respect, dignity, trust, confidence and in good faith;¹¹
 - (e) co-operate with the reasonable requirements of any other party;
 - (f) ensure that communication is open and effective;
 - (g) ensure that the funding is only used for family care;
 - (h) recognise the unique dynamics of the home and family/whānau/aiga setting;
 - (i) comply with monitoring and auditing;
 - (i) comply with this Notice; and
 - (k) apply these principles at all times, especially when resolving any problems.

Disability support services

Eligibility criteria

- 14. A disabled person may receive payments for funded family care if they meet the following requirements:
 - (a) are eligible to receive disability support services under the Act; ¹² and
 - (b) are eligible for funded family care. 13

Rate and hours of funding

- 15. The hourly rate for funded family care is based on the adult minimum wage and other employer obligations. 14
- 16. The maximum allocation of funded family care is 40 hours a week for the disabled person.

Expected benefit

- 17. The Ministry expects that the funded family care will enable the disabled person to be cared for in their home and take part in family and community life.
- 18. The funded family care must also respect the specific and cultural needs of Māori, Pacifika and other ethnic groups. 15

Responsibilities of the Ministry

- 19. The Ministry is responsible ¹⁶ for:
 - (a) confirming that the family relationship between the disabled person and the family carer is one that is permitted by the funded family care operational policy;¹⁷
 - (b) approving the family carer;¹⁸
 - (c) ensuring that any special legal status between the disabled person and the family carer, to make personal care and welfare or property decisions for the disabled person, does not affect the provision of the funded family care; ¹⁹
 - (d) making timely payments;²⁰
 - (e) minimising, so far as practicable, compliance²¹ for the disabled person;
 - (f) assisting the disabled person if they want to change or stop the funded family care;
 - (g) arranging for assessment, evaluation, monitoring and auditing;
 - (h) stopping payments where the Ministry is notified and reasonably believes that requirements of the disability support services are not being met; and
 - (i) stopping payments if requested to do so by the disabled person.

Responsibilities of the disabled person

20. The disabled person is responsible for:

Managing the services

- (a) agreeing with the family carer their individual service arrangement;
- (b) ensuring that the family carer provides the funded family care;
- (c) ensuring that all payments²² are paid to the family carer and made only to the family carer;
- (d) ensuring that payments are made for replacement care when the family carer is unable to provide funded family care;
- (e) notifying the Ministry of any problems that affect delivery, safety or quality;
- (f) notifying the Ministry (urgently) if the disability support services become unsafe or are harmful to them;
- (g) notifying the Ministry of any change in the disabled person's circumstances that makes them not eligible for funded family care.

Complying with employment requirements

- (h) employing the family carer;
- (i) paying the family carer;
- (i) complying with all laws as an employer;²³

- (k) ensuring that payments relating to employment obligations are made;²⁴
- (1) resolving any employment problems;²⁵
- (m) ensuring that the family carer does not carry out any other paid work, outside the agreed hours of the disability support services, if that work is likely to affect the provision, safety or quality of those services;²⁶
- (n) ensuring that the employment contract covers at least the following matters:
 - (i) the family carer has the necessary skills and experience, and can successfully deliver the funded family care;
 - (ii) funded family care must be delivered according to the individual service arrangement, and in a safe and acceptable manner to the disabled person;
 - (iii) funded family care must be delivered in a manner that is culturally appropriate for the disabled person;
 - (iv) the Ministry's agent must be notified of any change in the family relationship between the disabled person and family carer (if it may affect eligibility);
 - (v) the Ministry must be notified (urgently) if the family carer is unable or unwilling to continue providing the disability support services;²⁷
 - (vi) funded family care must continue during any period of transition to other disability support services; and
 - (vii) that the family carer must comply with monitoring or auditing processes, and with any requirements following those processes.

Complying with the Notice

- (o) advising the Ministry of their family relationship to the family carer;
- (p) advising the Ministry of any change in their family relationship to the family carer;
- (q) advising the Ministry of any special legal status with the family carer;²⁸
- (r) using the funding only for the purpose of paying the family carer;
- (s) using the funding only for the purpose of paying for replacement care (when required);
- (t) agreeing to allow the Ministry or the Ministry's agent to visit the home for any assessment, evaluation, monitoring and auditing; and
- (u) notifying the Ministry (in advance) if they wish to change or stop receiving funded family care.²⁹

Responsibilities of the family carer

- 21. The family carer is responsible for:
 - (a) providing funded family care of the required standard³⁰ to the disabled person; and
 - (b) complying with any responsibility that involves them.

Responsibilities for replacement care

- 22. The person providing replacement care is responsible for:
 - (a) providing funded family care to the disabled person; and
 - (b) complying with any responsibility that involves them.

Responsibilities of the Ministry's agent

23. The Ministry's agent is responsible for the following respective matters:

NASC

- (a) assessing the disability support service needs of the disabled person;³¹
- (b) reviewing information that is provided about the disabled person;
- (c) conducting a review if they decide that the disabled person may not be eligible, or if the disabled person requests a review;³²
- (d) monitoring the delivery of the funded family care;
- (e) assisting with requests for exceptions to the eligibility for funded family care; and
- (f) advising the Ministry, disabled person and family carer of any matter that the Ministry's agent reasonably believes is not in the best interests of the disabled person.

Host

- (g) providing:
 - (i) assistance with the set-up of the funded family care;
 - (ii) assistance to the disabled person and family carer to develop an individual service arrangement; and
 - (iii) initial and on-going advice on the employment relationship.

Collective responsibility of all parties

- 24. All parties are responsible for complying with this Notice (as appropriate to them).
- 25. All parties are responsible for complying with the Ministry's *Funded Family Care Operational Policy* (as appropriate to them).
- 26. All parties are responsible for notifying the Ministry when any circumstance occurs where the Ministry may decide to stop payment; notification must be made as soon as reasonably possible.³³

Individual service arrangement and back-up arrangement

- 27. The disabled person must have an individual service arrangement.³⁴
- 28. The individual service arrangement must be:
 - (a) discussed with the Ministry's agent before it is completed;
 - (b) specific to the disabled person in their home;
 - (c) kept up to date;

- (d) kept at home; and
- (e) provided (copy only) to the Ministry's agent after it has been signed.³⁵
- 29. The disabled person must have a back-up arrangement that:
 - (a) ensures the continued delivery of the funded family care;³⁶ and
 - (b) notes any change to the employment relationship.

Authorisation and payment

- 30. Before the disabled person can receive payment, the Ministry must be satisfied that:
 - (a) they are eligible to receive Ministry funded disability support services;
 - (b) they are eligible to receive funded family care;
 - (c) their documentation is completed properly;
 - (d) the family member is eligible to be a family carer;
 - (e) the individual service arrangement has been completed, and signed;
 - (f) the disabled person and the family carer understand all their responsibilities; and
 - (g) there is an employment agreement in place.

Invoicing and payment

- 31. The Ministry will, each fortnight, use buyer created tax invoices.³⁷
- 32. Payment will be made fortnightly in arrears.³⁸
- 33. The first payment must be backdated to the start date.³⁹
- 34. To receive payment, the disabled person must:
 - (a) provide the Ministry with:
 - (i) details of their bank account; 40 and
 - (ii) their goods and services number (if they are registered for GST); and
 - (b) notify the Ministry of any changes to those details immediately they occur.
- 35. If the disabled person dies while receiving funded family care, the Ministry must pay the family carer directly; payment will be for 28 days. 41

Stopping payments or imposing conditions

- 36. The Ministry must stop payments:
 - (a) if the disabled person requests;
 - (b) if the funded family care is not being provided by the family carer;
 - (c) if the disabled person is in hospital, overseas, or is otherwise temporarily not receiving the funded family care;⁴²
 - (d) if the Ministry's agent notifies the Ministry (after first discussing the matter with the disabled person and family carer);
 - (e) if the disabled person, family carer or person providing replacement care fails to co-operate with any monitoring or audit process;
 - (f) if the funded family care is not being provided by the family carer during an employment dispute;
 - (g) if there is a breach of the individual service arrangement;
 - (h) if there is a breach of this Notice by the disabled person or the family carer; or
 - (i) if the disabled person dies while receiving funded family care.
- 37. Instead of stopping payment, the Ministry may require the disabled person or family carer to comply with conditions before payment will be made.
- 38. The Ministry must discuss those conditions with all parties before they are required.

Recovering over-payments

- 39. The Ministry must recover, where reasonable, any over-payments:
 - (a) firstly, from other payments (that the Ministry may make to, or on behalf of, the disabled person); and
 - (b) secondly, as an amount due and owing from the disabled person.

Resolving problems

- 40. The disabled person must try and resolve any problems in the following order:
 - (a) directly with their family carer;
 - (b) with the assistance of any other member of the family/whānau/aiga;
 - (c) with the assistance of any friend; and
 - (d) with the assistance of the Ministry's agent.
- 41. The resolution of problems must take account of the principles and (if helpful to the parties) follow the complaints procedure. 43
- 42. If the problem is an employment one, the disabled person and the family carer must try to resolve the problem themselves.⁴⁴

Changing or stopping the funded family care

- 43. The disabled person, or the family carer, may request that:
 - (a) the funded family care be stopped; or
 - (b) the funded family care be stopped and an alternative disability support service be provided.
- 44. Requests for changes to, or stopping, the disability support services must be agreed to or acknowledged by the Ministry.

Review

- 45. The NASC must conduct a review:
 - (a) when requested by the disabled person; or
 - (b) if the NASC reasonably considers that a review is appropriate.
- 46. A review may cover:
 - (a) the number of hours initially allocated, if they were less than 40 a week;
 - (b) whether the funded family care is appropriate to the needs of the disabled person;
 - (c) whether the funded family care is being delivered according to the individual service arrangement; and
 - (d) any other matter directly related to funded family care as agreed by the parties.
- 47. The review must be done according to the Needs Assessment and Service Coordination operational policy and the manager's manual. 45

Information and records

- 48. The disabled person must keep, at home, a copy of the individual service arrangement.
- 49. The disabled person, family carer or Ministry's agent must provide, to the Ministry, the information in the Appendix.
- 50. The Ministry must ensure that it protects and keeps confidential all information held about the disabled person and family carer. 46
- 51. The Ministry must only use information about the disabled person and family carer for any matter relevant to the funded family care.

Monitoring, auditing and stopping payment

- 52. The Ministry must monitor and audit the delivery, safety and quality of the funded family care. 47
- 53. Monitoring and auditing may be carried out either following the Ministry's own decision, or at the request of any other party.
- 54. Monitoring and auditing may:
 - (a) appraise the individual service arrangement;
 - (b) verify that payments are accurate, have been received, and are being used properly; and
 - (c) confirm that all requirements have been complied with.
- 55. The disabled person, the family carer, and the person providing replacement care (if applicable) must co-operate with proposed monitoring or auditing by:
 - (a) allowing access (on reasonable notice⁴⁸) to their home, and any other location where funded family care is being provided;
 - (b) producing the individual service arrangement;
 - (c) producing any other relevant documents (listed in the Appendix as appropriate); and
 - (d) being available for interview.
- 56. The Ministry must ensure that monitoring and auditing does not unreasonably disrupt the provision of the funded family care.
- 57. The Ministry must allow a reasonable opportunity for the disabled person, family carer and person providing replacement care (if applicable) to comment on any draft monitoring and auditing reports, and take account of those comments in the final report.

Emergency and exceptional circumstances

- 58. This Notice does not apply to the delivery of funded family care in any circumstances which are an emergency or are exceptional.⁴⁹
- 59. Where those circumstances do occur, all parties may take any action that they consider is reasonable in the circumstances and which is in the best interests of the disabled person.⁵⁰

Construction (aids to reading this Notice)

- 60. Parts of this Notice are called:
 - (a) Clauses (eg 1, 3, and 8);
 - (b) Paragraphs (eg (a), (b), and (c)); and
 - (c) Subparagraphs (eg (i); (i)i; and (iii)).
- 61. References to funded family care have been kept to a minimum; if the term is not used, it is implied where appropriate.
- 62. References to *funded family care* mean disability support services under this Notice (for example, the phrases "provided to the disabled person" or "provided by the family carer" have not been expressly used, and are implied).
- 63. References to rights, responsibilities and requirements relate to those required by this Notice (for example, the phrases "of this Notice", "under this Notice" or "in accordance with this Notice" have not been expressly used in most places, and are implied)
- 64. There are no cross references to other clauses, it is intended that the Notice be read as a whole.
- 65. Requests to the Ministry can be made:
 - (a) by the disabled person at any time, and verbally;
 - (b) by the authorised representative; or
 - (c) by the Ministry's agent.
- 66. Notification between the disabled person and the Ministry should preferably be in writing⁵¹ and to:
 - (a) the Ministry's contact point on the individual service arrangement; or
 - (b) the Ministry's agent on the individual service arrangement.

- 67. All references to steps which the Ministry may take are at the Ministry's discretion.
- 68. The singular includes the plural, and vice versa.
- 69. Endnotes are part of this Notice but are intended only to assist in the explanation of a specific matter in the text.
- 70. Definitions apply to the endnotes where applicable.
- 71. Any term not defined has its meaning in the New Zealand Public Health and Disability Act 2000.⁵²

Definitions

72. The following terms have the meanings given to them:

all parties – Ministry, disabled person, family carer, Ministry's agent, and person providing replacement care (if applicable), together or separate where appropriate;

authorised representative – the person who has the legal authority to make personal care and welfare decisions, or property decisions, or both, for the disabled person under the Protection of Personal and Property Rights Act 1988; or other legal authority (this person may also be called the *advocate* in the Ministry's *Funded Family Care Operational Policy*);

disability support services – disability support services under section 6(1) of the New Zealand Public Health and Disability Act 2000;

disabled person – a person who is 18 years of age or over receiving the funded family care;

family carer⁵³ – the family member⁵⁴ who is approved by the Ministry, and employed by the disabled person, to provide the funded family care;

funded family care – the policy made by the Government under Part 4A of the New Zealand Public Health and Disability Act 2000; and includes the Ministry's *Funded Family Care Operational Policy*, this Notice, guidelines and related resources referring to *funded family care*, 55 which is published on www.health.govt.nz;

home – the disabled person's usual place of residence, or any other place where the disability support services are regularly provided (including outdoor activities and community based activities that are directly related to the funded family care);

Host – the Ministry's agent providing assistance with the set-up of the funded family care arrangements and initial and ongoing advice on the employment relationship;

individual service arrangement – the arrangement of personal care or household tasks, or both, for the disabled person, recorded in the template in the Ministry's *Funded Family Care Operational Policy*, guidelines, and related resources, (the individual service arrangement is called the Individual Service Plan in that Policy);

Ministry – Ministry of Health (representing the Crown);

Ministry's agent⁵⁶ – the Ministry's contracted service provider including:

- (a) the NASC, which work with disabled people to help identify their needs and coordinate their disability services; and
- (b) the Host;

Monitoring – as set out in the Ministry's *Funded Family Care Operational Policy*;

NASC - Needs Assessment and Service Co-ordination agencies; and

replacement care – funded family care, provided by another person when the family carer is unable to provide that care, for example when the family carer is on leave.

Information to be provided to the Ministry

The following information must be provided to the Ministry:

- (a) the identity and age of the family carer;
- (b) the relationship of the family carer to the disabled person;
- (c) confirmation that the family carer is physically capable of providing the services;
- (d) that the family carer has the necessary skills, qualifications and or experience to provide the services;
- (e) bank account details of the disabled person;
- (f) the GST number of the disabled person (if they are registered for GST);
- (g) individual service arrangement; and
- (h) any written record of any assessment, evaluation, monitoring, and auditing.

Justice

Anti-Money Laundering and Countering Financing of Terrorism Act 2009

Ministerial Exemptions under the Anti-Money Laundering and Countering Financing of Terrorism Act 2009

In accordance with section 159(3) of the Anti-Money Laundering and Countering Financing of Terrorism Act 2009 ("the Act"), the Minister of Justice hereby gives notice that she has granted the following exemptions from the Act:

Ministerial Exemption: JPMorgan Chase Bank, N.A. (New Zealand Branch)

- As the Minister of Justice and pursuant to section 157 of the Anti-Money Laundering and Countering Financing of Terrorism Act 2009 ("the Act"), I exempt the reporting entity JPMorgan Chase Bank, N.A. (New Zealand Branch) ("JPMorgan") from section 56(2) of the Act in so far as the Anti-Money Laundering and Countering Financing of Terrorism (AML/CFT) compliance officer must be an employee of the reporting entity. The exemption is approved in this case, allowing the AML/CFT compliance officer to be an employee of an Australian entity.
- 2. The AML/CFT compliance officer intends to maintain a strong relationship with the New Zealand reporting entity's senior management and have clear reporting lines. New Zealand staff should have access to the Sydney-based officer in order to report suspicious circumstances that may arise, and the officer maintain appropriate qualifications and knowledge, and proper access to key information and adequate resources.
- 3. This exemption has been granted as there are low risks of money laundering and terrorist financing associated with this specific exemption.
- 4. All other provisions apply. I particularly draw your attention to section 56(4) of the Act which states "The AML/CFT compliance officer must report to a senior manager of the reporting entity".
- 5. This exemption may be applied to successor(s) to the current AML/CFT Compliance Officer.
- This exemption comes into force on the day after the date I grant this exemption (granted 8 September 2013).
- This exemption will expire on 30 June 2018, and/or if the conditions of the exemption are breached.

Ministerial Exemption: Hallmark Life Insurance Company and Hallmark General Insurance Company Limited

1. As the Minister of Justice and pursuant to section 157 of the Anti-Money Laundering and Countering Financing

- of Terrorism Act 2009 ("the Act"), I provide Hallmark Life Insurance Company Limited and Hallmark General Insurance Company Limited with partial exemptions from the provisions of the Act in relation to the provision of consumer life insurance policies under which consumer credit insurance with a life cover component are offered to customers. The exemptions specifically cover Part 2 of the Act.
- 2. This exemption is not subject to any conditions.
- These exemptions have been made for the following reasons:
 - (a) The compliance burden to which both entities would be subjected if this exemption was not granted would be disproportionate to the money laundering and terrorist financing risks involved in the products offered.
 - (b) The low dollar value of the amounts involved.
 - (c) The loans to which these consumer life policies relate will have been checked and verified from an anti-money laundering perspective by the underlying credit providers.
 - (d) According to international findings, consumer life policies are considered to be lower risk products for money laundering and terrorist financing.
- 4. This exemption comes into force on the day after the date I grant this exemption (granted 8 September 2013).
- 5. This exemption will expire on 30 June 2016.

Ministerial Exemption: Hallmark Life Insurance Company Limited

- 1. As the Minister of Justice and pursuant to section 157 of the Anti-Money Laundering and Countering Financing of Terrorism Act 2009 ("the Act"), I partially exempt Hallmark Life Insurance Company Limited from the provisions of the Act in relation to the provision of current term life policies in run-off. This exemption specifically covers Part 2 of the Act.
- 2. This exemption is not subject to any conditions.
- 3. This exemption has been made for the following reasons:
 - (a) Sales of your term life policies were discontinued in 2008 and are currently in run-off.
 - (b) The compliance burden to which Hallmark would be subjected if this exemption was not granted would be disproportionate to the money laundering and terrorist financing risks involved with these products.
 - (c) The loans to which these term life policies relate will have been checked and verified from an anti-money laundering perspective by the underlying credit providers.
 - (d) According to international findings term life policies, are considered to be lower risk products for money laundering and terrorist financing.

- 4. This exemption comes into force on the day after the date I grant this exemption (granted 8 September 2013).
- 5. This exemption will expire on 30 June 2018.

Ministerial Exemption: GE Group

- 1. As the Minister of Justice and pursuant to section 157 of the Anti-Money Laundering and Countering Financing of Terrorism Act 2009 ("the Act"), I exempt the following reporting entities (together referred to as "GE Group") from paragraph (d)(i) of the definition of "designated business group" in the Act:
 - (a) Custom Fleet NZ;
 - (b) GE Finance and Insurance;
 - (c) GE Commercial Finance NZ; and
 - (d) GE Commercial Finance (USD) New Zealand.
- 2. This exemption is made subject to the following conditions:
 - (a) GE Group is required to otherwise satisfy all other requirements of the definition of a "designated business group";
 - (b) all the reporting entities which comprise the GE Group continue at all times to share the same common ownership and control; and
 - (c) all other provisions of the Act apply.
- 3. This exemption has been made for the following reasons:
 - (a) There are low risks of money laundering and terrorist financing associated with this specific exemption.
 - (b) The exemption is a technical exemption.
 - (c) All other provisions of the Act apply.
 - (d) The GE Group understands the requirements of the Act and is reviewing its current programme to ensure that it complies in time for the Act's inception.
 - (e) The burden of compliance costs on GE Group if the exemption was not granted would be unintended and significant.
- 4. This exemption comes into force on the day after the date I grant this exemption (granted 8 September 2013).
- 5. This exemption will expire on **30 June 2018**, and/or if the conditions of the exemption are breached.

Ministerial Exemption: New Zealand Harbours Superannuation Plan

- 1. In my capacity as the Minister of Justice and pursuant to section 157 of the Anti-Money Laundering and Countering Financing of Terrorism Act 2009 ("the Act"), I partially exempt:
 - (a) the Trustees of the New Zealand Harbours Superannuation Plan ("the Plan"); and
 - (b) the Rail and Maritime Transport Union ("the Union") as the principal promoter of the Plan and those members of the National Management Committee of the Union who are not Trustees and are therefore also promoters ("the Promoters")

from the provisions of Part 2 of the Act in relation to services provided in respect of the Plan. In order to provide consistency and eliminate risks of money-laundering, the specific provisions referred to below in paragraph 2 will still remain in force in relation to transfers to the Plan from international sources.

- 2. This exemption is subject to the following conditions:
 - (a) The Trustees are required to remove any mechanisms contained in the Trust Deed for the

- New Zealand Harbours Superannuation Scheme that enable members to contribute to the Scheme voluntarily other than through payroll.
- (b) The Trustees are required to introduce a cap on voluntary contributions made (other than those made through payroll) to the New Zealand Harbours KiwiSaver Scheme. The cap should be set at the amount required to enable a member to maximise those government contributions set out in section MK 4 of the Income Tax Act 2007.
- (c) With the exception of Australian superannuation transfers to the New Zealand Harbours KiwiSaver Scheme, Customer Due Diligence in accordance with sections 10–36 of the Act and suspicious transaction reports in accordance with sections 40–48 of the Act are required on all transfers to the Plan from international sources.
- The exemption has been granted for the following reasons:
 - (a) The Trustees' and the Promoters' only duties as reporting entities under the Act are in respect of the Plan;
 - (b) the Plan poses a very low risk of money laundering or terrorism financing;
 - (c) any risks posed by voluntary contributions outside of payroll have been covered off by conditions;
 - (d) due to the very low money laundering and terrorism financing risks raised by the Plan and the significant compliance costs that would arise from not granting this exemption, I consider that any benefits of requiring compliance with the Act are not justified given the associated costs; and
 - (e) this exemption is consistent with (and has no effect on the purpose or intent of) the Act, the Financial Transactions Reporting Act 1996 and New Zealand's international obligations as a member of the Financial Action Taskforce and the Asia Pacific Group on Money Laundering.
- 4. This exemption comes into force on the day after the date I grant this exemption (granted 8 September 2013).
- 5. This exemption will expire on 30 June 2018.

Ministerial Exemption: Seafarers Retirement Schemes

- 1. In my capacity as the Minister of Justice and pursuant to section 157 of the Anti-Money Laundering and Countering Financing of Terrorism Act 2009 ("the Act"), I partially exempt the Trustees of:
 - (a) the Seafarers Retirement Fund ("the SRF"); and
 - (b) the Seafarers Retirement Fund KiwiSaver Scheme ("the SRFKS");

together referred to as ("the Schemes") from the provisions of Part 2 of the Act in relation to services provided in respect of the Schemes. In order to provide consistency and eliminate risks of money-laundering, the specific provisions referred to below in paragraph 2 will still remain in force in relation to transfers to the Schemes from international sources.

- 2. This exemption is subject to the following conditions:
 - (a) The Trustees are required to remove any mechanisms contained in the Trust Deed for the SRF that enable members to contribute to the SRF voluntarily other than through payroll.
 - (b) The Trustees are required to introduce a cap on voluntary contributions made (other than those made through payroll) to the SRFKS. The cap should be set at the amount required to enable a member to

- maximise those government contributions set out in section MK 4 of the Income Tax Act 2007.
- (c) With the exception of Australian superannuation transfers to the SRFKS, customer due diligence in accordance with sections 10–36 of the Act and suspicious transaction reports in accordance with sections 40–48 of the Act are required on all transfers to the Schemes from international sources.
- 3. The exemption has been granted for the following reasons:
 - (a) The Trustees' only duties as a reporting entity under the Act are in respect of the Schemes;
 - (b) the Schemes pose a very low risk of money laundering or terrorism financing;
 - (c) any risks posed by voluntary contributions outside of payroll have been covered off by conditions;
 - (d) due to the very low money laundering and terrorism financing risks raised by the Schemes and the significant compliance costs that would arise from not granting this exemption, I consider that any benefits of requiring compliance with the Act are not justified by the associated costs; and
 - (e) this exemption is consistent with (and has no effect on the purpose or intent of) the Act, the Financial Transactions Reporting Act 1996 and New Zealand's international obligations as a member of the Financial Action Taskforce and the Asia Pacific Group on Money Laundering.
- 4. This exemption comes into force on the day after the date I grant this exemption (granted 8 September 2013).
- 5. This exemption will expire on 30 June 2018.

Ministerial Exemption: The New Zealand Guardian Trust Company Limited

- 1. As the Minister of Justice and pursuant to section 157 of the Anti-Money Laundering and Countering Financing of Terrorism Act 2009 ("the Act"), I exempt The New Zealand Guardian Trust Company Limited (NZGT) (and any of its wholly owned subsidiaries ("NZGT Subsidiary") and any other person that may be nominated by the Crown ("Crown Nominee") to perform one or more of the activities described in this exemption), in relation to NZGT's role as instalment receipt trustee for the initial public offer by the Crown of shares in Meridian Energy Limited ("Meridian"), from the Act.
- 2. This exemption has been made for the following reasons:
 - (a) For commercial reasons, the share offer by the Crown of shares in Meridian Energy Limited (the share offer) will be structured to allow investors to buy shares using a "split payment" method:
 - (i) Investors subscribe for the amount of shares they wish to hold in Meridian, but instead of paying the full subscription amount and receiving their shares straight away, investors will instead pay some of the purchase price upfront and receive an "instalment receipt" of the shares subscribed to;
 - (ii) Each instalment receipt entitles the holder to a share upon the Crown receiving a final instalment at a specified date in the future;
 - (iii) NZGT or an NZGT Subsidiary will hold the shares on trust for investors until the final instalment is required to be paid, following which the shares will be released;
 - (b) In relation to NZGT's role as instalment receipt trustee for the share offer, NZGT (or an NZGT

- Subsidiary) may have to perform a number of financial activities, in relation to:
- (i) paying any dividends to the instalment holders;
- (ii) enforcing payment to the Crown of an outstanding instalment and applying the recovered amounts to the Crown and certain other persons as set out in the trust deed;
- (iii) transferring ownership of shares once the final instalment is received;
- (c) If there are any unpaid amounts still owing after the date the final instalment is due, the Crown Nominee may be directed to carry out one or more of the financial activities described in this exemption in relation to recovering the unpaid amount rather than NZGT.
- (d) An exemption is justified because:
 - (i) If Meridian were to offer shares itself, it is unlikely that Meridian would be subject to any Anti-Money Laundering and Countering Financing of Terrorism (AML/CFT) obligations; it is largely a result of the different structure necessary to accommodate a split payment option that AML/CFT obligations apply to the share offer;
 - (ii) If the Crown were to issue the instalment receipts, although these instalment receipts could result in funds being repayable to the public in the event that the final instalment is not paid, it is likely that the exemption in Regulation 23 of the Anti-Money Laundering and Countering Financing of Terrorism (Definitions) Regulations 2011 would apply;
 - (iii) Granting an exemption would not have a material impact on the risks of money laundering or terrorist financing given there is no material difference in such risks between the share offer and an offer where the Crown offered the instalment receipts itself;
 - (iv) There would be undue compliance difficulties and costs if NZGT (or an NZGT Subsidiary or Crown Nominee) were required to comply with AML/CFT obligations, for example:
 - (A) performing customer due diligence on the potentially large numbers of investors where investors also have the ability to trade the receipts on the secondary market;
 - (B) the finite period of time that NZGT will be instalment receipt trustee;
 - (v) There are no clear reasons justifying different regulatory treatment between the share offer and an offer where the Crown offered the instalment receipts itself, and in the absence of an exemption this may result in a competitive disadvantage for the share offer;
 - (vi) Accordingly an exemption from the Act for NZGT (or an NZGT Subsidiary or Crown Nominee) in respect of NZGT's activities as instalment receipt trustee is justified.
- 3. This exemption comes into force on the day after the date I grant this exemption (granted 17 September 2013).
- 4. This exemption will expire on 30 June 2018.

Deer Industry New Zealand Regulations 2004

Deer Industry New Zealand Levy Rates

1. Deer Industry New Zealand (DINZ) is a marketing authority established by Regulation 4 of the Deer Industry New Zealand Regulations 2004.

2. DINZ levy

- 2.1 Under Regulation 18(1) of the Deer Industry New Zealand Regulations 2004, DINZ fixes the rates of DINZ levy (which levy rates are exclusive of goods and services tax imposed by the Goods and Services Tax Act 1985) as follows:
 - (a) On venison derived from deer, other than fallow deer, slaughtered in deer slaughtering premises, on the basis of hot clean carcass weight after removal of condemned parts:

- 19 cents (nineteen cents) per kilogram for the period 1 October 2013 to 30 September 2014.
- (b) On venison derived from each fallow deer slaughtered in deer slaughtering premises, on the basis of hot clean carcass weight after removal of condemned parts:
 - 12 cents (twelve cents) per kilogram for the period 1 October 2013 to 30 September 2014.
- (c) On velvet from deer other than fallow deer received at a packing house for processing or packing, on a frozen weight basis:
 - 325 cents (three hundred and twenty-five cents) per kilogram.
- (d) On velvet from fallow deer received at a packing house for processing or packing, on a frozen weight basis:
 - 90 cents (ninety cents) per kilogram.
- 2.2 For the purpose of paragraphs 2.1(a) and 2.1(b) above, hot clean carcass weight is defined in the DeerQA Venison Processors Industry Agreed Standards (dated 21 July 2003) at Standard IAS-3: Venison Standard Carcass. This document is available on request from Deer Industry New Zealand by telephone (04) 473 4500 or mail to PO Box 10702, Wellington.
- 2.3 The levy rates described in paragraphs 2.1(a) and 2.1(b) above are payable by the owner at the time of slaughter. However, where the venison is sold at the time of slaughter to a venison processor or venison marketer (as defined in Regulation 3 of the DINZ Regulations 2004):
 - (a) the portions of the levy on such venison that are allocated to TB free New Zealand (as described in paragraph 9.2 below) shall remain payable by the owner at the time of slaughter;
 - (b) the remainder of the levy payable on such venison shall be payable in equal shares by the owner at the time of slaughter and the venison processor or venison marketer.
- 2.4 No levy is payable on velvet when the value of the applicable velvet grade, as defined by the Industry Agreed Grading Guidelines, is less than or equal to \$15.00/kg (GST exclusive).
- 2.5 If the deer slaughtering premises (DSP) or packing house (PH) (formerly game packing house) fails to keep accurate records relating to the DINZ levy or to file accurate returns relating to the DINZ levy, then

- the levy payable will be assessed by DINZ with reference to such information as DINZ considers fit.
- 3. DSPs are not required to collect levies on Tb reactors but will be required to report the number of reactor deer slaughtered to DINZ in their monthly returns. The levy will be waived for those Tb reactors which are identified with an official reactor tag and where they arrive at the DSP accompanied by an official permit to move.
- **4.** A nil rate of levy applies to any farmed deer or killed game deer carcasses which are wholly condemned for any reason following slaughter or receipt into a PH.
- 5. No levy is payable in respect of any one farmed deer carcass or piece of velvet more than once.
- **6.** These rates of levy come into effect on and from 1 October 2013 and apply until 30 September 2014, or until such time as new levy rates are fixed and come into force.
- 7. Under Regulation 19, notice is given that DINZ fixes the rate of additional levy payable in respect of failure to pay, or late payment of, amounts of levy payable on or after 1 October 2013 at 10 per cent of the amount of levy unpaid.
- **8.** The additional levy for failure to pay or late payment may be applied by DINZ at a rate of 10 per cent on the outstanding balance following expiration of the period within which payment is required to be received by DINZ, and is payable by the DSP or PH concerned.
- 9. Of the DINZ levy, a portion will be paid to TBfree New Zealand as the deer industry's contribution to TBfree New Zealand's activities under the national pest management strategy for bovine tuberculosis. The DINZ levy will be broken down as follows:
- 9.1 For Deer Industry New Zealand:
 - Venison (fallow) 7 cents per kilogram.
 - Venison (other) 14 cents per kilogram.
 - Velvet (fallow) 40 cents per kilogram.
 - Velvet (other) \$2.75 per kilogram.
- 9.2 For TBfree New Zealand:
 - Venison 5 cents per kilogram.
 - Velvet 50 cents per kilogram.
