 - details of factory cost in terms of materials, labour, overheads, including the proportion of domestic and imported content.
- 3 Where further information is required in order to make a submission an objector should contact the applicant in writing and refer a copy of the enquiry to the New Zealand Customs Service quoting the details in paragraph 1 above.

Dumping and Countervailing Duties Act 1988

Reassessment of Anti-Dumping Duty: Diaries From The People's Republic of China and Malaysia

Pursuant to section 14(6) of the Dumping and Countervailing Duties Act 1988 ("the Act"), the Associate Minister of Commerce, having carried out a reassessment of the anti-dumping duty applying to imports into New Zealand of diaries from The People's Republic of China and Malaysia, following the completion of a review under section 14(8) of the Act, and having determined new rates of anti-dumping duty applicable to those goods, gives the following notice.

Notice

Title and commencement—(1) This notice may be cited as the "Reassessment of Anti-Dumping Duty: Diaries from The People's Republic of China and Malaysia".

(2) This notice replaces and supersedes all previous notices in relation to the subject goods described below in the First Schedule.

(3) Pursuant to section 17 of the Act, the reassessed anti-dumping duty, set out in the Second Schedule to this notice, shall apply to imports of the goods specified in the First Schedule with effect from the day after the date of this notice.

(4) Pursuant to section 17 of the Act, the reassessed anti-dumping duty, set out in the Third Schedule to this notice, shall apply to imports of the goods specified in the First Schedule with effect from 1 February 2014.

(5) Where the anti-dumping duties imposed as a result of this notice are lower than those previously in place, in accordance with subsection 14(10) of the Act, importers may apply to Customs for a refund of the difference between the anti-dumping duties imposed by this notice and the anti-dumping duty paid from 7 October 2012.
