#### Direction to Callaghan Innovation—Criteria for Assessing Proposals for Funding

Under section 103 of the Crown Entities Act 2004, I direct Callaghan Innovation to give effect to Government policy as specified in this direction.

#### INTRODUCTION

In this direction, I set criteria for Callaghan Innovation to adhere to for assessing proposals for Research, Science and Technology (R,S&T) funding. This notice uses the following format:

- R,S&T Funding decided by Callaghan Innovation.
- Criteria to be applied.
- Administrative processes.
- Transitional provisions.

#### R,S&T FUNDING DECIDED BY CALLAGHAN INNOVATION

Funding allocated by Callaghan Innovation may be allocated from any of the following multi-year appropriations:

- Research and Development Growth Grants (for Research and Development Growth Grants).
- Targeted Business Research and Development Funding (for Research and Development Project Grants and Research and Development Student Grants).

#### CRITERIA TO BE APPLIED

Callaghan Innovation must make funding decisions in accordance with the:

- Public Finance Act 1989;
- parameters specific to the business-led research and development (R&D) tool; and
- criteria specific to each initiative within the tool, which are:
  - o policy objectives;
  - o eligibility criteria;
  - o judgement criteria (if applicable); and
  - o parameters specific to the initiative (if applicable).

In addition to the criteria listed above, Callaghan Innovation must take into account the overall mix of relevant investments. Detailed criteria specific to each initiative are set out in more detail in the following sections.

#### ADMINISTRATIVE PROCESSES

Callaghan Innovation will:

- market the tool and provide easy to access public information explaining its features;
- actively seek out applicants from inside and outside the group of businesses it currently works with;
- develop and implement processes for vetting and auditing businesses to ensure that claimed research and development is legitimate;
- ensure that applicants and recipients of grants have access to complementary advice and services where appropriate;
- gather data on applicants during and following the grant period to support programme evaluation; and
- monitor funded businesses activities during and after the grant period and seek to claw-back (recover) funding as appropriate. Callaghan Innovation is expected to implement claw-back mechanisms.

Callaghan Innovation may issue standing or periodic calls to generate proposals for consideration. The calls for proposals will be consistent with the criteria in this direction, and will provide guidance for applicants. This guidance may include, where applicable:

- the area(s) of investment in which a funding decision is required;
- more detail as to how the criteria in this notice apply to the area of investment;
- the tool (or initiative within the tool) to be used;
- the amount of funding available;
- specific outcomes sought for a given investment process or decision; and
- other timeline and process information.

#### Criteria Specific to the Business-led R&D Tool

#### OVERALL POLICY OBJECTIVE

The objective of this tool is to increase New Zealand businesses' investment in research and development to support long-term economic growth.

#### **INITIATIVES**

Three initiatives sit within the business-led R&D tool:

- 1. Research and Development Growth Grants.
- 2. Research and Development Project Grants.
- 3. Research and Development Student Grants.

#### **BUSINESS ELIGIBILITY CRITERIA**

To be eligible for funding under this tool, the following criteria must be satisfied together with the eligibility criteria relevant to the specific initiative:

- Only businesses are eligible to receive funding via this tool. A business or group of businesses may nominate a representative to receive funding.
- A business must have at least one director who is resident in New Zealand and at least one of the following must be true:
  - The business is incorporated in New Zealand;
  - the business has a centre of management in New Zealand; or
  - o the business has a head office in New Zealand.
- Businesses may not be an entity established under or governed by the Education Act 1989, Crown Research Institutes
  Act 1992, Local Government Act 2002, Local Government (Auckland Council) Act 2009, the New Zealand Public
  Health and Disability Act 2000 or the Crown Entities Act 2004; or an entity that is 50 per cent or more owned by one or
  more of those types of entities.

#### **CLAWBACK PROVISIONS**

Businesses may be expected to return some or all grant funding, during or following a grant agreement, to Callaghan Innovation, if:

- the business breaches any grant agreement, misappropriates funding, provides incorrect information to Callaghan Innovation, or claims ineligible expenditure;
- the business enters into a contract or arrangement (including change of ownership) that materially reduces the current or future planned research and development activity in New Zealand; or
- the grant fund is unspent and for which contractual liabilities have not yet been incurred.

Criteria relating to each initiative are set out in the following sections.

#### 1. Research and Development (R&D) Growth Grants

#### POLICY OBJECTIVE

The objective of this initiative, in addition to the overall policy objective of the business-led R&D tool, is to provide a rule-based, market-led incentive for increasing R&D investment in businesses that are experienced in investing in R&D.

#### **ELIGIBILITY CRITERIA**

In addition to the BUSINESS ELIGIBILITY CRITERIA stated earlier, to be eligible to receive funding a business must:

- have had at least \$300,000.00 in eligible R&D expenditure (stated below) sourced from non-government funds in each of the two most recent years;
- have had eligible R&D expenditure of at least 1.5 per cent of revenues in each of the two most recent years;
- meet financial and management due diligence requirements sufficient to justify three years of funding; and
- provide Callaghan Innovation with a R&D plan including an estimate of R&D expenditures over the next three years. Businesses must compile the R&D plan to a level of detail and clarity sufficient to assess progress in the businesses' R&D programme over time.

Alternatively, a business that has not previously received a R&D Growth Grant may be eligible under the transitional eligibility criteria (stated below).

For R&D projects that were partially funded by government grants, the funding for the project that came from non-government sources is considered eligible R&D expenditure for the purpose of determining business eligibility.

While eligibility requires that applicants submit a R&D plan, the merits of the R&D programme described in the plan will not influence eligibility.

Entities that conduct or commission R&D activities mainly for other persons or businesses are likely to be ineligible due to insufficient eligible R&D expenditures.

#### ELIGIBILITY CRITERIA (TRANSITIONAL)

Transitional eligibility criteria will only apply for a business that has not previously received a R&D Growth Grant. No funding is payable by Callaghan Innovation unless the business actually reaches both the intended spend levels of at least \$300,000.00 per year on eligible R&D expenditure and at least 1.5 per cent of revenues per year on eligible R&D expenditure within the first year of the grant.

Notwithstanding the above ELIGIBILITY CRITERIA for R&D Growth Grants, and in addition to the BUSINESS ELIGIBILITY CRITERIA stated earlier, a business may be eligible to receive funding if the business:

- intends to spend at least \$300,000.00 per year on eligible R&D expenditure (stated below);
- has the necessary finance to spend at least \$300,000.00 per year on eligible R&D expenditure;

- intends to spend at least 1.5 per cent of revenues per year on eligible R&D expenditure;
- meets financial and management due diligence requirements sufficient to justify three years of funding;
- provides Callaghan Innovation with a R&D plan including an estimate of R&D expenditures over the next three years. Businesses must compile the R&D plan to a level of detail and clarity sufficient to assess progress in the businesses' R&D programme over time; and
- commits to and provides 3-monthly progress reports to Callaghan Innovation against the R&D plan for the first two years.

If the business does not achieve the intended spend levels within the first year of the grant, it will receive no funding and exit the initiative. The business will be ineligible to reapply for two years.

#### PARAMETERS SPECIFIC TO THIS INITIATIVE

All eligible applicants will receive a R&D Growth Grant for three years. Grant holders will receive up to 20 per cent of all eligible R&D expenditures incurred over the grant period up to a maximum of \$25 million of eligible expenditures per business, per year (maximum grant funding of \$5 million per business per year).

Businesses will be required to submit annual updates to their R&D plan and estimates. These plans must continue to be sufficiently detailed and clear.

Any business receiving a R&D Growth Grant that is found to be wilfully misreporting R&D expenditure at any point will be immediately removed from the initiative and will be ineligible to reapply for three years.

#### PARAMETERS SPECIFIC TO THIS INITIATIVE – EXTENSIONS

Two years into the grant period, grant holders will have the option of applying for a two-year extension on the grant. Grant holders will receive an extension if:

- the business' reported expenditure over the previous two years is found to meet the definition of eligible R&D expenditure (stated below);
- the business continues to meet the eligibility criteria (for the avoidance of doubt, the transitional eligibility criteria does not apply to extensions); and
- the business has maintained or increased non-government funded eligible R&D expenditure over the two years of the grant period as compared to the two years prior to the grant period.

If the business has reduced non-government funded eligible R&D expenditure but meets the other requirements, the Callaghan Innovation Board may still choose to grant the business an extension at its discretion. The Board should only do so in exceptional circumstances.

Businesses may continue to apply for, and receive, extensions every two years provided they continue to meet the requirements listed above.

Businesses that fail to receive an extension will receive a final year of grant funding and subsequently exit the initiative. Businesses that exit the initiative are not eligible to apply for another R&D Growth Grant for two years.

#### DEFINITION OF ELIGIBLE RESEARCH AND DEVELOPMENT EXPENDITURE FOR R&D GROWTH GRANTS

Eligible R&D expenditure is defined as those meeting the New Zealand Equivalent to International Account Standard 38 (NZ IAS 38) definition of research and development and expensed under that standard.

The NZ IAS 38 definitions of R&D are:

- Research is original and planned investigation undertaken with the prospect of gaining new scientific or technical knowledge and understanding.
- **Development** is the application of research findings or other knowledge to a plan or design for the production of new or substantially improved materials, devices, products, processes, systems or services before the start of commercial production or use.

#### **Clarifying Principle**

If necessary, when seeking to distinguish R&D from non R&D, the further advice provided by the New Zealand Financial Reporting Standard 13 (NZ FRS 13) should be applied:

• R&D is distinguished from non-R&D by the presence or absence of an appreciable element of innovation. If the activity departs from routine and breaks new ground it is normally R&D; if it follows an established pattern it is normally not R&D.

#### General Exclusions

The following types of expenditure are not eligible for the R&D Growth Grants initiative:

- any expenditure that is capitalised as an intangible asset under NZ IAS 38;
- R&D undertaken outside of New Zealand;
- R&D funded through an enforceable levy paid by another entity;
- enforceable levies for R&D paid to another entity; and
- any R&D funded by a grant or other payment provided by an entity that is not part of the same consolidated group of entities as the applicant. However, expensed funding for R&D contracted out by the applicant to another entity is eligible.

#### **Specific Exclusions**

To provide further clarification on the definition, some specific activities are excluded. This list is not exhaustive. Activities not specifically excluded are only eligible provided they meet all other features of the definition. Specific activities excluded are:

- Engineering follow-through in an early phase of commercial production.
- Activities related to the construction, relocation, rearrangement or start-up of facilities or equipment other than facilities or equipment solely used for the businesses' R&D (which may be included).
- Routine, on-going efforts to refine, enrich, or otherwise improve on the qualities of an existing product or process, or to make cosmetic or stylistic changes to it.

- Routine design of tools, jigs, moulds and dies, or seasonal or other periodic design changes to existing products. However, expensed design activities involved in developing a new product or process are eligible.
- Activities involved in ensuring that existing products or processes comply with statutory requirements or standards, and
  quality control, routine testing or trouble-shooting during commercial production. However, testing in search of
  significant product or process improvements is eligible.
- Adapting an existing product or process to a particular customer's need or site.
- Supporting, de-bugging or making minor improvements to existing computer software.
- Market research or surveys, market testing, market development or sales promotion, management studies, efficiency surveys or the routine collection of information.
- Any costs involved in protecting, licensing, selling or defending intellectual property or of acquiring or using external intangible assets (eg patent licences).
- Interest expenses or lease payments of any kind, and any overheads that are not closely linked to R&D activities. Eligible overheads include finance, personnel, training, travel, administration and library activities associated with R&D, and reasonable R&D-related transportation, storage, cleaning, repair, maintenance and security activities.
- Prospecting or exploring for minerals, petroleum, natural gas or geothermal energy.
- Research in the social sciences, arts or humanities.

#### 2. Research and Development (R&D) Project Grants

#### POLICY OBJECTIVES

The objectives of this initiative, in addition to the overall policy objective of the business-led R&D tool, are to:

- support greater investment by businesses in R&D activities and generate wider benefits to the New Zealand economy; and
- develop businesses with less established R&D programmes into stable and substantial R&D performers.

#### **ELIGIBILITY CRITERIA**

To be eligible for funding under this initiative the following criteria must be satisfied:

- Only businesses are eligible to receive funding via this initiative. A business or group of businesses may nominate a representative to receive funding.
- A business must have at least one director who is resident in New Zealand and at least one of the following must be true:
  - the business is incorporated in New Zealand;
  - the business has a centre of management in New Zealand; or
  - o the business has a head office in New Zealand.
- Businesses may not be an entity established under or governed by the Education Act 1989, Crown Research Institutes
  Act 1992, Local Government Act 2002, Local Government (Auckland Council) Act 2009, the New Zealand Public
  Health and Disability Act 2000, or the Crown Entities Act 2004; or an entity that is 50 per cent or more owned by one or
  more of those types of entities.

#### PARAMETERS SPECIFIC TO THIS INITIATIVE

#### DEFINITION OF ELIGIBLE RESEARCH AND DEVELOPMENT EXPENDITURE FOR R&D PROJECT GRANTS

Project grants fund research and development using the following definitions:

- Research is original and planned investigation undertaken with the prospect of gaining new scientific or technical knowledge and understanding.
- **Development** is the application of research findings or other knowledge to a plan or design for the production of new or substantially improved materials, devices, products, processes, systems or services before the start of commercial production or use.

R&D is distinguished from non-R&D by the presence or absence of an appreciable element of innovation. If the activity departs from routine and breaks new ground it is normally R&D; if it follows an established pattern it is normally not R&D.

#### RELATIONSHIP WITH R&D GROWTH GRANTS

- Businesses that receive a R&D Growth Grant will only be eligible for R&D Projects Grants if they undertake a "collaborative" R&D project.
- A collaborative R&D project is one where:
  - o at least two businesses (that are independent and not within common control) are undertaking a joint project for mutual benefit (each party is expected to gain value);
  - o at least one of the businesses is receiving a R&D Growth Grant;
  - o each business is contributing substantially to both the financial and technical requirements of the project; and
  - $\circ$  the project structure indicates the project has shared responsibility and decision-making.

#### **CO-FUNDING RATES**

Callaghan Innovation will determine the co-funding rate according to the following rules:

- R&D Project grants will typically provide funding for 30–50 per cent of the eligible R&D expenditure of a project.
- Collaborative R&D projects will only receive funding for 15–30 per cent of the R&D eligible expenditure on top of the R&D Growth Grant. If one of the contributing businesses does not have a R&D Growth Grant, the R&D Project Grant will typically provide funding for 30–50 per cent of their eligible expenditure.
- Callaghan Innovation must ensure the total annual funding allocated to all R&D Project Grants does not exceed 40 per cent of eligible expenditure.

- Criteria A–F must be the basis upon which Callaghan Innovation determines whether to provide a grant for a project.

  - o is studying a degree at NZQA levels 7 to 10 or equivalent; and
  - has appropriate immigration status at the time of application (or an application in progress that is subsequently approved).

#### DEFINITION OF ELIGIBLE EXPENDITURE FOR R&D STUDENT GRANTS

The eligible expenditure that may be incurred is limited to wages and salary of the student, a tax-free stipend for the student, a tertiary administration fee and, when the business is located a significant distance from the tertiary education institute, a travel allowance for the student.

- (b) a trustee of a trust or a funds manager, acting in that capacity, who has under that person's control, as trustee or funds manager, net assets of at least \$10 million; or
- (c) a person who is authorised to carry on the business of dealing in futures contracts under the Act; or
- (d) a person authorised in another jurisdiction by the competent authority of that jurisdiction to deal in futures contracts; or
- (e) Her Majesty The Queen in right of New Zealand, a Crown entity named in the Crown Entities Act 2004, or a State enterprise named in the First or Second Schedule to the State-Owned Enterprises Act 1986 (each as amended from time to time); or
- (f) a person who is a statutory corporation or a registered bank; or
- (g) a person whose principal business is the investment of money or who, in the course of and for the purposes of their business, habitually invests money; or
- (h) a person who is a related body corporate of any of the persons mentioned in subparagraphs (a) to (g) above.
- (2) Any term or expression that is defined in the Act and used, but not defined, in this notice has the same meaning as in the Act.
- **3. Authorisation for JPMAL**—(1) JPMAL is authorised to carry on the business of dealing in futures contracts generally.
- (2) The authorisation in clause 3(1) is subject to the conditions that:
  - (a) in respect of any futures contract to which the authorisation applies that is not a futures contract that is effected on a recognised exchange, JPMCB is a party to the futures contract; and
  - (b) JPMAL deals only on behalf of its wholesale clients;
  - (c) before dealing in any futures contract in respect of which the authorisation applies, JPMAL is satisfied on reasonable grounds that the wholesale client is contracting:
    - (i) as principal on its own account; or
    - (ii) on behalf of a related body corporate; or
    - (iii) as trustee of a trust or manager of a managed fund; and
  - (d) in respect of any futures contract that is made on or effected through a recognised exchange, any acquisition or disposal of the contract is effected through a person who is an authorised participant or member of the recognised exchange and who is authorised or licensed by the laws of the country in which it operates to deal in futures contracts on behalf of that person and to hold client money for that purpose; and
  - (e) JPMAL does not hold client money or client property in connection with dealing in futures contracts; and
  - (f) JPMAL is licensed as an Australian Financial Services Licensee under the Corporations Act and holds an AFS Licence which authorises JPMAL to provide futures advisory services to wholesale clients; and
  - (g) JPMAL notifies FMA if JPMAL's AFS Licence is varied or revoked and notifies FMA of any regulatory

  - (d) all client money and property held by JPMCB in connection with dealing in futures contracts is held in accordance with the client money and property protection provisions of the Corporations Act and the conditions of JPMCB's AFS Licence; and

### **New Zealand Racing Board**

#### Racing Act 2003

#### **Amendments to Betting Rules**

Pursuant to section 52 of the Racing Act 2003, the New Zealand Racing Board hereby gives notice of the following amendments to the Betting Rules published as a Supplement to the *New Zealand Gazette*, 25 August 2003, No. 113, page 2981.

#### Change #1

This is a new rule

#### 11.15 Triple Trio Betting with Concession

#### 11.15.1 Interpretation

In Rule 11.15, unless the context otherwise requires: –

"Triple Trio" is a bet type whereby the Investor endeavours to select the First Three Placings in any order in each of the three Races as designated by the Board.

"Dividend Pool" means the aggregate of all investments on a Triple Trio less the deductions for Triple Trio as designated in Appendix 1.

"Concession Pool" means 13.2 per cent of the Dividend Pool.

"First Prize Pool" means 74.8 per cent of the Dividend Pool, together with:

- (a) any previous First Prize Pool or Concession Pool which may have been carried forward in accordance with Rules 11.15.5 and 11.15.6; and
- (b) any part or all of the Prize Reserve Pool which may have been added to the First Prize Pool under Rule 11.15.7.

"Prize Reserve Pool" means 12 per cent of the Dividend Pool.

"First Three Placings" means the Race Entrants determined as the "First Entrant", "Second Entrant" and "Third Entrant" respectively according to the Official Result, provided that:

- (a) if the judge, stewards or judicial committee make an error regarding such determination and subsequently correct their error in accordance with the Rules of Racing, the First Three Placings shall be the Race Entrants which the judge, stewards or judicial committee, after correcting their error, determine to be the first three Entrants according to the Official Result;
- (b) the disqualification of any Race Entrants that have been placed among the first three Entrants shall not affect the determination of the First Three Placings for the purposes of Triple Trio betting if the disqualification resulted from a protest lodged after the expiration of the period allowed by the Rules of Racing for the lodging of such protests;
- (c) where a dead heat occurs, the First Three Placings shall be the first three Entrants determined as such according to the Official Result, except that:
  - (i) a dead heat between two or more Race Entrants may cause the number of Race Entrants eligible to fill the First Three placings to be more than three; and
  - (ii) where a dead heat occurs for a particular placing, all dead-heating Entrants shall be deemed to hold that placing and the immediate placing or placings below shall be skipped for the purpose of placing the other Entrants. For example, for a dead heat for second place the First Three Placings shall be as follows "first", "second", "second"; and
- (d) if the judge, stewards or judicial committee are unable or fail to determine the First Three Placings, the Board may determine the First Three Placings.

#### 11.15.2 Races upon which the Board may conduct Triple Trio betting

Triple Trio betting may be conducted on such Races as the Board may determine from time to time.

#### 11.15.3 Method of Triple Trio betting

A Triple Trio bet is placed by the Investor selecting at least three Race Entrants in each of the three Races of a Triple Trio.

#### 11.15.4 Dividend Pool

The Dividend Pool shall be distributed as follows:

- (a) 74.8 per cent of the Dividend Pool shall be allocated to the First Prize Pool;
- (b) 13.2 per cent shall be allocated to the Concession Pool; and
- (c) 12 per cent shall be allocated to the Prize Reserve Pool.

#### 11.15.5 First Prize Pool

Subject to Rule 11.15.8, the First Prize Pool shall be distributed as follows:

- (a) The First Prize Pool shall be distributed equally amongst those units of betting that have selected the First Three Placings in each of the three Races of a Triple Trio.
- (b) Where the sum of winning units of betting is less than the Dividend Unit, the First Prize Pool will be declared as the Dividend, and the winning units of betting will receive their proportional share of the First Prize Pool. The balance of the First Prize Pool, less any Prize Reserve funds, will be carried forward and added to the First Prize Pool of the next Triple Trio as determined by the Board.
- (c) If no units of betting have selected the First Three Placings in each of the three Races of a Triple Trio, the First Prize Pool in respect of that particular Triple Trio, less any Prize Reserve funds, shall be carried forward and added to the First Prize Pool of the next Triple Trio as determined by the Board.

#### 11.15.6 Concession Pool

Subject to Rule 11.15.12 relating to abandonment, the Concession Pool shall be distributed as follows:

- (a) The Concession Pool shall be distributed equally amongst those units of betting that have selected the First Three Placings in both of the first and second Triple Trio Races and failed to select the First Three Placings in the final Triple Trio Race. Note that this means that the entire Concession Pool will be paid out when the sum of successful units is less than the Dividend Unit.
- (b) If there are no units of betting that have selected the First Three Placings in both of the first and second Triple Trio Races, the Concession Pool shall added to the First Prize Pool and be dealt with in accordance with Rule 11.15.5.

#### 11.15.7 Prize Reserve Pool

The Board may allocate any part or all of the Prize Reserve Pool to the Dividend Pool of any bet type within the respective Code.

#### 11.15.8 Dead Heats

- (a) In the event of a dead heat for Third Place causing there to be more than Three Placings in any of the Races of a Triple Trio, all units of betting with the First Two Placings and either of the Race Entrants dead-heating for third shall be deemed to have the First Three Placings for the purpose of calculating the Dividend in accordance with Rules 11.15.5, 11.15.6, 11.15.11 and 11.15.12.
- (b) In the event of a triple dead heat for Second Place causing there to be more than Three Placings in any of the Races of a Triple Trio, all units of betting with the Winner and any two of the Race Entrants dead-heating for second shall be deemed to have the First Three Placings for the purpose of calculating the Dividend in accordance with Rules 11.15.5, 11.15.6, 11.15.11 and 11.15.12.

#### 11.15.9 Scratchings

Where a Race Entrant is Scratched from any of the three Races of a Triple Trio, the Board will substitute one of three alternative selections for that Entrant after the closing time for receipt of Triple Trio bets.

- (a) The first substitute will be used for those units of betting that have a scratching and do not already include the first substitute.
- (b) The second substitute will be used for those units of betting that have a scratching as well as the first substitute and do not already include the second substitute.
- (c) The third substitute will be used for those units of betting that have a scratching as well as both the first and second substitutes.

#### 11.15.10 Refunds

After the closing time for Triple Trio Investments, no Investor shall obtain a Refund except where all three of the Triple Trio Races have been abandoned, in accordance with Rule 11.15.12(d).

#### 11.15.11 Declaration of less than Three Placings

- (a) Where for any one of the Races of a Triple Trio the First Three Placings are incomplete;
  - (i) The Concession Pool shall be added to the First Prize Pool and the sum shall be distributed equally amongst those units of betting that have selected the First Three Placings in both of the remaining Triple Trio Races. Note that this means that the entire combined Concession and First Prize Pools will be paid out when the sum of successful units is less than the Dividend Unit.
  - (ii) If there are no units of betting that have selected the First Three Placings in both of the remaining Triple Trio Races, the combined Concession and First Prize Pools will be carried forward in accordance with 11.15.5(c).
- (b) Where for any two of the Races of a Triple Trio the First Three Placings are incomplete;
  - (i) The Concession Pool shall be added to the First Prize Pool and the sum shall be distributed equally amongst those units of betting that have selected the First Three Placings in the remaining Triple Trio Race. Note that this means that the entire combined Concession and First Prize Pools will be paid out when the sum of successful units is less than the Dividend Unit.
  - (ii) If there are no units of betting that have selected the First Three Placings in the remaining Triple Trio Race, the combined Concession and First Prize Pools will be carried forward in accordance with 11.15.5(c).
- (c) Where for all three of the Races of a Triple Trio the First Three Placings are incomplete, the Triple Trio will be abandoned and all units of betting will be refunded. Any amount brought forward to the First Prize Pool will Carry Forward in the same fashion as Rule 11.15.5(c).

#### 11.15.12 Abandonment of Races

For the purposes of Triple Trio betting, a race will also be considered "Abandoned" if the number of starters falls below three at any time. If any leg of a Triple Trio is Abandoned prior to the scheduled closing time for Triple Trio betting then the Triple Trio will be abandoned and all units of betting will be refunded. Any amount brought forward to the First Prize Pool will Carry Forward in the same fashion as Rule 11.15.5(c).

When an Abandonment occurs after the scheduled closing time for Triple Trio betting, the following rules shall apply:

- (a) Where any one of the Races of a Triple Trio is abandoned:
  - (i) The Concession Pool shall be added to the First Prize Pool and the sum shall be distributed equally amongst those units of betting that have selected the First Three Placings in both of the remaining Triple Trio Races. Note that this means that the entire combined Concession and First Prize Pools will be paid out when the sum of successful units is less than the Dividend Unit.
  - (ii) If there are no units of betting that have selected the First Three Placings in both of the remaining Triple Trio Races, the combined Concession and First Prize Pools will be carried forward in accordance with 11.15.5(c).
- (b) Where any two of the Races of a Triple Trio are abandoned:
  - (i) The Concession Pool shall be added to the First Prize Pool and the sum shall be distributed equally amongst those units of betting that have selected the First Three Placings in the remaining Triple Trio Race. Note that this means that the entire combined Concession and First Prize Pools will be paid out when the sum of successful units is less than the Dividend Unit.
  - (ii) If there are no units of betting that have selected the First Three Placings in the remaining Triple Trio Race, the combined Concession and First Prize Pools will be carried forward in accordance with 11.15.5(c).
- (c) Where all three of the Races of a Triple Trio are abandoned or all three of the races of a Triple Trio have exactly three starters, the Triple Trio will be abandoned and all units of betting will be refunded. Any amount brought forward to the First Prize Pool will Carry Forward in the same fashion as Rule 11.15.5.

#### Appendix #3

#### Percentage Priority Order for Percentage Triple Trio

The %PO for Percentage Triple Trio within each Triple Trio Race commences with those combinations involving the three lowest numbered Race Entrants, and continues in succession through those combinations with the two lowest numbered Race Entrants together with the fourth lowest, then the fifth lowest, then sixth lowest numbered Race Entrants and so on finishing with those combinations involving the two lowest numbered Race Entrant and the highest numbered Race Entrant. This order is then continued for the lowest and third lowest numbered Race Entrants together with the fourth lowest, then the fifth lowest, then the sixth lowest numbered Race Entrants and so on. This order continues until reaching the fourth highest and the third highest numbered race entrants together with the second highest, and then the highest numbered race entrants, and finishes with the combination containing the three highest numbered race entrants.

The %PO for those bets with a common first Race combination, keeps that first race combination fixed whilst proceeding through the Priority order (above) for combinations in the second Race.

The %PO for those bets with a common first and second Race combination, keeps that first and second race combination fixed whilst proceeding through the Priority order (above) for combinations in the third Race.

Example: For a Triple Trio bet with Race Entrants 1, 2, 3 and 4 Boxed in the first Triple Trio race, Race Entrants 1 and 2 the Bankers with 3 and 4 in the second, and Race Entrants 1 and 4 the Bankers with runners 2 and 3 in the third race, the %PO for these 16 combinations would be:
