  - the grounds on which objection is made (including reasons why the local product is a suitable alternative); present and potential output; details of factory cost in terms of materials, labour, overheads, including the proportion of domestic and imported content.
- Where further information is required in order to make a submission an objector should contact the applicant in writing and refer a copy of the enquiry to the Ministry of Economic Development quoting the details in paragraph 1 above.

#### **Dumping and Countervailing Duties Act 1988**

## Anti-dumping Duties: Notice That Anti-dumping Duties on Plasterboard From Thailand May Cease to Apply

Under section 14(9) of the Dumping and Countervailing Duties Act 1988 ("the Act"), anti-dumping duties imposed on plasterboard from Thailand will cease to apply to those goods on 11 **September 2011**, unless at that date the goods are subject to review under section 14(8) of the Act.

Any interested party that might request that the Chief Executive of the Ministry of Economic Development initiate a review before the cessation date referred to above, should be aware that positive evidence justifying the need for a review must be provided to the chief executive.

If an application is received which provides positive evidence justifying the need for a review, the chief executive must undertake and complete a review investigation within 180 days of initiation on whether the anti-dumping duties should continue to be applied.

Positive evidence justifying the need for a review would need to include reasons for believing that the expiration of anti-dumping duties would see the continuation or recurrence of dumping of plasterboard from Thailand, and for believing that such dumping would be likely to cause the continuation or recurrence of material injury to the New Zealand industry producing plasterboard.

The reasons should be supported by evidence and not be based on mere allegations or assertions.
