- (b) is a pharmaceutical active ingredient of a medicine that has been assessed and approved for use in New Zealand by the Ministry of Health, in Europe by the European Medicines Agency, in Australia by the Therapeutic Goods Administration, in Japan by the Pharmaceutical and Food Safety Bureau (PFSB) or the United States by the Food and Drug Administration (US FDA); and
- (c) has one or more of the following (but only the following) hazards:
 - A flammable liquid with a flashpoint of less than 23°C and an initial boiling point of greater than 35°C, HSNO 3.1B classification;
 - a flammable liquid with a flashpoint of greater than 23°C and less than or equal to 60°C, HSNO 3.1C classification;
 - a flammable liquid with a flashpoint of greater than 60°C and less than or equal to 93°C, HSNO 3.1D classification;
 - a flammable solid with low hazard, HSNO 4.1.1B classification;
 - an oxidising solid or liquid with low hazard, HSNO 5.1.1C classification;
 - acute toxicity, HSNO 6.1A, 6.1B, 6.1C, 6.1D, 6.1E classifications;
 - skin irritancy, HSNO 6.3A or 6.3B classification;
 - eye irritancy, HSNO 6.4A classification;
 - respiratory sensitisation, HSNO 6.5A classification;
 - contact sensitisation, HSNO 6.5B classification;
 - mutagenicity, HSNO 6.6A or 6.6B classifications;

- carcinogenicity, HSNO 6.7A or 6.7B classifications;
- reproductive toxicity, HSNO 6.8A, 6.8B or 6.8C classifications;
- target organ toxicity, HSNO 6.9A or 6.9B classifications;
- metallic corrosivity, HSNO 8.1A classification;
- skin corrosivity, HSNO 8.2A, 8.2B or 8.2C classifications;
- eye corrosivity, HSNO 8.3A classification;
- ecotoxicity, HSNO class 9.

(2) This Group Standard does not apply to a substance that is an excipient ingredient.

Biosecurity (Bovine Tuberculosis-Otago Land Levy) Order 1998

Levy on Rural Land in the Otago Region

Pursuant to the Biosecurity (Bovine Tuberculosis-Otago Land Levy) Order 1998 made under the Biosecurity Act 1993, a levy is payable to the Animal Health Board Incorporated by the occupiers of all rural landholdings 4 hectares or more in area in the Otago region.

The purpose of the levy is to partially fund TB vector control operations in Otago under the National Bovine Tuberculosis Pest Management Strategy.

For the 2010/2011 financial year, the single rate of levy payable is 0.01500% (\$15.00) per \$100,000.00 of the property land value recorded in the district valuation roll on 1 July 2010 (GST exclusive).

For the purpose of calculating the levy payable, no property shall be valued at more than \$5,000.00 per hectare.

Where the levy payable is less than \$10.00 excluding GST for the property, the occupier is exempt from payment of the levy and will not receive an invoice.

Land occupiers will be invoiced by the Animal Health Board for levies payable on or after **7 February 2011**.

The due date for payment of levies is **31 March 2011**.

Notice to All Aircraft Operators and Users of Ardmore Airport—Facility Fees Increase

Notice is hereby given, pursuant to the Airport Authorities Act 1966 (“the Act”), to advise all aircraft operators and users of Ardmore Airport that the fourth increment of the five-yearly annual increase for facility fees, night flying fees and parking fees is to take effect from 1 December 2010, being a 3% annual increase.

Additionally, Ardmore Airport Limited notifies that future increases in facility fees, night flying fees and parking fees for the next year, as published in the *New Zealand Gazette*, 15 November 2007, No. 123, page 3260, are as follows:

- A 3% per annum increase for the 12-month period commencing on 1 December 2011 and ending on 30 November 2012.

Charges effective **1 December 2010** are as follows:

FIXED WING	Facility Fee = \$10.94 + (MCTOW x 0.006889)
HELICOPTERS	Facility Fee = \$13.46 (flat rate all types)
NIGHT FLYING	In addition to the above fees, “night flying” fees are applicable to both fixed wing and helicopter aircraft as follows: <ol style="list-style-type: none"> 1. \$4.94 per chargeable night landing; 2. \$0.67 per night “touch and go” (fixed wing aircraft only).

Note: For administration purposes, a “night” movement is deemed to be any movement conducted between 2100 and 0600 hours local time during daylight saving and 2000 and 0600 hours standard time.

APPLICATION	The facility fee covers the use of runways, taxiways and apron areas with the exception that the flat rate for helicopters applies to all helicopters that access, for the purposes of facilitating a landing, any area of land designated as “airport land” by Ardmore Airport Limited (whether it be operational, non-operational or leased land and includes the airspace associated with that designation).

PARKING	This covers aircraft parked on aprons, airport operational area and non-leased sites: <ol style="list-style-type: none"> (a) Parking up to 2 hours – no charge. (b) Parking in excess of 2 hours – \$12.00 for every 24-hour period or part period from time of landing. Parking usage will be determined by Ardmore Airport Limited.

GENERAL	<ol style="list-style-type: none"> (a) MCTOW means maximum certified take-off weight in kilograms. (b) All charges are subject to goods and services tax. (c) All charges are payable by the 20th of the month following landing unless subject to a prior written arrangement with Ardmore Airport Limited. (d) A late payment penalty may be imposed on any charges which remain outstanding at the end of the month in which payment is due. Such penalty shall be 15% per annum on the amount outstanding calculated on a daily basis from the date on which payment was due until the date of actual payment, but with a minimum of \$10.00. (e) The charges are set in accordance with section 4(2) of the Act and may be varied from time to time. (f) These charges include the total cost of operating an aircraft into, out of or from Ardmore Airport only. (g) These charges will be invoiced to the registered owner of the aircraft per the Civil Aviation Authority Register of Aircraft unless prior arrangement has been made with Ardmore Airport Limited.
