CHILD RESISTANT PACKAGING GROUP STANDARD (AMENDMENT) NOTICE 2010

PURSUANT TO THE HAZARDOUS SUBSTANCES
AND NEW ORGANISMS ACT 1996

Child Resistant Packaging Group Standard (Amendment) Notice 2010

Pursuant to section 96B(3) of the Hazardous Substances and New Organisms Act 1996 (“the Act”), the Environmental Risk Management Authority (“ERMA New Zealand”) gives notice that the group standards specified in the appendices to this notice (“the principal group standards”) are amended.

Notice

1. Title—(1) This notice is the Child Resistant Packaging Group Standard (Amendment) Notice 2010 and is part of the principal notice.

(2) In this notice, “principal notice” means the Hazardous Substances (Group Standards) Notice 2006 (Supplement to the *New-Zealand Gazette*, 30 June 2006, No. 74, page 1889).

2. Commencement—The amendments referred to in this notice come into force 28 days after the date of its notification in the *New Zealand Gazette*.

3. Amendments to Group Standard—(1) This notice amends the principal group standards by:

- (a) removing the expiry date for the alternative compliance provisions for child resistant packaging in respect of 6.1E (not aspiration hazard) and 8.3A substances covered by group standards in Appendix 1;
- (b) inserting an alternative compliance provision in respect of child resistant packaging requirements for solid 6.1D substances in the cleaning Products Group Standards listed in Appendix 2. The alternative compliance provision does not have an expiry date and does not apply to liquid substances in these group standards; and
- (c) removing the expiry date of the alternative compliance provision in respect of permanent identification of packaging containing a liquid toxic substance for the group standards in Appendix 3.

(2) These amendments are set out in Appendices 1 to 3.
