FINAL ALLOCATIONS FOR ELIGIBLE FISHING QUOTA OWNERS

PURSUANT TO SECTION 77 OF THE
CLIMATE CHANGE RESPONSE ACT 2002

Final Allocations for Eligible Fishing Quota Owners

Pursuant to section 77 of the Climate Change Response Act 2002, the Minister for Climate Change Issues has made final determinations allocating the following New Zealand Units (NZUs) to eligible fishing quota owners as listed. All fishing quota owners listed¹ are eligible to receive an allocation of NZUs under the Fishing Allocation Plan. The NZUs allocated under these determinations will be transferred to the respective New Zealand Emission Unit Register (NZEUR) holding accounts in the appropriate year stated below.

The following quota owners have opened NZEUR holding accounts and will receive NZUs in 2010.
