Brett Woodley McGehan (E 41580) was found guilty of negligently creating a risk of serious harm to any persons as a result of carrying out prescribed electrical work contrary to section 143(b)(ii) of the Electricity Act 1992. **Brett Woodley McGehan** was fined \$7,000.00 and ordered to pay costs of \$10,000.00. The Board directed the Registrar to publish the decision, including the practitioner's name, in the *New Zealand Gazette*.

Brett Woodley McGehan was contracted to carry out prescribed electrical work on a residential home in Auckland on 30 March 2010. The work included installing a mains cable from the new meter box to the mains entry box located under the soffit of the house. The Board found that **Brett Woodley McGehan** transposed the wires at the mains point of entry causing the earthing system to become electrically live. **Brett Woodley McGehan** did not perform any testing as required under Regulation 37 of the Electricity Regulations 1997 and section 6 of the Wiring Rules AS/NZS3000:2000. The transposition was not detected by the inspector, Harry Martin Gedye, either.

The Board was satisfied that the work was negligent and created a significant risk of serious harm. The fault was detected when the owner of the property received a fatal electrical shock while inspecting the hot water cylinder underneath the house.

Following the incident, the Board suspended **Brett Woodley McGehan's** practising licence. That suspension was lifted after he completed an approved training course.

to publish the decision, including the practitioner's name, in the *New Zealand Gazette*.

A registered electrical practitioner, Brett Woodley McGehan, was contracted to carry out prescribed electrical work on a residential home in Auckland on 30 March 2010. The work included installing a mains cable from the new meter box to the mains entry box located under the soffit of the house. The Board found that Brett Woodley McGehan transposed the wires at the mains point of entry causing the earthing system to become electrically live. **Harry Martin Gedye**'s role was to inspect the work undertaken by Brett Woodley McGehan, check to ensure the work was carried out correctly and ensure it was safe to reconnect the electricity supply. He failed to carry out the necessary tests to detect transposition. The Board observed that had **Harry Martin Gedye** carried out his inspection in accordance with the requirements under Regulations 41 and 43A of the Electricity Regulations 1997 and particularly the requirements of section 3 of NZS(Int):2002, the fault would have been detected.

The Board was satisfied that the work was negligent and created a significant risk of serious harm. The fault was detected when the owner of the property received a fatal electrical shock while inspecting the hot water cylinder underneath the house.

Nomination of Tangata Tiaki/Kaitiaki—Te Rūnanga o Moeraki, representing the whānau and hapū of Ngāi Tahu Whānui holding manawhenua manamoana over the area/rohe moana (as represented by Te Rūnanga o Ngāi Tahu), has nominated David Higgins as a replacement Tangata Tiaki/Kaitiaki for managing customary food-gathering within the area/rohe moana for a five-year term.

5. Appointment of Tangata Tiaki/Kaitiaki—(1) On 18 April 2013, the Minister for Primary Industries appointed, under Regulation 10(2) of the Fisheries (South Island Customary Fishing) Regulations 1999, David Higgins as a Tangata Tiaki/Kaitiaki for managing customary food-gathering in the area/rohe moana from the mouth of the Waitaki River south to the mouth of the Shag River, extending seaward to the limit of the South Island fisheries waters, being the 200-mile limit, as well as inland to the boundaries defined for Te Rūnanga o Moeraki in Te Rūnanga o Ngāi Tahu (Declaration of Membership) Order 2001.

(2) The appointment described in clause 5(1) will expire on **2 May 2018**.

6. Power to authorise the taking of fisheries resources for customary food-gathering—Tangata Tiaki/Kaitiaki may authorise any individual to take fisheries resources managed under the Fisheries Act 1996, for customary food-gathering purposes from within the whole or any part of the area/rohe moana. No customary food-gathering of fisheries resources may take place in the area/rohe moana without an authorisation from a Tangata Tiaki/Kaitiaki.
