### Health (High-power Laser Pointers) Regulations 2013

---

#### Approved Classes of Persons to Supply or Acquire High-Power Laser Pointers

The Health (High-power Laser Pointers) Regulations 2013 introduced new controls on the supply and acquisition of high-power laser pointers.

The Regulations define a high-power laser pointer as a device that:

- (a) in the Director-General of Health's opinion, is of the kind commonly known as a laser pointer; and
- (b) is battery operated; and
- (c) is designed or intended to be operated while held in the hand; and
- (d) produces a coherent beam of optical radiation of low divergence; and
- (e) has a power output of greater than 1 milliwatt (mW).

Under the Regulations, people need to apply to the Director-General and obtain his/her authorisation to supply or acquire such a device.

However, Regulation 11 also empowers the Director-General, at his/her discretion, to declare by notice in the *New Zealand Gazette* classes of persons to be authorised suppliers or authorised recipients of high-power laser pointers.

The effect of such a declaration is that these classes of persons do not have to specifically apply for authorisation under the Regulations.

The following classes of persons are declared by me to be authorised suppliers or authorised recipients for the purposes of the Regulations:

- astronomical societies;
- members of astronomical societies; and
- people who use high-power laser pointers for scientific research or industrial purposes.

### Broadcasting Act 1989

---

#### Allocation of Broadcasting Time and Money for the 2014 General Election

The deadline by which political parties must give written notice to the Electoral Commission of eligibility for an allocation of broadcasting time or money under the Broadcasting Act 1989 for the 2014 General Election is **5.00pm, Friday 14 March 2014**.

The Broadcasting Act 1989 (section references are to sections in that Act), describes the responsibilities of the Electoral Commission ("the Commission") to allocate time and money to eligible political parties to enable them to broadcast election programmes during the election period.

The Commission allocates to eligible political parties:

- (a) the time that is made available by TVNZ and Radio New Zealand free of charge for the broadcasting of opening and closing addresses; and
- (b) the money that is appropriated by Parliament for the purpose of funding the broadcast of election programmes during the election period.

#### Eligibility for Allocation of Broadcasting Time and Money

The Commission must not allocate any time to a political party under section 73, or make an allocation of money under 74A of the Act, in respect of an election period unless:

- (a) the party has given the Commission written notice by **5.00pm, 14 March 2014** that the party considers itself eligible for an allocation of time under section 73 or of money under section 74A; and
- (b) the party is registered with the Commission at the time Parliament is dissolved.

#### What the Notice Must Contain

Notice should be addressed to the Electoral Commission.

In accordance with section 70C, every notice given to the Commission must state:

- (a) the full name of the political party; and
- (b) the name and address of the person providing the notice and the capacity in which he or she provides the notice; and

- (c) where the person providing the notice is not the secretary of the political party, the name and address of the secretary of the political party; and
- (d) details of any relationships that may exist between that political party and any other political parties in New Zealand which the Commission may need to take into account in allocating time or money to political parties; and
- (e) either:
  - (i) that the party is registered on the Register of Political Parties; or
  - (ii) that the party is intending to apply for registration on the Register of Political Parties in order to be registered at the date of dissolution or expiry of Parliament; and
- (f) whether or not the political party intends to submit a list under section 127 of the Electoral Act 1993 for the 2014 General Election.
